A BILL

To amend the Public Health Service Act to provide for
research and improvement of cardiovascular health
among the South Asian population of the United States,
and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “South Asian Heart*
 5 *Health Awareness and Research Act of 2020”.*

6 **SEC. 2. HEART HEALTH PROMOTION GRANTS.**

7 *Title III of the Public Health Service Act (42 U.S.C.*
 8 *241 et seq.) is amended by inserting after section 317U (42*
 9 *U.S.C. 247b–23) the following new section:*

10 **“SEC. 317V. HEART HEALTH PROMOTION GRANTS.**

11 *“(a) IN GENERAL.—The Secretary shall make grants*
 12 *to States for the purpose of promoting awareness of the in-*
 13 *creasing prevalence of heart disease, including, where ap-*
 14 *propriate, its relationship to type 2 diabetes, in commu-*
 15 *nities disproportionately affected by heart disease such as*
 16 *South Asian communities in the United States.*

17 *“(b) USE OF FUNDS.—A State that receives a grant*
 18 *under subsection (a) shall use such grant funds—*

19 *“(1) to develop culturally appropriate materials*
 20 *on evidence-based topics such as nutrition education,*
 21 *optimal diet plans, and programs for regular exercise;*

22 *“(2) to support heart health promotion activities*
 23 *of community organizations that work with or serve*
 24 *communities disproportionately affected by heart dis-*

1 *ease, such as South Asian communities in the United*
 2 *States; or*

3 *“(3) to support conferences or workshops on re-*
 4 *search practices, methodology, and design to include*
 5 *more members of communities disproportionately af-*
 6 *ected by heart disease, such as South Asian commu-*
 7 *nities in the United States, in scientific studies.*

8 *“(c) ANNUAL REPORT TO CONGRESS.—Not later than*
 9 *180 days after the date of the enactment of the South Asian*
 10 *Heart Health Awareness and Research Act of 2020, and an-*
 11 *nually thereafter, the Director shall submit to Congress a*
 12 *report on outreach efforts and data relating to heart disease*
 13 *in communities disproportionately affected by heart disease,*
 14 *such as South Asian communities in the United States.*

15 *“(d) AUTHORIZATION OF APPROPRIATIONS.—For pur-*
 16 *poses of carrying out this section, there is authorized to be*
 17 *appropriated \$1,000,000 for each of fiscal years 2020*
 18 *through 2024.”.*

19 **SEC. 3. HEART HEALTH RESEARCH.**

20 *Part B of title IV of the Public Health Service Act*
 21 *(42 U.S.C. 284 et seq.) is amended by adding at the end*
 22 *the following new section:*

23 **“SEC. 409K. HEART HEALTH RESEARCH.**

24 *“(a) IN GENERAL.—The Secretary may—*

1 “(1) conduct or support research and related ac-
2 tivities regarding cardiovascular disease, type 2 dia-
3 betes, and other heart health-related ailments among
4 at-risk populations, including South Asian commu-
5 nities in the United States; and

6 “(2) establish an Internet clearinghouse to cata-
7 log existing evidence-based heart health research and
8 treatment options for communities disproportionately
9 affected by heart disease, such as South Asian com-
10 munities in the United States, to prevent, treat, or re-
11 verse heart disease and diabetes.

12 “(b) *AUTHORIZATION OF APPROPRIATIONS.*—For pur-
13 poses of carrying out this section, there is authorized to be
14 appropriated \$1,000,000 for each of fiscal years 2020
15 through 2024.”.
