A BILL

To provide additional funding for scholarships for students at 1890 institutions, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. ADDITIONAL FUNDING FOR SCHOLARSHIPS
- 4 FOR STUDENTS AT 1890 INSTITUTIONS.
- 5 (a) Scholarships for Bachelor or Graduate
- 6 Programs.—Section 1446(a)(1) of the National Agricul-
- 7 tural Research, Extension, and Teaching Policy Act of
- 8 1977 (7 U.S.C. 3222a(a)(1)) is amended by striking

- 1 "scholarships to individuals" and inserting "scholarships
- 2 (including for programs leading to a bachelor or graduate
- 3 degree) to individuals".
- 4 (b) Mandatory Funding.—Section 1446(b)(1) of
- 5 the National Agricultural Research, Extension, and
- 6 Teaching Policy Act of 1977 (7 U.S.C. 3222a(b)(1)) is
- 7 amended by adding at the end the following:
- 8 "(C) FISCAL YEAR 2025 AND FISCAL YEARS
- 9 THEREAFTER.—Of the funds of the Commodity
- 10 Credit Corporation, the Secretary shall make
- available to carry out this section \$15,000,000
- for fiscal year 2025 and each fiscal year there-
- after, to remain available until expended.".
- 14 (c) DISCRETIONARY FUNDING.—Section 1446(b)(2)
- 15 of the National Agricultural Research, Extension, and
- 16 Teaching Policy Act of 1977 (7 U.S.C. 3222a(b)(2)) is
- 17 amended by striking "each of fiscal years 2020 through
- 18 2023" and inserting "fiscal year 2020 and each fiscal year
- 19 thereafter".
- 20 (d) Conforming Amendments.—Section
- 21 1446(a)(3) of the National Agricultural Research, Exten-
- 22 sion, and Teaching Policy Act of 1977 (7 U.S.C.
- 23 3222a(a)(3)) is amended by striking "each of the 4 suc-
- 24 ceeding academic years" and inserting "each academic

- 1 year thereafter for which funding is available under sub-
- 2 section (b)(1)".
