- 2 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall apply to:
- 3 (1) any order to appear for an examination in aid of enforcement of a money 4 judgment entered in a small claim action in the District Court on or after the effective date 5 of this Act; and
- 6 (2) any show cause order for contempt for failure to appear in court for an examination in aid of enforcement of a money judgment entered in a small claim action in the District Court on or after the effective date of this Act.
- 9 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 10 October 1, 2022.
