## A BILL

To improve public safety through sensible reforms to  
firearms regulations.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Safer America for Ev-  
5 eryone Right Now Act” or the “SAFER Now Act”.

6 **SEC. 2. PROHIBITION ON FIREARMS DEALERS SELLING A**  
7 **FIREARM PRIOR TO THE COMPLETION OF A**  
8 **BACKGROUND CHECK.**

9 Section 922(t)(1)(B) of title 18, United States Code,  
10 is amended—

11 (1) by striking “(i)”;

1           (2) by striking “; or” and inserting “; and”;

2           and

3           (3) by striking clause (ii).

4   **SEC. 3. DEFINITIONS.**

5           (a) IN GENERAL.—Section 921(a) of title 18, United  
6 States Code, is amended—

7           (1) by inserting after paragraph (29) the fol-  
8           lowing:

9           “(30) The term ‘semiautomatic pistol’ means any re-  
10          peating pistol that—

11           “(A) utilizes a portion of the energy of a firing  
12          cartridge to extract the fired cartridge case and  
13          chamber the next round; and

14           “(B) requires a separate pull of the trigger to  
15          fire each cartridge.

16          “(31) The term ‘semiautomatic shotgun’ means any  
17          repeating shotgun that—

18           “(A) utilizes a portion of the energy of a firing  
19          cartridge to extract the fired cartridge case and  
20          chamber the next round; and

21           “(B) requires a separate pull of the trigger to  
22          fire each cartridge.”; and

23          (2) by adding at the end the following:

1       “(36) The term ‘semiautomatic assault weapon’  
2 means any of the following, regardless of country of manu-  
3 facture or caliber of ammunition accepted:

4           “(A) A semiautomatic rifle that has the capac-  
5 ity to accept a detachable magazine and any one of  
6 the following:

7               “(i) A pistol grip.

8               “(ii) A forward grip.

9               “(iii) A folding, telescoping, or detachable  
10 stock.

11              “(iv) A grenade launcher or rocket launch-  
12 er.

13              “(v) A barrel shroud.

14              “(vi) A threaded barrel.

15           “(B) A semiautomatic rifle that has a fixed  
16 magazine with the capacity to accept more than 10  
17 rounds, except for an attached tubular device de-  
18 signed to accept, and capable of operating only with,  
19 .22 caliber rimfire ammunition.

20           “(C) Any part, combination of parts, compo-  
21 nent, device, attachment, or accessory that is de-  
22 signed or functions to accelerate the rate of fire of  
23 a semiautomatic rifle but not convert the semiauto-  
24 matic rifle into a machinegun.

1           “(D) A semiautomatic pistol that has the ca-  
2           capacity to accept a detachable magazine and any one  
3           of the following:

4                   “(i) A threaded barrel.

5                   “(ii) A second pistol grip.

6                   “(iii) A barrel shroud.

7                   “(iv) The capacity to accept a detachable  
8           magazine at some location outside of the pistol  
9           grip.

10                  “(v) A semiautomatic version of an auto-  
11           matic firearm.

12           “(E) A semiautomatic pistol with a fixed maga-  
13           zine that has the capacity to accept more than 10  
14           rounds.

15           “(F) A semiautomatic shotgun that has any one  
16           of the following:

17                   “(i) A folding, telescoping, or detachable  
18           stock.

19                   “(ii) A pistol grip.

20                   “(iii) A fixed magazine with the capacity to  
21           accept more than 5 rounds.

22                   “(iv) The ability to accept a detachable  
23           magazine.

24                   “(v) A forward grip.

1 “(vi) A grenade launcher or rocket launch-  
2 er.

3 “(G) Any shotgun with a revolving cylinder.

4 “(H) All of the following rifles, copies, dupli-  
5 cates, variants, or altered facsimiles with the capa-  
6 bility of any such weapon thereof:

7 “(i) All AK types, including the following:

8 “(I) AK, AK47, AK47S, AK-74,  
9 AKM, AKS, ARM, MAK90, MISR,

9 “(K) All belt-fed semiautomatic firearms, in-  
10 cluding TNW M2HB and FN M2495.

11 “(L) Any combination of parts from which a  
12 firearm described in subparagraphs (A) through (K)  
13 can be assembled.

14 “(M) The frame or receiver of a rifle or shot-  
15 gun described in subparagraph (A), (B), (C), (F),  
16 (G), (H), (J), or (K).

17 “(37) The term ‘large capacity ammunition feeding  
18 device’—

19 “(A) means a magazine, belt, drum, feed strip,  
20 or similar device, including any such device joined or  
21 coupled with another in any manner, that has an  
22 overall capacity of, or that can be readily restored,  
23 changed, or converted to accept, more than 10  
24 rounds of ammunition; and

1           “(B) does not include an attached tubular de-  
2       vice designed to accept, and capable of operating  
3       only with, .22 caliber rimfire ammunition.”.

4       (b) RELATED DEFINITIONS.—Section 921(a) of title  
5 18, United States Code, as amended by this Act, is  
6 amended by adding at the end the following:

7       “(38) The term ‘barrel shroud’—

8           “(A) means a shroud that is attached to, or  
9       partially or completely encircles, the barrel of a fire-  
10      arm so that the shroud protects the user of the fire-  
11      arm from heat generated by the barrel; and

12          “(B) does not include—

13               “(i) a slide that partially or completely en-  
14      closes the barrel; or

15               “(ii) an extension of the stock along the  
16      bottom of the barrel which does not encircle or  
17      substantially encircle the barrel.

18       “(39) The term ‘detachable magazine’ means an am-  
19 munition feeding device that can be removed from a fire-  
20 arm without disassembly of the firearm action.

21       “(40) The term ‘fixed magazine’ means an ammuni-  
22 tion feeding device that is permanently fixed to the firearm  
23 in such a manner that it cannot be removed without dis-  
24 assembly of the firearm.

1       “(41) The term ‘folding, telescoping, or detachable  
2 stock’ means a stock that folds, telescopes, detaches or  
3 otherwise operates to reduce the length, size, or any other  
4 dimension, or otherwise enhances the concealability, of a  
5 firearm.

6       “(42) The term ‘forward grip’ means a grip located  
7 forward of the trigger that functions as a pistol grip.

8       “(43) The term ‘rocket’ means any simple or complex  
9 tubelike device containing combustibles that on being ig-  
10 nited liberate gases whose action propels the tube through  
11 the air and has a propellant charge of not more than 4  
12 ounces.

13       “(44) The term ‘grenade launcher or rocket launcher’  
14 means an attachment for use on a firearm that is designed  
15 to propel a grenade, rocket, or other similar destructive  
16 device.

17       “(45) The term ‘permanently inoperable’ means a  
18 firearm which is incapable of discharging a shot by means  
19 of an explosive and incapable of being readily restored to  
20 a firing condition.

21       “(46) The term ‘pistol grip’ means a grip, a thumb-  
22 hole stock, or any other characteristic that can function  
23 as a grip.

24       “(47) The term ‘threaded barrel’ means a feature or  
25 characteristic that is designed in such a manner to allow

1 for the attachment of a device such as a firearm silencer  
2 or a flash suppressor.

3 “(48) The term ‘qualified law enforcement officer’  
4 has the meaning given the term in section 926B.

5 “(49) The term ‘grandfathered semiautomatic as-  
6 sault weapon’ means any semiautomatic assault weapon  
7 the importation, possession, sale, or transfer of which  
8 would be unlawful under section 922(v) but for the excep-  
9 tion under paragraph (2) of such section.

10 “(50) The term ‘belt-fed semiautomatic firearm’  
11 means any repeating firearm that—

12 “(A) utilizes a portion of the energy of a firing  
13 cartridge to extract the fired cartridge case and  
14 chamber the next round;

15 “(B) requires a separate pull of the trigger to  
16 fire each cartridge; and

17 “(C) has the capacity to accept a belt ammuni-  
18 tion feeding device.”.

19 **SEC. 4. RESTRICTIONS ON ASSAULT WEAPONS AND LARGE**  
20 **CAPACITY AMMUNITION FEEDING DEVICES.**

21 (a) IN GENERAL.—Section 922 of title 18, United  
22 States Code, is amended—

23 (1) by inserting after subsection (u) the fol-  
24 lowing:



1       “(v)(1) It shall be unlawful for a person to import,  
2 sell, manufacture, transfer, or possess, in or affecting  
3 interstate or foreign commerce, a semiautomatic assault  
4 weapon.

5       “(2) Paragraph (1) shall not apply to the possession,  
6 sale, or transfer of any semiautomatic assault weapon oth-  
7 erwise lawfully possessed under Federal law on the date  
8 of enactment of the Safer America for Everyone Right  
9 Now Act.

10       “(3) Paragraph (1) shall not apply to any firearm  
11 that—

12               “(A) is manually operated by bolt, pump, lever,  
13 or slide action;

14               “(B) has been rendered permanently inoperable;  
15 or

16               “(C) is an antique firearm, as defined in section  
17 921 of this title.

18       “(4) Paragraph (1) shall not apply to—

19               “(A) the importation for, manufacture for, sale  
20 to, transfer to, or possession by the United States  
21 or a department or agency of the United States or  
22 a State or a department, agency, or political subdivi-  
23 sion of a State, or a sale or transfer to or possession  
24 by a qualified law enforcement officer employed by  
25 the United States or a department or agency of the

1 United States or a State or a department, agency,  
2 or political subdivision of a State, for purposes of  
3 law enforcement (whether on or off duty), or a sale  
4 or transfer to or possession by a campus law en-  
5 forcement officer for purposes of law enforcement  
6 (whether on or off duty);

7 “(B) the importation for, or sale or transfer to  
8 a licensee under title I of the Atomic Energy Act of  
9 1954 for purposes of establishing and maintaining  
10 an on-site physical protection system and security  
11 organization required by Federal law, or possession  
12 by an employee or contractor of such licensee on-site  
13 for such purposes or off-site for purposes of licensee-  
14 authorized training or transportation of nuclear ma-  
15 terials;

16 “(C) the possession, by an individual who is re-  
17 tired in good standing from service with a law en-  
18 forcement agency and is not otherwise prohibited  
19 from receiving a firearm, of a semiautomatic assault  
20 weapon—

21 “(i) sold or transferred to the individual by  
22 the agency upon such retirement; or

23 “(ii) that the individual purchased, or oth-  
24 erwise obtained, for official use before such re-  
25 tirement;

1           “(D) the importation, sale, manufacture, trans-  
2           fer, or possession of a semiautomatic assault weapon  
3           by a licensed manufacturer or licensed importer for  
4           the purposes of testing or experimentation author-  
5           ized by the Attorney General; or

6           “(E) the importation, sale, manufacture, trans-  
7           fer, or possession of a firearm specified in Appendix  
8           A to this section, as such firearm was manufactured  
9           on the date of introduction of the Safer America for  
10          Everyone Right Now Ac.

11          “(5) For purposes of paragraph (4)(A), the term  
12          ‘campus law enforcement officer’ means an individual who  
13          is—

14               “(A) employed by a private institution of higher  
15               education that is eligible for funding under title IV  
16               of the Higher Education Act of 1965 (20 U.S.C.  
17               1070 et seq.);

18               “(B) responsible for the prevention or investiga-  
19               tion of crime involving injury to persons or property,  
20               including apprehension or detention of persons for  
21               such crimes;

22               “(C) authorized by Federal, State, or local law  
23               to carry a firearm, execute search warrants, and  
24               make arrests; and

1           “(D) recognized, commissioned, or certified by  
2           a government entity as a law enforcement officer.

3           “(6) The Attorney General shall establish and main-  
4           tain, in a timely manner, a record of the make, model,  
5           and, if available, date of manufacture of any semiauto-  
6           matic assault weapon which the Attorney General is made  
7           aware has been used in relation to a crime under Federal  
8           or State law, and the nature and circumstances of the  
9           crime involved, including the outcome of relevant criminal  
10          investigations and proceedings. The Attorney General  
11          shall annually submit a copy of the record established  
12          under this paragraph to the Congress and make the record  
13          available to the general public.

14          “(w)(1) It shall be unlawful for a person to import,  
15          sell, manufacture, transfer, or possess, in or affecting  
16          interstate or foreign commerce, a large capacity ammuni-  
17          tion feeding device.

18          “(2) Paragraph (1) shall not apply to the possession  
19          of any large capacity ammunition feeding device otherwise  
20          lawfully possessed on or before the date of enactment of  
21          the Safer America for Everyone Right Now Act.

22          “(3) Paragraph (1) shall not apply to—

23                  “(A) the importation for, manufacture for, sale  
24                  to, transfer to, or possession by the United States  
25                  or a department or agency of the United States or

1 a State or a department, agency, or political subdivi-  
2 sion of a State, or a sale or transfer to or possession  
3 by a qualified law enforcement officer employed by  
4 the United States or a department or agency of the  
5 United States or a State or a department, agency,  
6 or political subdivision of a State for purposes of law  
7 enforcement (whether on or off duty), or a sale or  
8 transfer to or possession by a campus law enforce-  
9 ment officer for purposes of law enforcement (wheth-  
10 er on or off duty);

11 “(B) the importation for, or sale or transfer to  
12 a licensee under title I of the Atomic Energy Act of  
13 1954 for purposes of establishing and maintaining  
14 an on-site physical protection system and security  
15 organization required by Federal law, or possession  
16 by an employee or contractor of such licensee on-site  
17 for such purposes or off-site for purposes of licensee-  
18 authorized training or transportation of nuclear ma-  
19 terials;

20 “(C) the possession, by an individual who is re-  
21 tired in good standing from service with a law en-  
22 forcement agency and is not otherwise prohibited  
23 from receiving ammunition, of a large capacity am-  
24 munition feeding device—

1                   “(i) sold or transferred to the individual by  
2                   the agency upon such retirement; or

3                   “(ii) that the individual purchased, or oth-  
4                   erwise obtained, for official use before such re-  
5                   tirement; or

6                   “(D) the importation, sale, manufacture, trans-  
7                   fer, or possession of any large capacity ammunition  
8                   feeding device by a licensed manufacturer or licensed  
9                   importer for the purposes of testing or experimen-  
10                  tation authorized by the Attorney General.

11                  “(4) For purposes of paragraph (3)(A), the term  
12                  ‘campus law enforcement officer’ means an individual who  
13                  is—

14                         “(A) employed by a private institution of higher  
15                         education that is eligible for funding under title IV  
16                         of the Higher Education Act of 1965 (20 U.S.C.  
17                         1070 et seq.);

18                         “(B) responsible for the prevention or investiga-  
19                         tion of crime involving injury to persons or property,  
20                         including apprehension or detention of persons for  
21                         such crimes;

22                         “(C) authorized by Federal, State, or local law  
23                         to carry a firearm, execute search warrants, and  
24                         make arrests; and

1 “(D) recognized, commissioned, or certified by  
2 a government entity as a law enforcement officer.”;  
3 and

4 (2) by adding at the end the following:

5 “(aa) SECURE STORAGE OR SAFETY DEVICE RE-  
6 QUIREMENT FOR GRANDFATHERED SEMIAUTOMATIC AS-  
7 SAULT WEAPONS.—It shall be unlawful for any person,  
8 other than a licensed importer, licensed manufacturer, or  
9 licensed dealer, to store or keep under the dominion or  
10 control of that person any grandfathered semiautomatic  
11 assault weapon that the person knows, or has reasonable  
12 cause to believe, will be accessible to an individual prohib-  
13 ited from receiving or possessing a firearm under sub-

15 less the grandfathered semiautomatic assault weapon is—

16 “(1) carried on the person, or within such close  
17 proximity that the person can readily retrieve and  
18 use the grandfathered semiautomatic assault weapon  
19 as if the grandfathered semiautomatic assault weap-  
20 on were carried on the person; or

21 “(2) locked by a secure gun storage or safety  
22 device that the prohibited individual has no ability to  
23 access.”.

1 **SEC. 6. BACKGROUND CHECKS FOR TRANSFERS OF GRAND-**  
2 **FATHERED SEMIAUTOMATIC ASSAULT WEAP-**  
3 **ONS.**

4 (a) IN GENERAL.—Section 922 of title 18, United  
5 States Code, as amended by the preceding provisions of  
6 this Act, is amended—

7 (1) by repealing subsection (s);

8 (2) by redesignating subsection (t) as sub-  
9 section (s);

10 (3) in subsection (s), as redesignated—

11 (A) in paragraph (3)(C)(ii), by striking  
12 “(as defined in subsection (s)(8))”; and

13 (B) by adding at the end the following:

14 “(7) In this subsection, the term ‘chief law en-  
15 forcement officer’ means the chief of police, the  
16 sheriff, or an equivalent officer or the designee of  
17 any such individual.”; and

18 (4) by inserting after subsection (s), as redesign-  
19 nated, the following:

20 “(t)(1) Beginning on the date that is 90 days after  
21 the date of enactment of the Safer America for Everyone  
22 Right Now Act, it shall be unlawful for any person who  
23 is not licensed under this chapter to transfer a grand-  
24 fathered semiautomatic assault weapon to any other per-  
25 son who is not licensed under this chapter, unless a li-  
26 censed importer, licensed manufacturer, or licensed dealer

1 has first taken custody of the grandfathered semiauto-  
2 matic assault weapon for the purpose of complying with  
3 subsection (s). Upon taking custody of the grandfathered  
4 semiautomatic assault weapon, the licensee shall comply  
5 with all requirements of this chapter as if the licensee were  
6 transferring the grandfathered semiautomatic assault  
7 weapon from the licensee's inventory to the unlicensed  
8 transferee.

9       “(2) Paragraph (1) shall not apply to a temporary  
10 transfer of possession for the purpose of participating in  
11 target shooting in a licensed target facility or established  
12 range if—

13               “(A) the grandfathered semiautomatic assault  
14 weapon is, at all times, kept within the premises of  
15 the target facility or range; and

16               “(B) the transferee is not known to be prohib-  
17 ited from possessing or receiving a grandfathered  
18 semiautomatic assault weapon.

19       “(3) For purposes of this subsection, the term ‘trans-  
20 fer’—

21               “(A) shall include a sale, gift, or loan; and

22               “(B) does not include temporary custody of the  
23 grandfathered semiautomatic assault weapon for  
24 purposes of examination or evaluation by a prospec-  
25 tive transferee.

1 “(4)(A) Notwithstanding any other provision of this  
 2 chapter, the Attorney General may implement this sub-  
 3 section with regulations.

4 “(B) Regulations promulgated under this para-  
 5 graph—

6 “(i) shall include a provision setting a max-  
 7 imum fee that may be charged by licensees for serv-  
 8 ices provided in accordance with paragraph (1); and

9 “(ii) shall not include any provision imposing  
 10 recordkeeping requirements on any unlicensed trans-  
 11 feror or requiring licensees to facilitate transfers in  
 12 accordance with paragraph (1).”.

13 (b) TECHNICAL AND CONFORMING AMENDMENTS.—

1 **SEC. 7. NOTIFICATION TO LAW ENFORCEMENT AGENCIES**  
2 **OF PROHIBITED PURCHASE OR ATTEMPTED**  
3 **PURCHASE OF A FIREARM.**

4 (a) IN GENERAL.—Title I of the NICS Improvement  
5 Amendments Act of 2007 (34 U.S.C. 40911–40916) is  
6 amended by adding at the end the following:

7 **“SEC. 108. NOTIFICATION TO LAW ENFORCEMENT AGEN-**  
8 **CIES OF PROHIBITED PURCHASE OR AT-**  
9 **TEMPTED PURCHASE OF A GRANDFATHERED**  
10 **SEMIAUTOMATIC ASSAULT WEAPON.**

11 “(a) IN GENERAL.—In the case of a background  
12 check conducted by the National Instant Criminal Back-  
13 ground Check System pursuant to the request of a li-  
14 censed importer, licensed manufacturer, or licensed dealer  
15 of firearms (as such terms are defined in section 921 of  
16 title 18, United States Code), which background check de-  
17 termines that the receipt of a grandfathered semiauto-  
18 matic assault weapon (as defined in section 921(a)(49) of  
19 title 18, United States Code) by a person would violate  
20 subsection (g) or (n) of section 922 of title 18, United  
21 States Code, the System shall notify the law enforcement  
22 agencies described in subsection (b), including in a case  
23 where such a determination is made after 14 business days  
24 have elapsed since the licensee contacted the System.

25 “(b) LAW ENFORCEMENT AGENCIES DESCRIBED.—  
26 The law enforcement agencies described in this subsection

1 are the law enforcement agencies that have jurisdiction  
 2 over the location from which the licensee contacted the  
 3 System and the law enforcement agencies that have juris-  
 4 diction over the location of the residence of the person for  
 5 which the background check was conducted, as follows:

6           “(1) The field office of the Federal Bureau of  
 7       Investigation.

8           “(2) The local law enforcement agency.

9           “(3) The State law enforcement agency.”.

10       (b) CLERICAL AMENDMENT.—Section 1(b) of such  
 11 Act (Public Law 110–180; 121 Stat. 2559) is amended  
 12 by inserting after the item relating to section 107 the fol-  
 13 lowing:

“108. Notification to law enforcement agencies of prohibited purchase or at-  
 tempted purchase of a firearm.”.

14 **SEC. 8. USE OF BYRNE GRANTS FOR BUY-BACK PROGRAMS**  
 15 **FOR SEMIAUTOMATIC ASSAULT WEAPONS**  
 16 **AND LARGE CAPACITY AMMUNITION FEED-**  
 17 **ING DEVICES.**

18       Section 501(a)(1) of the Omnibus Crime Control and  
 19 Safe Streets Act of 1968 (34 U.S.C. 10152(a)(1)) is  
 20 amended by adding at the end the following:

21           “(G) Compensation for surrendered semi-  
 22       automatic assault weapons and large capacity  
 23       ammunition feeding devices, as those terms are  
 24       defined in section 921 of title 18, United States

1 Code, under buy-back programs for semiauto-  
2 matic assault weapons and large capacity am-  
3 munition feeding devices.”.

4 **SEC. 9. GUN SHOW BACKGROUND CHECK.**

5 (a) FINDINGS.—The Congress finds that—

6 (1) approximately 5,200 traditional gun shows  
7 are held annually across the United States, attract-  
8 ing thousands of attendees per show and hundreds  
9 of Federal firearms licensees and unlicensed fire-  
10 arms sellers; and

11 (2) gun shows at which firearms are exhibited  
12 or offered for sale or exchange provide a convenient  
13 and centralized commercial location where criminals  
14 and other prohibited persons obtain firearms without  
15 background checks and without records that enable  
16 firearm tracing.

17 (b) DEFINITIONS.—Section 921(a) of title 18, United  
18 States Code, as amended by the preceding provisions of  
19 this Act, is amended by adding at the end the following:

20 “(51) GUN SHOW.—The term ‘gun show’—

21 “(A) means any event at which 50 or more fire-  
22 arms are offered or exhibited for sale, exchange, or  
23 transfer, if one or more of the firearms has been  
24 shipped or transported in, or otherwise affects, inter-  
25 state or foreign commerce;

1           “(B) does not include an offer or exhibit of fire-  
2           arms for sale, exchange, or transfer by an individual  
3           from the personal collection of that individual, at the  
4           private residence of that individual, if the individual  
5           is not required to be licensed under section 923; and

6           “(C) does not include an offer or exhibit of fire-  
7           arms for sale, exchange, or transfer at events—

8                   “(i) where not more than 100 firearms are  
9                   offered or exhibited for sale, exchange or trans-  
10                  fer;

11                   “(ii) that are conducted by private, not-for-  
12                   profit organizations whose primary purpose is  
13                   owning and maintaining real property for the  
14                   purpose of hunting activities; and

15                   “(iii) that are attended only by permanent  
16                   or annual dues-paying members of the organi-  
17                   zations, and the members of the immediate  
18                   families of the dues-paying members.

19           “(52) GUN SHOW VENDOR.—The term ‘gun show  
20           vendor’ means a person who is not licensed under section  
21           923 and who exhibits, sells, offers for sale, transfers, or  
22           exchanges a firearm at a gun show, regardless of whether  
23           or not the person arranges with the gun show operator  
24           for a fixed location from which to exhibit, sell, offer for  
25           sale, transfer, or exchange the firearm.”.



1 (c) REGULATION OF FIREARMS TRANSFERS AT GUN  
2 SHOWS.—

3 (1) IN GENERAL.—Chapter 44 of such title is  
4 amended by adding at the end the following:

5 **“§ 932. Regulation of firearms transfers at gun shows**

6 “(a) REGISTRATION OF GUN SHOW OPERATORS.—

7 It shall be unlawful for a person to operate a gun show,  
8 unless—

9 “(1) the person has attained 21 years of age;

10 “(2) the person (and, if the person is a corpora-  
11 tion, partnership, or association, each individual pos-  
12 sessing, directly or indirectly, the power to direct or  
13 cause the direction of the management and policies  
14 of the corporation, partnership, or association) is not  
15 prohibited by subsection (g) or (n) of section 922  
16 from transporting, shipping, or receiving firearms or  
17 ammunition in interstate or foreign commerce;

18 “(3) the person has not willfully violated any  
19 provision of this chapter or regulation issued under  
20 this chapter;

21 “(4) the person has registered with the Attor-  
22 ney General as a gun show operator, in accordance  
23 with regulations promulgated by the Attorney Gen-  
24 eral, and as part of the registration—

1           “(A) has provided the Attorney General  
2           with a photograph and the fingerprints of the  
3           person; and

4           “(B) has certified that the person meets  
5           the requirements of subparagraphs (A) through  
6           (D) of section 923(d)(1);

7           “(5) the person has not willfully failed to dis-  
8           close any material information required, and has not  
9           made any false statement as to any material fact, in  
10          connection with the registration; and

11          “(6) the person has paid the Attorney General  
12          a fee for the registration, in an amount determined  
13          by the Attorney General.

14          “(b) RESPONSIBILITIES OF GUN SHOW OPERA-  
15          TORS.—

16          “(1) IN GENERAL.—It shall be unlawful for a  
17          person to operate a gun show, unless the person—

18               “(A) not later than 30 days before the  
19               commencement of the gun show, notifies the  
20               Attorney General, in writing, of the date, time,  
21               duration, and location of the gun show, and the  
22               identity of each person who will be a gun show  
23               vendor at the gun show;

24               “(B) before commencement of the gun  
25               show—

1 “(i) verifies the identity of each indi-  
2 vidual who will be a gun show vendor at  
3 the gun show by examining a valid identi-  
4 fication document (as defined in section  
5 1028(d)(4)) of the individual containing a  
6 photograph of the individual; and

7 “(ii) requires each such individual to  
8 sign—

9 “(I) a ledger, and enter into the  
10 ledger identifying information con-  
11 cerning the individual; and

12 “(II) a notice which sets forth  
13 the obligations of a gun show vendor  
14 under this chapter; and

15 “(C) notifies each person who attends the  
16 gun show of the requirements of this chapter,  
17 in accordance with such regulations as the At-  
18 torney General shall prescribe.

19 “(2) RECORDKEEPING.—A person who oper-  
20 ates, or has operated, a gun show shall maintain  
21 records demonstrating compliance with paragraph  
22 (1)(B), at such place, for such period of time, and  
23 in such form as the Attorney General shall require  
24 by regulation, or transmit the records to the Attor-  
25 ney General.

1       “(c) BACKGROUND CHECK REQUIRED BEFORE  
2 TRANSFER OF FIREARM BETWEEN UNLICENSED PER-  
3 SONS.—It shall be unlawful for a person who is not li-  
4 censed under this chapter to transfer possession of, or title  
5 to, a firearm at, or on the curtilage of, a gun show, to  
6 another person who is not so licensed, or for a person who  
7 is not so licensed to receive possession of, or title to, a  
8 firearm at, or on the curtilage of, a gun show from another  
9 person who is not so licensed, unless a licensed importer,  
10 licensed manufacturer, or licensed dealer—

11               “(1) has entered into a separate bound record  
12 the make, model, and serial number of the firearm,  
13 and such other information about the transaction as  
14 the Attorney General may require by regulation; and

15               “(2) has notified the prospective transferor and  
16 prospective transferee of the firearm that the na-  
17 tional instant criminal background check system es-  
18 tablished under section 103 of the Brady Handgun  
19 Violence Prevention Act has provided the licensee  
20 with a unique identification number, indicating that  
21 receipt of the firearm by the prospective transferee  
22 would not violate section 922 of this title or State  
23 law.

24       “(d) RECORDKEEPING REQUIREMENTS.—

1           “(1) IN GENERAL.—A licensee who provides a  
2       notice pursuant to subsection (c)(2) with respect to  
3       the transfer of a firearm shall—

4           “(A) not later than 10 days after the date  
5       of the transfer, submit to the Attorney General  
6       a report of the transfer, which report shall  
7       specify the make, model, and serial number of  
8       the firearm, and contain such other information  
9       and be on such form, as the Attorney General  
10      shall require by regulation, except that the re-  
11      port shall not include the name of or other  
12      identifying information relating to any person  
13      involved in the transfer who is not licensed  
14      under this chapter; and

15          “(B) retain a record of the transfer, in-  
16      cluding the same information as would be re-  
17      quired if the transfer were from the inventory  
18      of the licensee, as part of the permanent busi-  
19      ness records of the licensee.

20          “(2) LIMITATION.—The Attorney General may  
21      not impose any recordkeeping requirement on any  
22      gun show vendor by reason of this section.”.

23          (2) PENALTIES.—Section 924(a) of such title is  
24      amended by adding at the end the following:

1       “(8)(A) Whoever knowingly violates subsection (a) or  
2 (d) of section 932 shall be fined under this title, impris-  
3 oned not more than 5 years, or both.

4       “(B) Whoever knowingly violates subsection (b) or (c)  
5 of section 932, shall be—

6           “(i) fined under this title, imprisoned not more  
7 than 2 years, or both; and

8           “(ii) in the case of a second or subsequent con-  
9 viction, fined under this title, imprisoned not more  
10 than 5 years, or both.

11       “(C) In addition to any other penalties imposed  
12 under this paragraph, the Attorney General may, with re-  
13 spect to any person who knowingly violates any provision  
14 of section 932—

15           “(i) if the person is registered pursuant to sec-  
16 tion 932(a), after notice and opportunity for a hear-  
17 ing, suspend for not more than 6 months or revoke  
18 the registration of that person under section 932(a);  
19 and

20           “(ii) impose a civil fine in an amount equal to  
21 not more than \$10,000.”.

22       (3) CLERICAL AMENDMENT.—The table of con-  
23 tents for such chapter is amended by adding at the  
24 end the following:

“Sec. 932. Regulation of firearms transfers at gun shows.”.

1 (d) INSPECTION AUTHORITY.—Section 923(g)(1) of  
2 such title is amended by adding at the end the following:

3 “(E) Notwithstanding subparagraph (B) of this para-  
4 graph, the Attorney General may enter during business  
5 hours any place where a gun show operator operates a  
6 gun show or is required to maintain records pursuant to  
7 section 932(b)(2), for purposes of examining the records  
8 required by sections 923 and 932 and the inventory of  
9 licensees conducting business at the gun show. The entry  
10 and examination shall be conducted for the purposes of  
11 determining compliance with this chapter by gun show op-  
12 erators and licensees conducting business at the gun show,  
13 and shall not require a showing of reasonable cause or  
14 a warrant.”.

15 (e) REPORTS OF MULTIPLE SALES ASSISTED BY LI-  
16 CENSEES AT GUN SHOWS.—Section 923(g)(3)(A) of such  
17 title is amended by inserting “or provides pursuant to sec-  
18 tion 932(c)(2) notice with respect to,” after “sells or oth-  
19 erwise disposes of,”.

20 (f) INCREASED PENALTIES FOR SERIOUS RECORD-  
21 KEEPING VIOLATIONS BY LICENSEES.—Section 924(a)(3)  
22 of such title is amended to read as follows:

23 “(3)(A) Except as provided in subparagraph (B), any  
24 licensed dealer, licensed importer, licensed manufacturer,  
25 or licensed collector who knowingly makes any false state-

1 ment or representation with respect to the information re-  
 2 quired by this chapter to be kept in the records of a person  
 3 licensed under this chapter, or violates section 922(m),  
 4 shall be fined under this title, imprisoned not more than  
 5 1 year, or both.

6 “(B) If the violation described in subparagraph (A)  
 7 is in relation to an offense—

8 “(i) under paragraph (1) or (3) of section  
 9 922(b), such person shall be fined under this title,  
 10 imprisoned not more than 5 years, or both; or

11 “(ii) under subsection (a)(6) or (d) of section  
 12 922, such person shall be fined under this title, im-  
 13 prisoned not more than 10 years, or both.”.

14 (g) INCREASED PENALTIES FOR VIOLATIONS OF  
 15 CRIMINAL BACKGROUND CHECK REQUIREMENTS.—

16 (1) PENALTIES.—Section 924(a)(5) of such  
 17 title is amended—

18 (A) by striking “subsection (s) or (t) of  
 19 section 922” and inserting “section 922(s)”;  
 20 and

21 (B) by striking “1” and inserting “5”.

22 (2) ELIMINATION OF CERTAIN ELEMENTS OF  
 23 OFFENSE.—Section 922(s)(5) of such title, as so re-  
 24 designated by the preceding provisions of this Act,



1 is amended by striking “and, at the time” and all  
2 that follows through “State law”.

3 (h) AUTHORITY TO HIRE PERSONNEL TO INSPECT  
4 GUN SHOWS.—The Director of the Bureau of Alcohol, To-  
5 bacco, Firearms and Explosives may hire at least 40 addi-  
6 tional Industry Operations Investigators for the purpose  
7 of carrying out inspections of gun shows (as defined in  
8 section 921(a)(51) of title 18, United States Code).

9 (i) REPORT TO THE CONGRESS.—The Director of the  
10 Bureau of Alcohol, Tobacco, Firearms and Explosives  
11 shall submit biennial reports to the Congress on how fire-  
12 arms (as defined in section 921(a)(3) of title 18, United  
13 States Code) are sold at gun shows (as defined in para-  
14 graph (51) of such section), how this section is being car-  
15 ried out, whether firearms are being sold without back-  
16 ground checks conducted by the national instant criminal  
17 background check system established under section 103  
18 of the Brady Handgun Violence Prevention Act, what re-  
19 sources are needed to carry out this section, and any rec-  
20 ommendations for improvements to ensure that firearms  
21 are not sold without the background checks.

22 (j) EFFECTIVE DATE.—This section and the amend-  
23 ments made by this section shall take effect 180 days after  
24 the date of enactment of this Act.

1 **SEC. 10. FIREARMS TRAFFICKING.**

2 (a) IN GENERAL.—Chapter 44 of title 18, United  
3 States Code, as amended by the preceding provisions of  
4 this Act, is amended by adding at the end the following:

5 **“§ 933. Trafficking in firearms**

6 “(a) OFFENSES.—Except as provided in subsection  
7 (b), it shall be unlawful for any person, in or affecting  
8 interstate commerce—

9 “(1) to purchase, attempt to purchase, or trans-  
10 fer a firearm, with the intent to deliver the firearm  
11 to another person who the transferor knows, or has  
12 reasonable cause to believe, is prohibited by Federal  
13 or State law from possessing a firearm;

14 “(2) in purchasing, attempting to purchase, or  
15 transferring a firearm, to intentionally provide false  
16 or misleading material information on a Bureau of  
17 Alcohol, Tobacco, Firearms and Explosives firearms  
18 transaction record form; or

19 “(3) to knowingly direct, promote, or facilitate  
20 conduct that violates paragraph (1) or (2).

21 “(b) GIFT EXCEPTIONS.—Subsection (a) shall not  
22 apply to a firearm that is—

23 “(1) lawfully acquired by a person to be given  
24 to another person not prohibited from possessing a  
25 firearm under Federal or State law as a gift; or

1           “(2) lawfully received or otherwise acquired by  
2           a court-appointed trustee, receiver, or conservator  
3           for, or on behalf of, an estate or creditor or by a  
4           person to carry out a bequest, or an acquisition by  
5           intestate succession under the laws of the State of  
6           residence of the person.

7           “(c) PENALTIES.—

8           “(1) IN GENERAL.—Any person who violates  
9           this section shall be fined under this title, impris-  
10          oned for not more than 20 years, or both.

11          “(2) ORGANIZER ENHANCEMENT.—If a viola-  
12          tion of subsection (a) is committed by a person in  
13          concert with 5 or more other persons with respect to  
14          whom such person occupies a position of organizer,  
15          a supervisory position, or any other position of man-  
16          agement, such person may be sentenced to an addi-  
17          tional term of imprisonment of not more than 5 con-  
18          secutive years.

19          “(3) CONSPIRACY.—Any person who conspires  
20          to commit an offense described in this section shall  
21          be fined under this title, imprisoned for not more  
22          than 10 years, or both.”.

23          (b) TECHNICAL AND CONFORMING AMENDMENT.—  
24          The table of sections for chapter 44 of title 18, United

1 States Code, as amended by the preceding provisions of  
2 this Act, is amended by adding at the end the following:

“933. Trafficking in firearms.”.

3 (c) DIRECTIVE TO THE SENTENCING COMMISSION.—

4 (1) IN GENERAL.—Pursuant to its authority  
5 under section 994(p) of title 28, United States Code,  
6 the United States Sentencing Commission shall re-  
7 view and, if appropriate, amend the Federal sen-  
8 tencing guidelines and policy statements applicable  
9 to persons convicted of offenses under section 933 of  
10 title 18, United States Code (as added by subsection  
11 (a)).

12 (2) REQUIREMENT.—In carrying out this sec-  
13 tion, the Commission shall review the penalty struc-  
14 ture that the guidelines currently provide based on  
15 the number of firearms involved in the offense and  
16 determine whether any changes to that penalty  
17 structure are appropriate in order to reflect the in-  
18 tent of Congress that such penalties reflect the grav-  
19 ity of the offense.

20 **SEC. 11. ADDITION OF DATING PARTNERS AND INDIVID-**  
21 **UALS SUBJECT TO RESTRAINING ORDERS.**

22 (a) DEFINITION.—Section 921(a) of title 18, United  
23 States Code, is amended—

24 (1) by striking paragraph (32) and inserting  
25 the following:

1 “(32) The term ‘intimate partner’—

2 “(A) means with respect to a person, the spouse  
3 of the person, a former spouse of the person, an in-  
4 dividual who is a parent of a child of the person, and  
5 an individual who cohabitates or has cohabited with  
6 the person; and

7 “(B) includes—

8 “(i) a dating partner (as defined in section  
9 2266); and

10 “(ii) any other person similarly situated to  
11 a spouse who is protected by the domestic or  
12 family violence laws of the State or tribal juris-  
13 diction in which the injury occurred or where  
14 the victim resides.”; and

15 (2) in paragraph (33)(A)(ii)—

16 (A) by inserting “intimate partner,” after  
17 “former spouse,”; and

18 (B) by inserting “intimate partner,” after  
19 “a spouse,” each place it appears.

20 (b) ADDITION OF STALKING.—Section 922 of title  
21 18, United States Code, is amended—

22 (1) in subsection (d)—

23 (A) in paragraph (8)(ii), by striking “or”  
24 at the end;

1 (B) in paragraph (9), by striking the pe-  
2 riod at the end and inserting “; or”; and

3 (C) by inserting after paragraph (9) the  
4 following:

5 “(10) has been convicted in any court of a mis-  
6 demeanor crime of stalking.”; and

7 (2) in subsection (g)—

8 (A) in paragraph (8)(C)(ii), by striking  
9 “or” at the end;

10 (B) in paragraph (9), by striking the  
11 comma at the end and inserting “; or”; and

12 (C) by inserting after paragraph (9) the  
13 following:

14 “(10) has been convicted in any court of a mis-  
15 demeanor crime of stalking,”.

16 **SEC. 12. SEVERABILITY.**

17 If any provision of this Act, an amendment made by  
18 this Act, or the application of such provision or amend-  
19 ment to any person or circumstance is held to be unconsti-  
20 tutional, the remainder of this Act, the amendments made  
21 by this Act, and the application of such provision or  
22 amendment to any person or circumstance shall not be af-  
23 fected thereby.
