A BILL

To amend the American Rescue Plan Act of 2021 to provide additional funding for E-rate support for emergency educational connections and devices, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Securing Universal
- 5 Communications Connectivity to Ensure Students Succeed
- 6 Act" or the "SUCCESS Act".

| 24 | as in effect before the date of enactment of this Act, that |
