## A BILL

To authorize the establishment of a program of voluntary separation incentive payments for nonjudicial employees of the District of Columbia courts and employees of the District of Columbia Public Defender Service.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "District of Columbia
- 5 Courts and Public Defender Service Voluntary Separation
- 6 Incentive Payments Act".

1	SEC. 2. AUTHORIZATION FOR PROGRAM OF VOLUNTARY

4	(a) In General.—Chapter 17 of title 11, District
5	of Columbia Official Code, is amended by inserting after
6	section 11–1726 the following new section:
7	"§11-1726A. Voluntary Separation Incentive Pay-
8	ments
9	"The Joint Committee on Judicial Administration
10	may, by regulation, establish a program substantially simi-
11	lar to the program established under subchapter II of
12	chapter 35 of title 5, United States Code, for nonjudicial
13	employees of the District of Columbia courts, except that
14	the maximum amount of the payment made under the pro-
15	gram to any individual may not exceed the amount re-
16	ferred to in section 3523(b)(3)(B) of title 5, United States
17	Code.".
18	(b) CLERICAL AMENDMENT.—The table of contents

11	II of chapter 35 of title 5, United States Code, for employ-
12	ees of the Service, except that the maximum amount of

14	may not exceed the amount referred to in section
15	3523(b)(3)(B) of title 5, United States Code.".
