A BILL

To amend section 6 of the Joint Resolution entitled “A Joint Resolution to approve the Covenant To Establish a Commonwealth of the Northern Mariana Islands in Political Union with the United States of America, and for other purposes”.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Northern Mariana Is-*
 5 *lands Residents Relief Act”.*

6 **SEC. 2. LONG-TERM LEGAL RESIDENTS OF THE COMMON-**
 7 **WEALTH OF THE NORTHERN MARIANA IS-**
 8 **LANDS.**

9 *Section 6(e)(6)(B) of the Joint Resolution entitled “A*
 10 *Joint Resolution to approve the Covenant To Establish a*
 11 *Commonwealth of the Northern Mariana Islands in Polit-*
 12 *ical Union with the United States of America, and for other*
 13 *purposes”, approved March 24, 1976 (48 U.S.C. 1806), is*
 14 *amended—*

15 (1) *in clause (iii), by inserting “except in the*
 16 *case of an alien who meets the requirements of sub-*
 17 *clause (VI) of clause (v),” before “resided continuously*
 18 *and lawfully”; and*

19 (2) *in clause (v)—*

20 (A) *in subclause (IV), by striking “; or”*
 21 *and inserting a semicolon;*

22 (B) *in subclause (V), by striking the period*
 23 *at the end and inserting “;”; and*

24 (C) *by adding at the end the following:*

1 “(VI) *was admitted to the Com-*
2 *monwealth as a Commonwealth Only*
3 *Transitional Worker during fiscal year*
4 *2015, and during every subsequent fis-*
5 *cal year beginning before the date of*
6 *the enactment of the Northern Mariana*
7 *Islands U.S. Workforce Act of 2018*
8 *(Public Law 115–218); or*

9 “(VII) *resided in the Northern*
10 *Mariana Islands as an investor under*
11 *Commonwealth immigration law, and*
12 *is presently a resident classified as a*
13 *CNMI-only nonimmigrant under sec-*
14 *tion 101(a)(15)(E)(ii) of the Immigra-*
15 *tion and Nationality Act (8 U.S.C.*
16 *1101(a)(15)(E)(ii)).”.*
