1 A CONCURRENT RESOLUTION

1 deaths per one thousand live births, Louisiana's infant mortality rate ranks forty-eighth  
2 among U.S. states and is nearly twice that of the state with the nation's lowest infant  
3 mortality rate (Massachusetts); and

4 WHEREAS, promoting safe sleep and reducing other risk factors for infant mortality  
5 have been longstanding priorities of the bureau of family health of the Louisiana Department  
6 of Health, the child welfare division of the Department of Children and Family Services, and  
7 the Louisiana State Child Death Review Panel.

8 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby  
9 urge and request the bureau of family health of the Louisiana Department of Health to  
10 evaluate the feasibility and desirability of implementing a "baby box" program of the type  
11 described in this Resolution as a means to promote safe sleep among families with newborns  
12 and thereby reduce infant mortality.

13 BE IT FURTHER RESOLVED that in conducting the evaluation requested in this  
14 Resolution, the bureau of family health shall engage, collaborate with, and obtain  
15 information and perspective from the child welfare division of the Department of Children  
16 and Family Services, the Louisiana State Child Death Review Panel, and any other  
17 stakeholder groups as deemed appropriate by the director of the bureau of family health.

18 BE IT FURTHER RESOLVED that the bureau of family health shall submit a  
19 written report of its findings resulting from the evaluation requested in this Resolution to the  
20 House Committee on Health and Welfare and the Senate Committee on Health and Welfare  
21 no later than sixty days prior to the convening of the 2018 Regular Session of the Legislature  
22 of Louisiana.

23 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the  
24 secretary of the Louisiana Department of Health, the secretary of the Department of Children  
25 and Family Services, and the chairperson of the Louisiana State Child Death Review Panel.

Urges and requests the bureau of family health of the La. Dept. of Health to evaluate the feasibility and desirability of a prospective program to distribute "baby boxes" (sturdy cardboard boxes which double as bassinets and come with a firm foam mattress, tight-fitting sheet, and breastfeeding accessories) as a means of reducing infant mortality, akin to similar programs of three other U.S. states.

Requests the bureau of family health to report findings of the evaluation to the legislative committees on health and welfare no later than 60 days prior to the convening of the 2018 R.S.
