A BILL ENTITLED

1 AN ACT concerning

2 **Criminal Law – Concealment of Death and Disturbing and Dismembering**
3 **Human Remains**

4 FOR the purpose of prohibiting a person, with the intent to conceal the death of another,
5 from failing to notify emergency medical services or law enforcement regarding the
6 death, committing certain destructive acts to any part of human remains, or burying
7 or otherwise disposing of a dead body; prohibiting a person from aiding or abetting
8 another in committing a violation of this Act; and generally relating to the
9 prohibition against the intentional concealment of a death.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – Criminal Law**

18 **10–405.**

19 **(A) A PERSON MAY NOT, WITH THE INTENT TO CONCEAL THE DEATH OF**
20 **ANOTHER:**

21 **(1) FAIL TO CONTACT EMERGENCY MEDICAL SERVICES OR LAW**
22 **ENFORCEMENT REGARDING THE DEATH OF THE PERSON;**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(2) KNOWINGLY AND WILLFULLY DISMEMBER, DESTROY, REMOVE, OR**
2 **OTHERWISE OBLITERATE BY ANY MEANS ANY PORTION OF HUMAN REMAINS; OR**

3 **(3) BURY OR OTHERWISE DISPOSE OF A DEAD BODY.**

4 **(B) A PERSON MAY NOT AID OR ABET ANOTHER IN COMMITTING A**
5 **VIOLATION OF THIS SECTION.**

6 **(C) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A FELONY AND**
7 **ON CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 10 YEARS.**

8 **(D) A SENTENCE IMPOSED UNDER THIS SECTION SHALL BE CONSECUTIVE**
9 **TO AND NOT CONCURRENT WITH ANY OTHER SENTENCE IMPOSED FOR ANY OTHER**
10 **CRIME BASED ON THE ACT ESTABLISHING THE VIOLATION OF THIS SECTION.**

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
12 October 1, 2025.
