A BILL

To amend the Carl D. Perkins Career and Technical Edu-
cation Act of 2006 to support maker education and
makerspaces.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “21st Century Strength-
5 ening Hands On Programs that Cultivate Learning Ap-
6 proaches for Successful Students Act” or the “SHOP
7 CLASS Act”.

1 **SEC. 2. DEFINITIONS.**

2 Section 3 of the Carl D. Perkins Career and Tech-
3 nical Education Act of 2006 (20 U.S.C. 2302) is amended
4 by adding at the end the following:

5 “(35) **MAKER EDUCATION.**—The term ‘maker
6 education’ means a hands-on learning approach that
7 encourages students to imagine, create, innovate,
8 tinker, and collaborate through the process of manu-
9 facturing, testing, and demonstrating their ideas.

10 “(36) **MAKERSPACE.**—The term ‘makerspace’
11 means a community space that provides access to
12 tools, technology and knowledge for learners and en-
13 trepreneurs, which result in the prototyping or cre-
14 ation of physical goods, and which supports the de-
15 velopment of educational opportunities for personal
16 growth, workforce training, and early stage business
17 ventures.”.

18 **SEC. 3. STATE LEADERSHIP ACTIVITIES.**

19 Section 124 of the Carl D. Perkins Career and Tech-
20 nical Education Act of 2006 (20 U.S.C. 2344) is amend-
21 ed—

22 (1) in subsection (b)(3)(D)(iii), by inserting be-
23 fore the semicolon at the end the following: “and
24 maker education”; and

25 (2) in subsection (c)—

1 (A) by striking “and” at the end of para-
 2 graph (16)(B);

3 (B) by striking the period and inserting “;
 4 and” at the end of paragraph (17); and

5 (C) by adding at the end the following:

6 “(18) support for maker education and
 7 makerspaces.”.

8 **SEC. 4. LOCAL USES OF FUNDS.**

9 Section 135 of the Carl D. Perkins Career and Tech-
 10 nical Education Act of 2006 (20 U.S.C. 2355) is amend-
 11 ed—

12 (1) in subsection (b)(5)—

13 (A) by striking “and” at the end of sub-
 14 paragraph (C);

15 (B) by adding “and” at the end of sub-
 16 paragraph (D); and

17 (C) by adding at the end the following:

18 “(E) programs designed to train teachers
 19 specifically in the effective use and application
 20 of maker education and makerspaces;”; and

21 (2) in subsection (c)—

22 (A) by striking “and” at the end of para-
 23 graph (19)(D);

24 (B) by redesignating paragraph (20) as
 25 paragraph (21); and

1 (C) by inserting after paragraph (19), the
2 following:
3 “(20) to support maker education and
4 makerspaces; and”.
