A BILL

To require the Secretary of Commerce to establish a grant program to benefit coastal habitats, resiliency, and the economy, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Shovel-Ready Restora-
- 5 tion Grants for Coastlines and Fisheries Act of 2021".

1 SEC. 2. SHOVEL-READY RESTORATION AND RESILIENCY

2	GRANT PROGRAM.
3	(a) Establishment.—The Secretary shall establish
4	a grant program to provide funding and technical assist-
5	ance to eligible entities for purposes of carrying out a
6	project described in subsection (d).
7	(b) Project Proposal.—To be considered for a
8	grant under this section, an eligible entity shall submit
9	a grant proposal to the Secretary in a time, place, and
10	manner determined by the Secretary. Such proposal shall
11	include monitoring, data collection, and measurable per-
12	formance criteria with respect to the project.
13	(c) Development of Criteria.—The Secretary
14	shall select eligible entities to receive grants under this
15	section based on criteria developed by the Secretary, in
16	consultation with relevant offices of the National Oceanic
17	and Atmospheric Administration, such as the Office of
18	Habitat Conservation and the Office for Coastal Manage-
19	ment.
20	(d) Eligible Projects.—A project is described in
21	this subsection if—
22	(1) the purpose of the project is to restore a
23	marine, estuarine, coastal, or Great Lake habitat,
24	including—
25	(A) restoration of habitat to protect or re-
26	cover a species that is threatened, endangered,

1	or a species of concern under the Endangered
2	Species Act of 1973 (16 U.S.C. 1531 et seq.);
3	(B) through the removal or remediation of
4	marine debris, including derelict vessels and
5	fishing gear, in coastal and marine habitats;
6	and
7	(C) for the benefit of—
8	(i) shellfish;
9	(ii) fish, including diadromous fish; or
10	(iii) coral reef; or
11	(2) the project provides adaptation to climate
12	change, including—
13	(A) by constructing or protecting ecological
14	features or nature-based infrastructure that
15	protects coastal communities from sea level rise,
16	coastal storms, or flooding; and
17	(B) blue carbon projects.
18	(e) Priority.—In determining which projects to
19	fund under this section, the Secretary shall give priority
20	to a proposed project—
21	(1) that would stimulate the economy;
22	(2) for which the applicant can demonstrate
23	that the grant will fund work that will begin not
24	more than 90 days after the date of the award:

- 1 (3) for which the applicant can demonstrate 2 that the grant will fund work that will employ fish-3 ermen who have been negatively impacted by the 4 COVID-19 pandemic or pay a fisherman for the use 5 of a fishing vessel;
 - (4) for which the applicant can demonstrate that any preliminary study or permit required before the project can begin has been completed or can be completed shortly after an award is made; or
- 10 (5) that includes communities that may not 11 have adequate resources, including low-income com-12 munities, communities of color, Tribal communities, 13 Indigenous communities, and rural communities.
- 14 (f) AUTHORIZATION OF APPROPRIATIONS.—There is 15 authorized to be appropriated to the Secretary of Com-16 merce \$3,000,000,000 for fiscal year 2021, to remain 17 available until expended, to carry out this section.
- 18 (g) Definitions.—In this section:
- 19 (1) ELIGIBLE ENTITY.—The term "eligible enti20 ty" means a nonprofit, a for-profit business, an in21 stitution of higher education (as such term is de22 fined in section 101(a) of the Higher Education Act
 23 of 1965 (20 U.S.C. 1001(a))), or a State, local,
 24 Tribal, or Territorial government.

1	(2) FISHERMAN.—The term "fisherman"
2	means a commercial or for-hire fisherman or an oys-
3	er farmer.

(3) Secretary.—The term "Secretary" means the Secretary of Commerce, acting through the Administrator of the National Oceanic and Atmospheric Administration.
