The General Assembly of North Carolina enacts:

SECTION 1. G.S. 163-82.5 reads as rewritten:

"§ 163-82.5. Distribution of application forms.

The State Board of Elections shall make the forms described in G.S. 163-82.3 available for distribution through governmental and private entities, with particular emphasis on making them available for organized voter registration drives.entities."

SECTION 2. Article 7A of Chapter 163 of the General Statutes is amended by adding a new section to read:

"§ 163-82.5A. Sample voter registration drive forms.

- (a) The State Board shall develop a sample voter registration form to be used for organized voter registration drives. The form shall be given an appearance that clearly distinguishes it from the voter registration application form as described in G.S. 163-82.3. The form shall include a disclaimer that it is not an official registration application form for voting purposes. The form may display the contents of what is required on the application form as set forth in G.S. 163-82.4(a) for informational purposes only and shall not provide spaces for an individual to fill in the individual's personal information. The form shall include the following information:
 - (1) Where to obtain an official voter registration application form.
 - (2) Where to return completed voter registration application forms in person.
 - (3) How to register online.
 - (4) A list of important dates, including the deadline for registering to vote and dates for any primary or general elections during the election cycle, or how to find important dates online.
- (b) The State Board shall make the sample voter registration forms available to county boards of elections for distribution in accordance with this section.
- (c) An organization seeking to sponsor or conduct a voter registration drive shall register with the county board of elections in the county in which the voter registration drive is to be held. In registering with the county board of elections, the organization shall provide the following:
 - (1) The name of the organization conducting the voter registration drive.
 - (2) The hierarchical structure within the organization.
