## A BILL

To amend the National Security Act of 1947 to require the President to designate an employee of the National Security Council to be responsible for pandemic prevention and response, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. NATIONAL SECURITY COUNCIL COORDINATOR**  
4 **FOR PANDEMIC PREVENTION AND RE-**  
5 **SPONSE.**

6 Section 101 of the National Security Act of 1947 (50  
7 U.S.C. 3021) is amended—

1           (1) by redesignating subsection (h) as sub-  
2       section (i); and

3           (2) by inserting after subsection (g) the fol-  
4       lowing new subsection (h):

5       “(h) COORDINATOR FOR PANDEMIC PREVENTION  
6       AND RESPONSE.—

7           “(1) IN GENERAL.—The President shall des-  
8       ignate an employee of the National Security Council  
9       to be the permanent coordinator for pandemic pre-  
10      vention and response for the Federal Government  
11      (in this subsection referred to as the ‘Coordinator’).

12          “(2) PURPOSE.—The Coordinator shall direct  
13      all efforts of the Federal Government relating to  
14      United States policy regarding pandemic prevention  
15      and response, including by carrying out the duties  
16      under paragraph (3).

17          “(3) DUTIES.—The Coordinator shall—

18              “(A) serve as the principal advisor to the  
19      President regarding pandemic prevention and  
20      response;

21              “(B) notwithstanding any other provision  
22      of law, coordinate and direct all activities, poli-  
23      cies, programs, and funding relating to pan-  
24      demic prevention and response, for all Federal  
25      agencies;

1           “(C) direct, as appropriate, Federal Gov-  
2           ernment resources to respond to needs for pan-  
3           demic prevention and response; and

4           “(D) lead interagency coordination for  
5           pandemic prevention and response, including  
6           regular consultation with nongovernmental or-  
7           ganizations and public health officials working  
8           to prevent and respond to pandemics.

9           “(4) AUTHORITY TO REPRESENT THE UNITED  
10          STATES.—The Coordinator may represent the  
11          United States in bilateral and multilateral discus-  
12          sions and agreements on matters relevant to pan-  
13          demic prevention and response.”.
