A BILL

To amend the Immigration and Nationality Act to provide for a minimum number of refugees who may be admitted in any fiscal year after fiscal year 2018, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Lady Liberty Act of
- 5 2019".
- 6 SEC. 2. MINIMUM NUMBER OF REFUGEES TO BE ADMITTED.
- 7 Section 207(a) of the Immigration and Nationality
- 8 Act (8 U.S.C. 1157(a)) is amended by inserting after "in
- 9 any fiscal year after fiscal year 1982 shall be such number
- 10 as the President determines," the following: "except that
- 11 in any fiscal year after fiscal year 2020, such number may
- 12 not be less than 110,000".
