A BILL

To require reports by the Secretary of State, the Secretary of the Treasury, and the Director of National Intelligence relating to construction of the Nord Stream 2 pipeline, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Protect European En-
- 5 ergy Security Act".

1 SEC. 2. FINDINGS.

- 2 Congress finds the following:
- (1) The Russian Federation is proposing to construct a gas pipeline from Russia to Germany, named the Nord Stream 2 pipeline, the completion of which could address potential increases in Euro-pean energy consumption but also increase Euro-pean dependence on Russian energy and have desta-bilizing effects on the Government of Ukraine if Ukraine loses energy transit fees as a result of con-struction of the Nord Stream 2 pipeline.
 - (2) According to experts, the Nord Stream 2 pipeline would transport 80 percent of Russia's current gas exports to Europe through one single pipeline system, which would run counter to the European Union energy policy of energy security and diversification of supply.
 - (3) Section 257(a) of the Countering America's Adversaries through Sanctions Act of 2017 (Public Law 115–44; 22 U.S.C. 9546(a)) states in part that it is the policy of the United States—
 - (A) "to work with European Union member states and European Union institutions to promote energy security through developing diversified and liberalized energy markets that

- provide diversified sources, suppliers, and routes"; and
- 3 (B) "to continue to oppose [the Nord 4 Stream 2 pipeline] given its detrimental im-5 pacts on the European Union's energy security, 6 gas market development in Central and Eastern 7 Europe, and energy reforms in Ukraine".
 - (4) On January 27, 2018, then-Secretary of State Rex Tillerson stated, "[T]he United States opposes the Nord Stream 2 pipeline. We see it as undermining Europe's overall energy security and stability . . .". Tillerson further stated that the pipeline would allow Putin to use energy as a "political tool".
 - (5) On March 11, 2018, German chancellor Angela Merkel acknowledged "political" and "strategic" concerns regarding the Nord Stream 2 pipeline and stated that the pipeline "is not just an economic project, but that, of course, political factors must also be taken into account".
 - (6) Gazprom, a Russian energy company, is controlled by the Government of the Russian Federation, which, according to the European Commission's Statement of Objections to Gazprom dated

April 22, 2015, has undertaken efforts to use gas as 1 2 a weapon of coercion. 3 (7) The Department of State, led by the Bureau of Energy of Resources, has worked extensively 5 with allies, including Denmark, to thwart such Rus-6 sian efforts. SEC. 3. SENSE OF CONGRESS. 8 It is the sense of Congress that the United States should— 10 (1) continue to oppose construction of the Nord 11 Stream 2 pipeline and other Russian Federation gas 12 pipelines in northern Europe; and 13 (2) take affirmative diplomatic steps to halt the 14 construction of such pipelines. 15 SEC. 4. REPORTING REQUIREMENTS. 16 (a) Report by Secretary of State.— 17 (1) IN GENERAL.—The Secretary of State, in 18 coordination with the Secretary of the Treasury, 19 shall submit to the appropriate congressional com-20 mittees a report on actions the Department of State 21 is taking to implement section 257 of the Countering 22 America's Adversaries through Sanctions Act of 23 2017 (Public Law 115–44; 22 U.S.C. 9546). 24 (2) Elements.—The report shall include de-25 tails on the following:

- 1 (A) Efforts by the Department of State 2 since August 3, 2017, to work with European 3 Union member states and institutions to pro-4 mote energy security and decrease their dependence on Russian sources of energy, including 6 use of the Countering Russian Influence Fund 7 authorized pursuant to section 254 of the 8 Countering America's Adversaries through 9 Sanctions Act of 2017 (Public Law 115–44; 22 10 U.S.C. 9543).
 - (B) Diplomatic efforts undertaken by the Department of State to oppose directly the Nord Stream 2 pipeline and the Turk Stream pipeline.
 - (C) An estimation of European natural gas supply demand from 2019 through 2023.
 - (b) Report by Secretary of the Treasury.—
 - (1) IN GENERAL.—The Secretary of Treasury, in coordination with the Secretary of State, shall submit to the appropriate congressional committees a report on each entity involved in construction of the Nord Stream 2 pipeline or construction of the Turk Stream pipeline.
- 24 (2) Entity Defined.—In this subsection, the term "entity"—

6	(c) Report by Director of National Intel-
7	LIGENCE.—The Director of National Intelligence, in co-
8	ordination with the Secretary of Defense, shall submit to
9	the appropriate congressional committees a report on the
10	impact of the Nord Stream 2 pipeline on—
11	(1) United States interests and security objec-
12	tives;
13	(2) European energy security and defense pos-
14	ture;
15	(3) Russian influence in Europe; and
16	(4) Ukraine, including the implications of re-
17	ductions in transit fees as a result of Nord Stream
18	2 pipeline.
19	(d) FORM.—The reports required by this section shall
20	be submitted in unclassified form, but may contain a clas-
21	sified annex.
22	(e) Appropriate Congressional Committees De-
23	FINED.—In this section, the term "appropriate congres-
24	sional committees" means—
25	(1) in the House of Representatives—

1	(A) the Committee on Armed Services;
2	(B) the Committee on Foreign Affairs;
3	(C) the Committee on Financial Services;
4	(D) the Committee on Energy and Com-
5	merce; and
6	(E) the Permanent Select Committee on
7	Intelligence; and
8	(2) in the Senate—
9	(A) the Committee on Armed Services;
10	(B) the Committee on Foreign Relations;
11	(C) the Committee on Finance;
12	(D) the Committee on Banking, Housing,
13	and Urban Affairs; and
14	(E) the Select Committee on Intelligence.
