16 year 2023, and \$10,967,554 for fiscal year 2024.”.

17 **SEC. 102. PERSON-CENTERED, TRAUMA-INFORMED SERV-**
18 **ICES.**

19 Section 101(2) (42 U.S.C. 3001(2)) is amended by in-
20 serting “(including access to person-centered, trauma-in-
21 formed services as appropriate)” after “health”.

22 **SEC. 103. AGING AND DISABILITY RESOURCE CENTERS.**

23 Section 102(4) (42 U.S.C. 3002(4)) is amended—

24 (1) in the matter preceding subparagraph (A),
25 by inserting “, in collaboration with (as appropriate)

1 *area agencies on aging, centers for independent living*
 2 *(as described in part C of chapter 1 of title VII of the*
 3 *Rehabilitation Act of 1973 (29 U.S.C. 796f et seq.)),*
 4 *and other aging or disability entities” after “pro-*
 5 *vides”;*

6 *(2) in subparagraph (B)—*

7 *(A) by inserting “services, supports, and”*
 8 *after “plan for long-term”; and*

9 *(B) by inserting “and choices” after “de-*
 10 *sires”; and*

11 *(3) in subparagraph (D), by striking “part C of*

 25 *as subparagraph (M); and*

1 (iii) by inserting after subparagraph
2 (K) the following:

3 “(L) assistive technology devices and services;
4 and”; and

5 (3) in section 411(a) (42 U.S.C. 3032(a))—

6 (A) in paragraph (2), by inserting “,
7 aligned with evidence-based practice,” after “ap-
8 plied social research”; and

9 (B) in paragraph (10), by inserting “con-
10 sistent with section 508 of the Rehabilitation Act
11 of 1973 (29 U.S.C. 794d)” after “other tech-
12 nologies”.

13 **SEC. 105. VACCINATION.**

14 Section 102(14) (42 U.S.C. 3002(14)) is amended—

15 (1) in subparagraph (B), by inserting “immuni-
16 zation status,” after “oral health,”; and

17 (2) in subparagraph (D), by inserting “infec-
18 tious disease, and vaccine-preventable disease, as well
19 as” after “cardiovascular disease),”.

20 **SEC. 106. MALNUTRITION.**

21 The Older Americans Act of 1965 (42 U.S.C. 3001 et
22 seq.) is amended—

23 (1) in section 102(14)(B), as amended by section
24 105(1), by inserting “(including screening for mal-
25 nutrition)” after “nutrition screening”; and

1 (2) in section 330(1), by striking “and food inse-
 2 curity” and inserting “, food insecurity, and mal-
 3 nutrition”.

4 **SEC. 107. SEXUALLY TRANSMITTED DISEASES.**

5 Section 102(14)(D) (42 U.S.C. 3002(14)(D)), as
 6 amended by section 105(2), is further amended by inserting
 7 “prevention of sexually transmitted diseases,” after “vac-
 8 cine-preventable disease,”.

9 **SEC. 108. ADDRESSING CHRONIC PAIN MANAGEMENT.**

10 Section 102(14)(D) (42 U.S.C. 3002(14)(D)), as
 11 amended by section 107, is further amended by inserting
 12 “chronic pain management,” after “substance abuse reduc-
 13 tion,”.

14 **SEC. 109. SCREENING FOR SUICIDE RISK.**

15 Section 102(14)(G) (42 U.S.C. 3002(14)(G)) is amend-
 16 ed by inserting “and screening for suicide risk” after “de-
 17 pression”.

19 *designated by paragraph (1), the following:*

21 *tive health effects associated with social isolation*
22 *and coordination of supportive services and*
23 *health care to address negative health effects as-*
24 *sociated with social isolation; and”;* and

1 (6) in subparagraph (O), as redesignated, by
 2 striking “(A) through (K)” and inserting “(A)
 3 through (N)”.

4 **SEC. 111. CLARIFICATION REGARDING BOARD AND CARE**
 5 **FACILITIES.**

6 Section 102(35)(C) (42 U.S.C. 3002(35)(C)) is amend-
 7 ed by striking “for purposes of sections 307(a)(12) and
 8 712,”.

9 **SEC. 112. PERSON-CENTERED, TRAUMA-INFORMED SERV-**
 10 **ICES DEFINITION.**

11 Section 102 (42 U.S.C. 3002) is amended—

12 (1) by redesignating paragraphs (41) through
 13 (54) as paragraphs (42) through (55), respectively;
 14 and

15 (2) by inserting after paragraph (40) the fol-
 16 lowing:

17 “(41) The term ‘person-centered, trauma-in-
 18 formed’, with respect to services, means services pro-
 19 vided through an aging program that—

20 “(A) use a holistic approach to providing
 21 services or care;

22 “(B) promote the dignity, strength, and em-
 23 powerment of victims of trauma; and

1 “(C) incorporate evidence-based practices
2 based on knowledge about the role of trauma in
3 trauma victims’ lives.”.

4 **SEC. 113. TRAUMATIC BRAIN INJURY.**

5 Section 102 (42 U.S.C. 3002), as amended by section
6 112, is further amended—

14 **SEC. 114. MODERNIZING THE REVIEW OF APPLICATIONS**
15 **AND PROVIDING TECHNICAL ASSISTANCE**
16 **FOR DISASTERS.**

17 (a) REVIEW OF APPLICATIONS.—Section 202 (42
18 U.S.C. 3012) is amended—

19 (1) by amending subsection (a)(4) to read as fol-
20 lows:

21 “(4) administer the grants provided by this Act,
22 but not approve an application submitted by an ap-
23 plicant for a grant for an activity under a provision
24 of this Act for which such applicant previously re-

1 *ceived a grant under such provision unless the Assist-*
 2 *ant Secretary determines—*

3 *“(A) the activity for which such application*
 4 *was submitted is being operated, or was oper-*
 5 *ated, effectively to achieve its stated purpose; and*

6 *“(B) such applicant has complied with the*
 7 *assurances provided to the Assistant Secretary*
 8 *with the application for such previous grant.”;*
 9 *and*

10 *(2) by adding at the end the following:*

11 *“(h) The Assistant Secretary shall publish, on an an-*
 12 *nual basis, a list of centers and demonstration projects*
 13 *funded under each title of this Act. The Assistant Secretary*
 14 *shall ensure that this information is also directly provided*
 15 *to State agencies and area agencies on aging.”.*

16 *(b) ADDRESSING THE NEEDS OF OLDER INDIVIDUALS*
 17 *IN DISASTERS.—Section 202(a) (42 U.S.C. 3012(a)) is*
 18 *amended—*

19 *(1) in paragraph (30), by striking “; and” and*
 20 *inserting a semicolon;*

21 *(2) in paragraph (31), by striking the period at*
 22 *the end and inserting a semicolon; and*

23 *(3) by adding at the end the following:*

24 *“(32) provide technical assistance to, and share*
 25 *best practices with, State agencies and area agencies*

1 *on aging on how to collaborate and coordinate activi-*
 2 *ties and develop long-range emergency preparedness*
 3 *plans with local and State emergency response agen-*
 4 *cies, relief organizations, local and State governments,*
 5 *Federal agencies as appropriate, and any other insti-*
 6 *tutions that have responsibility for disaster relief*
 7 *service delivery;”.*

11 *Section 202(a) (42 U.S.C. 3012(a)), as amended by*
 12 *section 114(b), is further amended by adding at the end*
 13 *the following:*

14 *“(33) with input from aging network stake-*
 15 *holders, including caregivers, develop objectives, prior-*
 16 *ities, and a long-term plan for supporting State and*
 17 *local efforts involving education about prevention of,*
 18 *detection of, and response to negative health effects as-*
 19 *sociated with social isolation among older individ-*
 20 *uals, and submit a report to Congress on this effort*
 21 *by January 2021; and”.*

1 **SEC. 116. NOTIFICATION OF AVAILABILITY OF OR UPDATES**
 2 **TO POLICIES, PRACTICES, AND PROCEDURES**
 3 **THROUGH A UNIFORM E-FORMAT.**

4 *Section 202(a) (42 U.S.C. 3012(a)), as amended by*
 5 *sections 114(b) and 115, is further amended by adding at*
 6 *the end the following:*

7 *“(34) provide (to the extent practicable) a stand-*
 8 *ardized notification to State agencies, area agencies*
 9 *on aging, providers of services under this Act, and*
 10 *grantees or contract awardees under this Act, through*
 11 *an electronic format (e-mail or other electronic notifi-*
 12 *cation), of the availability of, or updates to, policies,*
 13 *practices, and procedures under this Act.”.*

14 **SEC. 117. EVIDENCE-BASED PROGRAM ADAPTATION.**

15 *(a) FUNCTIONS OF THE ASSISTANT SECRETARY.—Sec-*
 16 *tion 202 (42 U.S.C. 3012) is amended—*

17 *(1) in subsection (a)(28), by inserting before the*
 18 *semicolon “, including information and technical as-*
 19 *sistance on delivery of such services in different set-*
 20 *tings”; and*

21 *(2) in subsection (b)(9)(B), by inserting before*
 22 *the semicolon “, including delivery of such services in*
 23 *different settings”.*

24 *(b) EVIDENCE-BASED DISEASE PREVENTION AND*
 25 *HEALTH PROMOTION SERVICES.—Section 361(a) (42*
 26 *U.S.C. 3030m(a)) is amended in the second sentence by in-*

1 *serting “provide technical assistance on the delivery of evi-*
 2 *dence-based disease prevention and health promotion serv-*
 3 *ices in different settings and for different populations, and”*
 4 *before “consult”.*

5 **SEC. 118. BUSINESS ACUMEN PROVISIONS AND CLARIFICA-**
 6 **TION REGARDING OUTSIDE FUNDING FOR**
 7 **AREA AGENCIES ON AGING.**

8 *(a) ASSISTANCE RELATING TO GROWING AND SUS-*
 9 *TAINING CAPACITY.—Section 202(b)(9) (42 U.S.C.*
 10 *3012(b)(9)) is amended—*

11 *(1) in subparagraph (A), by striking “and” after*
 12 *the semicolon at the end;*

13 *(2) in subparagraph (B), as amended by section*
 14 *117(a)(2), by inserting “and” after the semicolon at*
 15 *the end; and*

16 *(3) by adding at the end the following:*

17 *“(C) activities for increasing business acu-*
 18 *men, capacity building, organizational develop-*
 19 *ment, innovation, and other methods of growing*
 20 *and sustaining the capacity of the aging network*
 21 *to serve older individuals and caregivers most ef-*
 22 *fectively;”.*

23 *(b) CLARIFYING PARTNERSHIPS FOR AREA AGENCIES*
 24 *ON AGING.—Section 306 (42 U.S.C. 3026) is amended by*
 25 *adding at the end the following:*

1 “(g) *Nothing in this Act shall restrict an area agency*
 2 *on aging from providing services not provided or authorized*
 3 *by this Act, including through—*

4 “(1) *contracts with health care payers;*

5 “(2) *consumer private pay programs; or*

6 “(3) *other arrangements with entities or individ-*
 7 *uals that increase the availability of home- and com-*
 8 *munity-based services and supports.”.*

9 (c) *CONFORMING AMENDMENT.—Section 307(a) (42*
 10 *U.S.C. 3027(a)) is amended—*

11 (1) *by striking paragraph (26); and*

12 (2) *by redesignating paragraphs (27) through*
 13 *(30) as paragraphs (26) through (29).*

 2 verse and high-quality direct care workforce, in-
 3 cluding providing wages, benefits, and advance-
 4 ment opportunities needed to attract or retain
 5 direct care workers; and

6 “(B) to provide education and workforce de-
 7 velopment programs for direct care workers that
 8 include supportive services and career plan-
 9 ning;”.

10 **SEC. 120. NATIONAL RESOURCE CENTER FOR OLDER INDIV-**
 11 **VIDUALS EXPERIENCING THE LONG-TERM**
 12 **AND ADVERSE CONSEQUENCES OF TRAUMA.**

13 Section 411(a) (42 U.S.C. 3032(a)), as amended by
 14 section 119, is further amended—

15 (1) by redesignating paragraphs (14) and (15)
 16 as paragraphs (15) and (16), respectively; and

17 (2) by inserting after paragraph (13) the fol-
 18 lowing:

19 “(14) the establishment and operation of a na-
 20 tional resource center that shall—
