

# 117TH CONGRESS 1ST SESSION H.R. 3237

Making emergency supplemental appropriations for the fiscal year ending September 30, 2021, and for other purposes.

## A BILL

Making emergency supplemental appropriations for the fiscal year ending September 30, 2021, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That the following sums are appropriated, out of any
- 4 money in the Treasury not otherwise appropriated, for the
- 5 fiscal year ending September 30, 2021, and for other pur-
- 6 poses, namely:

- 8 such amount, such sums as necessary may be used to re-
- 9 store amounts, either directly or through reimbursement,
- 10 for obligations incurred for such purposes by the Sergeant

- 13 such amount, not more than \$500,800 may be transferred

(a) Authorizing Use of Funds.—Subject to subsection (b), the Office of the Sergeant at Arms of the House of Representatives may use amounts which are appropriated or otherwise made available for the operations of the Office during a fiscal year to carry out secu-8 rity enhancements deemed necessary for the protection of Members of Congress including the Delegates and the 10 Resident Commissioner of Congress only if the enhancement is deemed necessary by the Sergeant at Arms of the House of Representatives. 12 13 (b) REGULATIONS.—The Committee on House Administration of the House of Representatives shall have 14 15 the authority to prescribe regulations to carry out this sec-16 tion. 17 (d) Effective Date.—This section shall take effect 18 on the date on which the Committee on House Administration prescribes regulations under subsection (c) to carry 19 20 out this section, and shall apply with respect to the fiscal 21 year in which the Committee prescribes the regulations

10	OFFICERS TO UTILIZE BODY-WORN CAMERAS WHILE

12	Sec. 103. (a) Requirement.—Each uniformed offi-
13	cer of the United States Capitol Police whose job duties
14	include interacting with the general public shall utilize a
15	body-worn camera and ensure that the body-worn camera
16	is activated while on duty.
17	(b) Exception for Officers on Personal Pro-
18	TECTION DETAIL.—Subsection (a) does not apply to an
19	officer during any time in which the officer is serving on
20	a personal protection detail.
21	(c) Regulations.—
22	(1) In General.—The Capitol Police Board
23	shall promulgate such regulations as may be nec-
24	essary to carry out this section.
25	(2) Body camera footage.—The regulations
26	promulgated under paragraph (1) shall include guid-

- ance on the retention and deletion of video footage recorded by a body-worn camera utilized by an officer of the United States Capitol Police.
- (3) Requiring notification prior to discussive of certain recorded information.—

  The regulations promulgated under paragraph (1) shall include a requirement that the United States Capitol Police shall not make any disclosure to any third party (including a law enforcement agency), including any disclosure pursuant to a request by compulsory process, of any video or audio information relating to the House of Representatives or the Senate which is recorded by a body-worn camera utilized by an officer of the United States Capitol Police until the United States Capitol Police provides notice of the request to, and consults regarding the disclosure with—
  - (A) in the case of information relating to the House of Representatives, the Office of the General Counsel of the House of Representatives and any Member (including a Delegate or Resident Commissioner), officer, or employee of the House involved; or
  - (B) in the case of information relating to the Senate, the Office of Senate Legal Counsel,

- 1 and any Senator, officer, or employee of the
- 2 Senate involved.
- 3 (d) Effective Date.—This section shall apply with
- 4 respect to fiscal year 2021 and each succeeding fiscal year.
- 5 REPORT ON EVACUATION PROCEDURES OF THE CAPITOL
- 6 BUILDINGS AND GROUNDS
- 7 Sec. 104. (a) In General.—The appropriate secu-
- 8 rity official of the House of Representatives and the Sen-
- 9 ate shall submit a report (in the appropriate format) to
- 10 the Committee on House Administration of the House of
- 11 Representatives, the Committee on Rules and Administra-
- 12 tion of the Senate, and the Committees on Appropriations
- 13 of the House of Representatives and Senate not later than
- 14 60 days after enactment of this Act on the procedures in
- 15 place for evacuating the Membership, staff, workforce, and
- 16 visitors of the Capitol, the House Office Buildings and the
- 17 Senate Office buildings.
- 18 (b) REQUIREMENTS OF REPORT.—The report ref-
- 19 erenced in subsection (a) shall include an assessment of
- 20 previous evacuations, plans for evacuations involving civil

- 23 plans and policies.
- (c) Classification of Report.—The report accom-
- 25 panying this section shall be submitted in unclassified
- 26 form but may be accompanied by a classified annex.

- 1 \$350,000,000, to remain available until expended, for
- 2 emergency expenses to respond to necessary requirements
- 3 associated with, and the consequences of, the attack on
- 4 the United States Capitol Complex that occurred on Janu-
- 5 ary 6, 2021, including for the costs of: (1) providing sup-
- 6 port for the Architect of the Capitol, the Sergeants at
- 7 Arms of the House of Representatives and the Senate, the
- 8 United States Capitol Police, and the Library of Congress
- 9 in responding to the attack and in preparing for and miti-
- 10 gating the effects of similar attacks in the future; (2) re-
- 11 pairing public facilities damaged by the attack; (3) secur-
