A BILL

To amend the Homeland Security Act of 2002 to require the Secretary of Homeland Security to issue Department of Homeland Security-wide guidance and develop training programs as part of the Department of Homeland Security Blue Campaign, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Department of Home-*
 5 *land Security Blue Campaign Authorization Act of 2017”.*

6 **SEC. 2. ENHANCED DEPARTMENT OF HOMELAND SECURITY**
 7 **COORDINATION THROUGH THE BLUE CAM-**
 8 **PAIGN.**

9 *(a) IN GENERAL.—Subtitle C of title IV of the Home-*
 10 *land Security Act of 2002 (6 U.S.C. 231 et seq.) is amended*
 11 *by adding at the end the following new section:*

12 **“SEC. 434. DEPARTMENT OF HOMELAND SECURITY BLUE**
 13 **CAMPAIGN.**

14 *“(a) IN GENERAL.—There is authorized in the Depart-*
 15 *ment a campaign to be known as the ‘Blue Campaign’. As*
 16 *part of the Blue Campaign, the Secretary shall—*

17 *“(1) issue Department-wide guidance to appro-*
 18 *priate personnel of the Department;*

19 *“(2) develop training programs for such per-*
 20 *sonnel; and*

21 *“(3) coordinate departmental efforts, including*
 22 *training for such personnel.*

23 *“(b) GUIDANCE AND TRAINING.—The Blue Campaign*
 24 *shall provide guidance and training to appropriate per-*
 25 *sonnel of the Department regarding the following:*

1 “(1) *Programs for such personnel, as well as*
2 *Federal, State, and local law enforcement entities, to*
3 *help identify instances of human trafficking and po-*
4 *tential connections to terrorist activities, including*
5 *along the borders of the United States.*

6 “(2) *Systematic and routine information sharing*
7 *between and among the components of the Depart-*
8 *ment and the National Network of Fusion Centers re-*
9 *garding individuals suspected or convicted of human*
10 *trafficking and patterns and practices of human traf-*
11 *ficking and potential connections to terrorist activi-*
12 *ties, including along the borders of the United States.*

13 “(3) *Techniques to identify suspected victims of*
14 *trafficking along the borders of the United States.*

15 “(4) *Techniques specifically for Transportation*
16 *Security Administration personnel to—*

17 “(A) *identify suspected victims of traf-*
18 *ficking at airport security; and*

19 “(B) *serve as a liaison and resource to*
20 *aviation workers and the traveling public.*

21 “(5) *Utilizing resources to educate partners and*
22 *stakeholders and increase public awareness of human*
23 *trafficking, such as indicator cards, fact sheets, pam-*
24 *phlets, posters, brochures, and radio and television*
25 *campaigns.*

1 “(6) *Leveraging partnerships with governmental,*
2 *non-governmental, and private sector organizations at*
3 *the State and local levels to raise public awareness of*
4 *human trafficking and potential connections to ter-*
5 *rorist activities, including along the borders of the*
6 *United States.*

7 “(7) *Any other activities determined necessary*
8 *by the Secretary as part of the Blue Campaign.*

9 “(c) *DEFINITION.—In this section, the term ‘human*
10 *trafficking’ means an act or practice described in para-*
11 *graph (9) or (10) of section 103 of the Trafficking Victims*
12 *Protection Act of 2000 (22 U.S.C. 7102).’.*

13 (b) *INFORMATION TECHNOLOGY SYSTEMS.—Not later*
14 *than one year after the date of the enactment of this Act,*
15 *the Secretary of Homeland Security shall ensure that, con-*
16 *sistent with the Department of Homeland Security-wide*
17 *guidance required under subsection (a) of section 434 of the*
18 *Homeland Security Act of 2002 (as added by subsection (a)*
19 *of this section), information technology systems utilized*
20 *within the Department to record and track information re-*
21 *garding individuals suspected or convicted of human traf-*
22 *ficking (as such term is defined in such section 434) are*
23 *integrated with each other.*

24 (c) *OVERSIGHT.—Not later than 18 months after the*
25 *date of the enactment of this Act, the Secretary of Homeland*

1 *Security shall report to the Committee on Homeland Secu-*
2 *urity of the House of Representatives and the Committee on*
3 *Homeland Security and Governmental Affairs of the Senate*
4 *on the status and effectiveness of the Blue Campaign.*

5 (d) *AUTHORIZATION.—There is authorized to be ap-*
6 *propriated \$819,000 to carry out section 434 of the Home-*
7 *land Security Act of 2002, as added by subsection (a) of*
8 *this section.*

9 (e) *CLERICAL AMENDMENT.—The table of contents of*
10 *the Homeland Security Act of 2002 is amended by inserting*
11 *after the item relating to section 433 the following new item:*

“Sec. 434. Department of Homeland Security Blue Campaign.”.
