Environment – Bay Restoration Fund – Septic System Upgrade Program

- 3 FOR the purpose of authorizing the Department of the Environment to establish performance-based funding levels for best available nitrogen removal technologies 4 for on-site sewage disposal systems using a certain evaluation and ranking process; 5 6 requiring the Department to make certain eligible funding levels available in a 7 certain manner; altering priorities for funding the repair or replacement of certain 8 on-site sewage disposal systems; expanding certain funding eligibility criteria for 9 on-site sewage disposal systems and community sewerage systems; exempting 10 procurements by the Department of certain best available nitrogen removal technologies for on-site sewage disposal systems from certain provisions of the 11 general procurement law; and generally relating to on-site sewage disposal systems. 12
