- 1 (b) The surcharge shall be collected by the office of the clerk of the circuit court 2 for each county.
- 3 (c) The surcharge may not be charged to an entity that is exempt from the 4 payment of fees under § 3–603 of the Real Property Article.
- 5 (d) Receipts from the surcharge shall be placed in the Fund and used by the 6 Administrator for the purposes of the Fund.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 8 October 1, 2020.
