A BILL

To direct the Secretary of the Interior to conduct a special resource study to determine the suitability and feasibility of establishing the John P. Parker House in Ripley, Ohio, as a unit of the National Park System.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "John P. Parker House
- 3 Study Act".
- 4 SEC. 2. DEFINITIONS.
- 5 In this Act:
- 6 (1) Secretary.—The term "Secretary" means
- 7 the Secretary of the Interior.
- 8 (2) Study area.—The term "study area"
- 9 means the John P. Parker House in Ripley, Ohio,
- which was recognized as a National Historic Land-
- 11 mark in 1997.
- 12 SEC. 3. SPECIAL RESOURCE STUDY OF JOHN P. PARKER
- HOUSE.
- 14 (a) Study.—The Secretary shall conduct a special
- 15 resource study of the study area to determine the suit-
- 16 ability and feasibility of establishing the John P. Parker
- 17 House in Ripley, Ohio, as a unit of the National Park Sys-
- 18 tem.
- 19 (b) Study Requirements.—The Secretary shall
- 20 conduct the study in accordance with section 100507 of
- 21 title 54, United States Code.
- (c) Report.—Not later than 18 months after the
- 23 date on which funds are made available to carry out this
- 24 Act, the Secretary shall submit to the Committee on Nat-
- 25 ural Resources of the House of Representatives and the

- 1 Committee on Energy and Natural Resources of the Sen-
- 2 ate a report that describes—
- 3 (1) the results of the study; and
- 4 (2) any recommendations of the Secretary.
