 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "GI Bill STEM Exten-
 - 5 sion Act of 2017".

| 13 | "(b) Eligibility.—For purposes of this section, an |
| 14 | eligible individual is an individual— |
| 15 | "(1) who is or was entitled to educational as- |
| 16 | sistance under section 3311 of this title; |
| 17 | "(2) who has used all of the educational assist- |
| 18 | ance to which the individual is entitled under this |
| 19 | chapter; |
| 20 | "(3) who applies for assistance under this sec- |
| 21 | tion; and |
| 22 | "(4) who— |
| 23 | "(A) is enrolled in a program of education |
| 24 | leading to a post-secondary degree that requires |
| 25 | more than the standard 128 semester (or 192 |
| 26 | quarter) credit hours for completion in— |

- 1 "(d) Amount of Assistance.—The Secretary shall
- 2 pay to each eligible individual who receives additional ben-
- 3 efits under this section a one-time, lump sum payment
- 4 that is the lesser of the following amounts (adjusted with
- 5 respect to the individual pursuant to paragraphs (2)
- 6 through (7) of section 3313(c), as appropriate):
- 7 "(1) The amount payable under section 3313 of
- 8 this title for nine months of the program of edu-
- 9 cation in which the individual is enrolled.
- 10 "(2) \$30,000.
- 11 "(e) Prohibition on Transfer.—An individual
- 12 who receives additional benefits under this section may not
- 13 transfer any amount of such additional benefits under sec-
- 14 tion 3319 of this title.
- 15 "(f) MAXIMUM AMOUNT OF TOTAL ASSISTANCE.—
- 16 The total amount of benefits paid to all eligible individuals
- 17 under this section may not exceed \$100,000,000 for any
- 18 fiscal year.".
- 19 (b) Clerical Amendment.—The table of sections
- 20 at the beginning of such chapter is amended by inserting
- 21 after the item relating to section 3319 the following new
- 22 item:

"3320. Additional benefits.".
