A BILL

To establish an offshore wind career training grant program,
and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Offshore Wind Jobs and*
 5 *Opportunity Act”.*

6 **SEC. 2. OFFSHORE WIND CAREER TRAINING GRANT PRO-**
 7 **GRAM.**

8 *The Outer Continental Shelf Lands Act (43 U.S.C.*
 9 *1331 et seq.) is amended by adding at the end the following:*
 10 **“SEC. 33. OFFSHORE WIND CAREER TRAINING GRANT PRO-**
 11 **GRAM.**

12 “(a) *GRANTS AUTHORIZED.*—Beginning 360 days
 13 *after the date of the enactment of this section, the Secretary*
 14 *may award offshore wind career training grants to eligible*
 15 *entities for the purpose of developing, offering, or improving*
 16 *educational or career training programs that provide indi-*
 17 *viduals in such programs skills necessary for employment*
 18 *in the offshore wind industry.*

19 “(b) *ALLOCATION OF GRANTS.*—

20 “(1) *LIMITATION ON GRANT QUANTITY AND*
 21 *SIZE.*—*An eligible entity may not be awarded—*

22 “(A) *more than one grant under this section*
 23 *for which the eligible entity is the lead applicant;*

24 *or*

1 “(B) a grant under this section in excess of
2 \$2,500,000.

3 “(2) *ALLOCATION TO COMMUNITY COLLEGES.*—
4 *Not less than 25 percent of the total amount awarded*
5 *under this section for a fiscal year shall be awarded*
6 *to eligible entities that are community colleges.*

7 “(c) *PARTNERSHIPS.*—*An eligible entity seeking to re-*
8 *ceive a grant under this section may partner with one or*
9 *more of the following:*

10 “(1) *Another eligible entity (including an eligible*
11 *entity that is a community college).*

12 “(2) *A State or local government.*

13 “(3) *A nonprofit organization.*

14 “(d) *USE OF GRANT.*—*An eligible entity may use a*
15 *grant awarded under this section for the following activi-*
16 *ties:*

17 “(1) *Occupational skills training, including cur-*
18 *riculum development, on-the-job training, and class-*
19 *room training.*

20 “(2) *Safety and health training.*

21 “(3) *The provision of basic skills, English as a*
22 *second language, and job readiness training.*

23 “(4) *Individual referral and tuition assistance*
24 *for a community college training program or simi-*
25 *larly situated training program operated by a non-*

1 *profit organization leading to a recognized postsec-*
2 *ondary credential (as such term is defined in section*
3 *3 of the Workforce Innovation and Opportunity Act*
4 *(29 U.S.C. 3102)).*

5 *“(5) Internship programs in a field related to*
6 *offshore wind energy.*

7 *“(6) Customized training in conjunction with an*
8 *existing registered apprenticeship program or labor-*
9 *management partnership.*

10 *“(7) Incumbent worker and career ladder train-*
11 *ing and skill upgrading and retraining.*

12 *“(8) The implementation of transitional jobs*
13 *strategies.*

14 *“(9) Curriculum development at the under-*
15 *graduate and postgraduate levels.*

16 *“(10) Development and support of offshore wind*
17 *energy major, minor, or certificate programs.*

18 *“(11) Such other activities, as determined by the*
19 *Secretary, to meet the purposes of this section.*

20 *“(e) GRANT PROPOSALS.—*

21 *“(1) SUBMISSION PROCEDURE FOR GRANT PRO-*
22 *POSALS.—An eligible entity seeking to receive a grant*
23 *under this section shall submit a grant proposal to*
24 *the Secretary at such time, in such manner, and con-*

1 *taining such information as the Secretary may re-*
2 *quire.*

3 “(2) *CONTENT OF GRANT PROPOSALS.*—*A grant*
4 *proposal submitted to the Secretary under this section*
5 *shall include a detailed description of—*

6 “(A) *the specific project for which the grant*
7 *proposal is submitted, including the manner in*
8 *which the grant will be used to develop, offer, or*
9 *improve an educational or career training pro-*
10 *gram that will provide individuals in such pro-*
11 *gram skills necessary for employment in the off-*
12 *shore wind industry;*

13 “(B) *any previous experience of the eligible*
14 *entity in providing such educational or career*
15 *training programs; and*

16 “(C) *the extent to which such project will*
17 *meet the educational or career training needs*
18 *identified under subsection (i).*

19 “(f) *CRITERIA FOR AWARD OF GRANTS.*—

20 “(1) *IN GENERAL.*—*Subject to appropriations,*
21 *the Secretary shall award grants under this section*
22 *based on an evaluation of—*

23 “(A) *the merits of the grant proposal;*

24 “(B) *the likely employment opportunities*
25 *available to individuals who complete the edu-*

1 *cational or career training program that the eli-*
2 *gible entity proposes to develop, offer, or im-*
3 *prove;*

4 *“(C) prior demand for such educational or*
5 *career training programs in the community*
6 *served by the eligible entity; and*

7 *“(D) the availability and capacity of exist-*
8 *ing educational or career training programs in*
9 *the community to meet future demand for such*
10 *programs.*

11 *“(2) PRIORITY.—Priority in awarding grants*
12 *under this section shall be given to an eligible entity*
13 *that—*

14 *“(A) is—*

15 *“(i) an institute of higher education*
16 *that has formed a partnership with a labor*
17 *organization; or*

18 *“(ii) a labor organization that has*
19 *formed a partnership with an institute of*
20 *higher education;*

21 *“(B) has entered into a memorandum of*
22 *understanding with an employer in the offshore*
23 *wind industry to foster workforce development;*

24 *“(C) is located in an economically dis-*
25 *tressed area;*

1 “(D) focuses on individuals who are—

2 “(i) displaced workers (particularly
3 workers displaced from the offshore oil and
4 gas, onshore fossil fuel, nuclear energy, or
5 fishing industries);

6 “(ii) veterans, members of the reserve
7 components of the Armed Forces, or former
8 members of such reserve components;

9 “(iii) unemployed;

10 “(iv) seeking employment pathways
11 out of poverty and into economic self-suffi-
12 ciency;

13 “(v) at-risk youth; or

14 “(vi) formerly incarcerated, adju-
15 dicated, nonviolent offenders; or

16 “(E) with respect to an eligible entity that
17 is an institution of higher education, has a high
18 percentage or number of low-income or minority
19 students.

20 “(3) GEOGRAPHIC DISTRIBUTION.—The Sec-
21 retary shall, to the extent practicable, award grants
22 under this section in a manner that provides for a
23 reasonable geographic distribution, except that the
24 Secretary shall not be required to award grants equal-
25 ly among different regions of the United States.

1 “(g) *MATCHING REQUIREMENTS.*—A grant awarded
 2 under this section may not be used to satisfy any non-Fed-
 3 eral funds matching requirement under any other provision
 4 of law.

5 “(h) *GRANTEE DATA COLLECTION.*—

6 “(1) *IN GENERAL.*—A grantee, with respect to
 7 the educational or career training program for which
 8 the grantee received a grant under this section, shall
 9 collect and report to the Secretary on an annual basis
 10 the following:

11 “(A) *The number of participants enrolled in*
 12 *the educational or career training program.*

13 “(B) *The number of participants that have*
 14 *completed the educational or career training pro-*
 15 *gram.*

16 “(C) *The services received by such partici-*
 17 *pants, including a description of training, edu-*
 18 *cation, and supportive services.*

19 “(D) *The amount spent by the grantee per*
 20 *participant.*

21 “(E) *The rate of job placement of partici-*
 22 *pants in the offshore wind industry or related*
 23 *fields.*

24 “(F) *The rate of employment retention—*

1 “(i) if the eligible entity is not an in-
 2 stitution of higher education, 1 year after
 3 completion of the educational or career
 4 training program; or

5 “(ii) if the eligible entity is an institu-
 6 tion of higher education, 1 year after com-
 7 pletion of the educational or career training
 8 program or 1 year after the participant is
 9 no longer enrolled in such institution of
 10 higher education, whichever is later.

11 “(2) *DISAGGREGATION OF DATA.*—The data col-
 12 lected and reported under this subsection shall be
 13 disaggregated by—

14 “(A) race;

15 “(B) low-income status;

16 “(C) disability; and

17 “(D) English language proficiency.

18 “(3) *ASSISTANCE FROM SECRETARY.*—The Sec-
 19 retary shall assist grantees in the collection of data
 20 under this subsection by making available, where
 21 practicable, low-cost means of tracking the labor mar-
 22 ket outcomes of participants and by providing stand-
 23 ardized reporting forms, where appropriate.

24 “(i) *IDENTIFICATION OF EDUCATIONAL AND CAREER*
 25 *TRAINING NEEDS.*—Not later than 120 days after the date

1 *of the enactment of this section, the Secretary, in consulta-*
2 *tion with the offshore wind industry, eligible entities, in-*
3 *cluding eligible entities that are community colleges, State*
4 *and local governments, labor organizations, and nonprofit*
5 *organizations, shall identify the educational and career*
6 *training needs of such industry, including needs related to*
7 *construction and installation, engineering, manufacturing,*
8 *operation, and maintenance activities relevant to the off-*
9 *shore wind industry.*

10 “(j) *GUIDELINES.*—Not later than 240 days after the
11 *date of the enactment of this section, the Secretary shall—*

12 “(1) *promulgate guidelines for the submission of*
13 *grant proposals under this section, including a list of*
14 *the educational and career training needs identified*
15 *under subsection (i); and*

16 “(2) *publish and maintain such guidelines on a*
17 *public website of the Secretary.*

18 “(k) *REPORTING REQUIREMENT.*—Not later than 18
19 *months after the date of the enactment of this section, and*
20 *every 2 years thereafter, the Secretary shall submit a report*
21 *to the Committee on Natural Resources of the House of Rep-*
22 *resentatives, the Committee on Energy and Natural Re-*
23 *sources of the Senate, the Committee on Education and*
24 *Labor of the House of Representatives, and the Committee*
25 *on Health, Education, Labor, and Pensions of the Senate*

1 *on the grant program established by this section. The report*
 2 *shall include a description of the grantees and the activities*
 3 *for which grantees used a grant awarded under this section.*

4 “(l) *AUTHORIZATION OF APPROPRIATIONS.—There are*
 5 *authorized to be appropriated for purposes of this section*
 6 *\$25,000,000 for each of fiscal years 2020 through 2024.*

7 “(m) *DEFINITIONS.—In this section:*

8 “(1) *COMMUNITY COLLEGE.—The term ‘commu-*
 9 *nity college’ has the meaning given the term ‘junior*
 10 *or community college’ in section 312(f) of the Higher*
 11 *Education Act of 1965 (20 U.S.C. 1058(f)).*

12 “(2) *ELIGIBLE ENTITY.—The term ‘eligible enti-*
 13 *ty’ means an entity that is—*

14 “(A) *an institution of higher education, as*
 15 *such term is defined in section 101 of the Higher*
 16 *Education Act of 1965 (20 U.S.C. 1001)); or*

17 “(B) *a labor organization.*

18 “(3) *GRANTEE.—The term ‘grantee’ means an el-*
 19 *igible entity that has received a grant under this sec-*
 20 *tion.*

21 “(4) *LEAD APPLICANT.—The term ‘lead appli-*
 22 *cant’ means the eligible entity that is primarily re-*
 23 *sponsible for the preparation, conduct, and adminis-*
 24 *tration of the project for which the grant was award-*
 25 *ed.*

1 “(5) *SECRETARY.*—*The term ‘Secretary’ means*
2 *the Secretary of the Interior, in consultation with the*
3 *Secretary of Energy, the Secretary of Education, and*
4 *the Secretary of Labor.’.*”
