A BILL

To reauthorize the Justice and Mental Health Collaboration Program, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Justice and Mental
- 5 Health Collaboration Reauthorization Act of 2022".

1	SEC. 2. REAUTHORIZATION OF THE JUSTICE AND MENTAL
2	HEALTH COLLABORATION PROGRAM.
3	(a) In General.—Section 2991(b)(5) of title I of
4	the Omnibus Crime Control and Safe Streets Act of 1968
5	(34 U.S.C. 10651(b)(5)) is amended—
6	(1) in subparagraph (I)—
7	(A) in clause (i), by striking "teams and
8	treatment accountability services for commu-
9	nities" and inserting "teams, treatment ac-
10	countability services for communities, and train-
11	ing for State and local prosecutors relating to
12	diversion programming and implementation";
13	(B) in clause (v)—
14	(i) in subclause (III), by striking
15	"and" at the end;
16	(ii) in subclause (IV), by striking the
17	period at the end and inserting "; and";
18	and
19	(iii) by adding at the end the fol-
20	lowing:
21	"(V) coordinate, implement, and
22	administer models to address mental
23	health calls that include specially
24	trained officers and mental health cri-
25	sis workers responding to those calls
26	together."; and

1	(C) by adding at the end the following:
2	"(vi) Suicide prevention serv-
3	ICES.—Funds may be used to develop, pro-
4	mote, and implement comprehensive sui-
5	cide prevention programs and services for
6	incarcerated individuals that include ongo-
7	ing risk assessment.
8	"(vii) Case management serv-
9	ICES.—Funds may be used for case man-
10	agement services for preliminary qualified
11	offenders and individuals who are released
12	from any penal or correctional institution
13	to—
14	"(I) reduce recidivism; and
15	"(II) assist those individuals with
16	reentry into the community.
17	"(viii) Enhancing community ca-
18	PACITY AND LINKS TO MENTAL HEALTH
19	CARE.—Funds may be used to support, ad-
20	minister, or develop treatment capacity
21	and increase access to mental health care
22	and substance use disorder services for
23	preliminary qualified offenders and individ-
24	uals who are released from any penal or
25	correctional institution

1	"(ix) Implementing 988.—Funds
2	may be used to support the efforts of State
3	and local governments to implement and
4	expand the integration of the 988 universal
5	telephone number designated for the pur-
6	pose of the national suicide prevention and
7	mental health crisis hotline system under
8	section 251(e)(4) of the Communications
9	Act of 1934 (47 U.S.C. 251(e)(4)), includ-
10	ing by hiring staff to support the imple-
11	mentation and expansion."; and
12	(2) by adding at the end the following:
13	"(K) TEAMS ADDRESSING MENTAL
14	HEALTH CALLS.—With respect to a multidisci-
15	plinary team described in subparagraph (I)(v)
16	that receives funds from a grant under this sec-
17	tion, the multidisciplinary team—
18	"(i) shall, to the extent practicable,
19	provide response capability 24 hours each
20	day and 7 days each week to respond to
21	crisis or mental health calls; and
22	"(ii) may place a part of the team in
23	a 911 call center to facilitate the timely re-
24	sponse to mental health crises.".

- 1 (b) AUTHORIZATION OF APPROPRIATIONS.—Section
- 2 2991(o)(1)(C) of title I of the Omnibus Crime Control and
- 3 Safe Streets Act of 1968 (34 U.S.C. 10651(o)(1)(C)) is
- 4 amended by striking "2017 through 2021" and inserting
- 5 "2022 through 2026".
- 6 SEC. 3. EXAMINATION AND REPORT ON PREVALENCE OF
- 7 MENTALLY ILL OFFENDERS.
- 8 Section 5(d) of the Mentally Ill Offender Treatment
- 9 and Crime Reduction Reauthorization and Improvement
- 10 Act of 2008 (Public Law 110-416; 122 Stat. 4355) is
- 11 amended by striking "2009" and inserting "each of fiscal
- 12 years 2022 through 2026".
