A BILL TO BE ENTITLED

AN ACT TO ENACT PROVISIONS RELATED TO IMPROVING THE NUMBER AND QUALITY OF SCHOOL PSYCHOLOGISTS IN NORTH CAROLINA.

The General Assembly of North Carolina enacts:

#### PART I. INCREASE COMPENSATION FOR SCHOOL PSYCHOLOGISTS

**SECTION 1.(a)** For the 2025-2026 fiscal year, in addition to any salary received under the teacher salary schedule, school psychologists shall receive the following salary supplements:

- (1) The sum of six hundred fifty dollars (\$650.00) per month.
- (2) School psychologists who have a Nationally Certified School Psychologist (NCSP) credential shall receive a salary supplement each month of twelve percent (12%) of their monthly salary.

**SECTION 1.(b)** There is appropriated from the General Fund to the Department of Public Instruction for the 2025-2026 fiscal year the sum of eight million one hundred thousand dollars (\$8,100,000) in recurring funds to provide compensation increases for school psychologists pursuant to this section.

#### PART II. SCHOOL PSYCHOLOGISTS GRANT PROGRAM

**SECTION 2.(a)** Article 21 of Chapter 115C of the General Statutes is amended by adding a new section to read:

# "§ 115C-316.6. School Psychologists Grant Program.

- (a) Program Established. The Department of Public Instruction shall establish the School Psychologists Grant Program (Program) to improve the safety, mental health, and well-being of students by providing grants to public school units to recruit school psychologists, to the extent funds are made available for this purpose, as follows:
  - (1) Grant application. A public school unit may submit an application to the Superintendent of Public Instruction to receive a grant pursuant to this subdivision. The application shall identify current and ongoing needs for school psychologist services, including needs related to recruitment.
  - Criteria and guidelines. The Superintendent of Public Instruction shall consult with the school psychologist recruitment and retention coordinator established in Section 7.8(a)(2) of S.L. 2021-180 to develop criteria and guidelines for the administration and use of the grants under the Program, including any documentation required to be submitted by applicants.



- Award of funds. To the extent funds are made available for this purpose, the
  Superintendent of Public Instruction shall award grants to public school units
  to provide signing bonuses to recruit school psychologists, as follows:

  The Superintendent shall prioritize the award of funds to public school
  - a. The Superintendent shall prioritize the award of funds to public school units that do not employ a full-time school psychologist at the time the application is submitted.
  - <u>b.</u> No individual bonus shall be greater than five thousand dollars (\$5,000).
  - c. As a condition of accepting a signing bonus, a school psychologist shall agree to remain employed in the public school unit for at least one year.
  - d. Grants provided to public school units pursuant to the Program shall be used to supplement and not to supplant State or non-State funds already provided for these services.
  - (b) Administration. The Department shall use up to five percent (5%) of the funds appropriated for the Program each year for the administrative costs of the Program. As part of administering the Program, the Department shall provide sufficient funds for the salary of the school psychologist recruitment and retention coordinator.
  - (c) Report. No later than April 1, 2026, and each subsequent year thereafter in which funds allocated pursuant to this section are awarded, the Superintendent of Public Instruction shall report on the Program to the Joint Legislative Education Oversight Committee and the Fiscal Research Division. The report shall include the identity of each public school unit that received a grant through the Program, the amount of funding provided to the public school unit, and the use of funds by the public school unit."

**SECTION 2.(b)** Appropriation. – There is appropriated from the General Fund to the Department of Public Instruction for the 2025-2026 fiscal year the sum of five million dollars (\$5,000,000) in recurring funds to establish and implement the School Psychologists Grant Program pursuant to G.S. 115C-316.6, as enacted by this section.

## PART III. SCHOOL PSYCHOLOGISTS INTERNSHIP PROGRAM

**SECTION 3.(a)** Article 21 of Chapter 115C of the General Statutes is amended by adding a new section to read:

#### "§ 115C-316.7. School psychologists internship program.

- (a) The Department of Public Instruction shall establish an internship program for school psychologists in public school units. Participants in an approved full-time school psychology preparation program shall receive up to a 10-month stipend during the internship period of the program. The stipend shall be at the beginning salary of a school psychologist. The school psychology preparation program where the intern is enrolled shall provide the Department of Public Instruction with certification that the intern is an eligible full-time student.
- (b) Field supervisors in public school units providing instruction to school psychology interns receiving stipends in accordance with this section shall be eligible to receive one lump sum salary supplement of between five hundred dollars (\$500.00) and one thousand two hundred dollars (\$1,200) in an amount to be determined by the public school unit."

**SECTION 3.(b)** There is appropriated from the General Fund to the Department of Public Instruction for the 2025-2026 fiscal year the sum of five million dollars (\$5,000,000) in recurring funds to establish and implement the school psychologists internship program pursuant to G.S. 115C-316.7, as enacted by this act.

#### PART IV. FUNDS FOR A VIRTUAL SCHOOL PSYCHOLOGY TRAINING PROGRAM

**SECTION 4.** There is appropriated from the General Fund to the Board of Governors of The University of North Carolina for the 2025-2026 fiscal year the sum of five million dollars

(\$5,000,000) in nonrecurring funds to be allocated to Appalachian State University (ASU) to host a virtual school psychology training program at the ASU campus in Hickory, North Carolina.

# PART V. INCREASE FUNDS FOR SCHOOL PSYCHOLOGIST TRAINING PROGRAMS

SECTION 5. There is appropriated from the General Fund to the Board of Governors of The University of North Carolina the sum of one million six hundred thousand dollars (\$1,600,000) in recurring funds for the 2025-2026 fiscal year to be allocated to the following constituent institutions of The University of North Carolina to support the school psychology programs at those institutions with the goal of doubling the number of school psychologists produced:

- (1) Appalachian State University.
  - (2) East Carolina University.
  - (3) North Carolina State University.
  - (4) The University of North Carolina at Chapel Hill.
  - (5) Western Carolina University.

#### PART VI. INTERSTATE COMPACT FOR SCHOOL PSYCHOLOGISTS

**SECTION 6.(a)** Chapter 115C of the General Statutes is amended by adding a new Article to read:

## "Article 17F.

"School Psychologist Interstate Licensure Compact.

## "<u>§ 115C-270.40. Purpose.</u>

The purpose of this Compact is to facilitate the interstate practice of School Psychology in educational or school settings, and in so doing to improve the availability of School Psychological Services to the public. This Compact is intended to establish a pathway to allow School Psychologists to obtain equivalent licenses to provide School Psychological Services in any Member State. In this way, this Compact shall enable the Member States to ensure that safe and effective School Psychological Services are available and delivered by appropriately qualified professionals in their educational settings. To facilitate the objectives described above, this Compact does the following:

- (1) Enables School Psychologists who qualify for receipt of an Equivalent License to practice in other Member States without first satisfying burdensome and duplicative requirements.
- (2) Promotes the mobility of School Psychologists between and among the Member States in order to address workforce shortages and to ensure that safe and reliable School Psychological Services are available in each Member State.
- (3) Enhances the public accessibility of School Psychological Services by increasing the availability of qualified, licensed School Psychologists through the establishment of an efficient and streamlined pathway for Licensees to practice in other Member States.
- (4) Preserves and respects the authority of each Member State to protect the health and safety of its residents by ensuring that only qualified, licensed professionals are authorized to provide School Psychological Services within that state.
- (5) Requires School Psychologists practicing within a Member State to comply with the Scope of Practice laws present in the state where the School Psychological Services are being provided.
- (6) Promotes cooperation between the Member States in regulating the practice of School Psychology within those states.

Qualifying School Psychologist Education Program. – An education program 12 (20)13 which awards a Specialist-Level or Doctoral-Level degree or equivalent upon 14 completion and is approved by the Rules of the Commission as meeting the 15 necessary minimum educational standards to ensure that its graduates are 16 ready, qualified, and able to engage in the Practice of School Psychology. 17 Remote State. – A Member State other than the Home State where a Licensee <u>(21)</u> 18 holds a License through the Compact. Rule. – A regulation promulgated by an entity, including, but not limited to, 19 (22)20 the Commission and the State Licensing Authority of each Member State, that 21 has the force of law. 22 (23) School Psychological Services. – Academic, mental, and behavioral health 23 services, including assessment, prevention, consultation and collaboration, 24 intervention, and evaluation provided by a School Psychologist in a school, as 25 outlined in applicable professional standards as determined by Commission 26 27 School Psychologist. – An individual who has met the requirements to obtain <u>(24)</u> 28 a Home State License that legally conveys the professional title of School Psychologist, or its equivalent, as determined by the Rules of the Commission. 29 30 <u>(25)</u> School Psychologist Interstate Licensure Compact Commission 31 (Commission). – The joint government agency established by this Compact 32 whose membership consists of representatives from each Member State that 33 has enacted the Compact, and as further described in G.S. 115C-270.46. 34 Scope of Practice. - The procedures, actions, and processes a School (26)35 Psychologist licensed in a state is permitted to undertake in that state and the 36 circumstances under which that Licensee is permitted to undertake those 37 procedures, actions, and processes. Such procedures, actions, and processes, 38 and the circumstances under which they may be undertaken, may be 39 established through means, including, but not limited to, statute, regulations, 40 case law, and other processes available to the State Licensing Authority or 41 other government agency. 42 <u>Specialist-Level Degree. – A</u> degree program that requires at least 60 graduate (27)43 semester hours or equivalent in the field of School Psychology, including a 44 supervised internship. 45 <u>(28)</u> State. – Any state, commonwealth, district, or territory of the United States of 46 America. 47 (29)State Licensing Authority. – A Member State's regulatory body responsible 48 for issuing Licenses or otherwise overseeing the Practice of School 49 Psychology. 50 **(30)** State Specific Requirement. – A requirement for licensure covered in 51 coursework or examination that includes content of unique interest to the state.

(1) 36 (2) Satisfy any applicable State Specific Requirements established by the 37 Member State after an Equivalent License is granted. 38 Complete any administrative or application requirements which the **(3)** 39 Commission may establish by Rule and pay any associated fees. 40 Complete any requirements for renewal in the Home State, including **(4)** 41 applicable Continuing Professional Education requirements. 42 Upon their application to receive a license under this Compact, undergo a <u>(5)</u> 43

- (5) Upon their application to receive a license under this Compact, undergo a criminal background check in the Member State in which the Equivalent License is sought in accordance with the laws and regulations of such Member State.
- (b) To renew an Equivalent License in a Member State other than the Home State, a Licensee must only apply for renewal, complete a background check, and pay renewal fees as determined by the Licensing Authority.

A Licensee who is an Active Military Member or is the spouse of an Active Military Member shall be deemed to hold a Home State License in any of the following locations:

  - (2) A Member State that is the Licensee's primary state of practice.
  - A Member State where the Licensee has relocated pursuant to a Permanent (3) Change of Station (PCS).

# "§ 115C-270.45. Discipline/adverse actions.

- Nothing in this Compact shall be deemed or construed to limit the authority of a Member State to investigate or impose disciplinary measures on Licensees according to the State Practice Laws thereof.
- Member States shall be authorized to receive, and shall provide, files and information regarding the investigation and discipline, if any, of Licensees in other Member States upon request. Any Member State receiving such information or files shall protect and maintain the security and confidentiality thereof, in at least the same manner that it maintains its own investigatory or disciplinary files and information. Prior to disclosing any disciplinary or investigatory information received from another Member State, the disclosing state shall communicate its intention and purpose for such disclosure to the Member State which originally provided that information.

# "§ 115C-270.46. Establishment of the School Psychologist Interstate Licensure Compact Commission.

- The Member States hereby create and establish a joint government agency whose (a) membership consists of all Member States that have enacted the Compact, and this agency shall be known as the School Psychologist Interstate Licensure Compact Commission. The Commission is an instrumentality of the Member States acting jointly and not an instrumentality of any one state. The Commission shall come into existence on or after the effective date of the Compact as set forth in G.S. 115C-270.50.
  - Membership, Voting, and Meetings. (b)
    - Each Member State shall have and be limited to one delegate selected by that (1) Member State's State Licensing Authority.
    - **(2)** The delegate shall be the primary administrative officer of the Member State Licensing Authority or their designee who is an employee of the Member State Licensing Authority.
    - The Commission shall by Rule or bylaw establish a term of office for <u>(3)</u> delegates and may by Rule or bylaw establish term limits.
    - The Commission may recommend removal or suspension of any delegate **(4)** from office.
    - A Member State's Licensing Authority shall fill any vacancy of its delegate <u>(5)</u> occurring on the Commission within 60 days of the vacancy.
    - <u>(6)</u> Each delegate shall be entitled to one vote on all matters before the Commission requiring a vote by Commission delegates.
    - A delegate shall vote in person or by such other means as provided in the <u>(7)</u> bylaws. The bylaws may provide for delegates to meet by telecommunication, videoconference, or other means of communication.
    - The Commission shall meet at least once during each calendar year. (8) Additional meetings may be held as set forth in the bylaws. The Commission may meet by telecommunication, video conference, or other similar electronic means.
  - (c) The Commission shall have the following powers:
    - Establish the fiscal year of the Commission. (1)
    - (2) Establish code of conduct and conflict of interest policies.
    - (3) Establish and amend Rules and bylaws.
  - (4) Establish the procedure through which a Licensee may change their Home State.

- (23) Perform such other functions as may be necessary or appropriate to achieve the purposes of this Compact.
- (d) The Executive Committee.
  - (1) The Executive Committee shall have the power to act on behalf of the Commission according to the terms of this Compact. The powers, duties, and responsibilities of the Executive Committee shall include the following:
    - a. Oversee the day-to-day activities of the administration of the Compact, including enforcement and compliance with the provisions of the Compact, its Rules and bylaws, and other such duties as deemed necessary.

All minutes and documents of a closed meeting 33 shall remain under seal, subject to release only by a majority vote of the 34 Commission or order of a court of competent jurisdiction. 35 Financing of the Commission. (g) 36 The Commission shall pay, or provide for the payment of, the reasonable (1) 37 expenses of its establishment, organization, and ongoing activities. 38 The Commission may accept any and all appropriate revenue sources as **(2)** 39 provided in subdivision (13) of subsection (c) of this section. 40 The Commission may levy on and collect an annual assessment from each (3) 41 Member State and impose fees on Licensees practicing in the Member States 42 under an Equivalent License to cover the cost of the operations and activities 43 of the Commission and its staff, which must be in a total amount sufficient to 44 cover its annual budget as approved each year for which revenue is not provided by other sources. The aggregate annual assessment amount for 45 46 Member States shall be allocated based upon a formula that the Commission 47 shall promulgate by Rule. 48 The Commission shall not incur obligations of any kind prior to securing the (4) 49 funds adequate to meet the same, nor shall the Commission pledge the credit 50 of any of the Member States, except by and with the authority of the Member 51 State.

- 1 The Commission shall keep accurate accounts of all receipts and (5) 2 disbursements. The receipts and disbursements of the Commission shall be 3 subject to the financial review and accounting procedures established under 4 its bylaws. However, all receipts and disbursements of funds handled by the 5 Commission shall be subject to an annual financial review by a certified or 6 licensed public accountant, and the report of the financial review shall be 7 included in and become part of the annual report of the Commission. 8 Qualified Immunity, Defense, and Indemnification. (h) 9 The members, officers, executive director, employees, and representatives of 10 the Commission shall be immune from suit and liability, both personally and 11 in their official capacity, for any claim for damage to or loss of property or 12 personal injury or other civil liability caused by or arising out of any actual or 13 alleged act, error, or omission that occurred, or that the person against whom 14 the claim is made had a reasonable basis for believing occurred within the 15 scope of Commission employment, duties, or responsibilities; provided that nothing in this subdivision shall be construed to protect any such person from 16 17 suit or liability for any damage, loss, injury, or liability caused by the 18 intentional or willful or wanton misconduct of that person. The procurement 19 of insurance of any type by the Commission shall not in any way compromise 20 or limit the immunity granted hereunder. 21 <u>(2)</u> The Commission shall defend any member, officer, executive director, employee, and representative of the Commission in any civil action seeking 22 23 to impose liability arising out of any actual or alleged act, error, or omission 24 that occurred within the scope of Commission employment, duties, or 25 responsibilities, or as determined by the Commission that the person against 26 whom the claim is made had a reasonable basis for believing occurred within 27 the scope of Commission employment, duties, or responsibilities; provided 28 that nothing herein shall be construed to prohibit that person from retaining 29 their own counsel at their own expense; and provided further, that the actual or alleged act, error, or omission did not result from that person's intentional 30 31 or willful or wanton misconduct. 32 The Commission shall indemnify and hold harmless any member, officer, (3) 33 executive director, employee, and representative of the Commission for the 34 amount of any settlement or judgment obtained against that person arising out 35 of any actual or alleged act, error, or omission that occurred within the scope 36 of Commission employment, duties, or responsibilities, or that such person 37 had a reasonable basis for believing occurred within the scope of Commission 38 employment, duties, or responsibilities, provided that the actual or alleged act, 39 error, or omission did not result from the intentional or willful or wanton 40 misconduct of that person. 41 Nothing herein shall be construed as a limitation on the liability of any <u>(4)</u> 42 licensee for professional malpractice or misconduct, which shall be governed 43 solely by any other applicable state laws. 44 Nothing in this Compact shall be interpreted to waive or otherwise abrogate a <u>(5)</u> 45 Member State's state action immunity or state action affirmative defense with 46 respect to antitrust claims under the Sherman Act, Clayton Act, or any other
  - (6) Nothing in this Compact shall be construed to be a waiver of sovereign immunity by the Member States or by the Commission.

state or federal antitrust or anticompetitive law or regulation.

"§ 115C-270.47. Facilitating information exchange.

- (a) The Commission shall provide for facilitating the exchange of information to administer and implement the provisions of this Compact in accordance with the Rules of the Commission, consistent with generally accepted data protection principles.
- (b) Notwithstanding any other provision of state law to the contrary, a Member State shall agree to provide for the facilitation of the following Licensee information as required by the Rules of the Commission, including:
  - (1) <u>Identifying information.</u>
  - (2) Licensure data.
  - (3) Adverse Actions against a Licensee and information related thereto.
  - (4) Nonconfidential information related to Alternative Program participation, the beginning and ending dates of such participation, and other information related to such participation not made confidential under Member State law.
  - (5) Any denial of application for licensure, and the reason(s) for such denial.
  - (6) The presence of investigative information.
  - (7) Other information that may facilitate the administration of this Compact or the protection of the public, as determined by the Rules of the Commission.
- (c) Nothing in this Compact shall be deemed or construed to alter, limit, or inhibit the power of a Member State to control and maintain ownership of its Licensee information or alter, limit, or inhibit the laws or regulations governing Licensee information in the Member State.

### "§ 115C-270.48. Rulemaking.

- (a) The Commission shall exercise its Rulemaking powers pursuant to the criteria set forth in this interstate compact and the Rules adopted thereunder. Rules and amendments shall become binding as of the date specified in each Rule or amendment.
- (b) The Commission shall promulgate reasonable Rules to achieve the intent and purpose of this interstate compact. In the event the Commission exercises its Rulemaking authority in a manner that is beyond the purpose and intent of this interstate compact, or the powers granted hereunder, then such an action by the Commission shall be invalid and have no force and effect of law in the Member States.
- (c) If a majority of the legislatures of the Member States reject a Rule, by enactment of a statute or resolution in the same manner used to adopt the Compact within four years of the date of adoption of the Rule, then such Rule shall have no further force and effect in any Member State.
- (d) Rules or amendments to the Rules shall be adopted or ratified at a regular or special meeting of the Commission in accordance with Commission Rules and bylaws.
- (e) Prior to promulgation and adoption of a final Rule or Rules by the Commission, and at least 30 days in advance of the meeting at which the Rule will be considered and voted upon, the Commission shall file a notice of proposed Rulemaking:
  - (1) On the website of the Commission or other publicly accessible platform; and
  - On the website of each Member State Licensing Authority or other publicly accessible platform or the publication in which each state would otherwise publish proposed Rules.
- (f) Upon determination that an emergency exists, the Commission may consider and adopt an emergency Rule with 48 hours' notice, with opportunity to comment, provided that the usual Rulemaking procedures shall be retroactively applied to the Rule as soon as reasonably possible, in no event later than 90 days after the effective date of the Rule. For the purposes of this provision, an emergency Rule is one that must be adopted immediately in order to accomplish the following:
  - (1) Meet an imminent threat to public health, safety, or welfare.
  - (2) Prevent a loss of Commission or Member State funds.
  - (3) Meet a deadline for the promulgation of an administrative Rule that is established by federal law or Rule.

(4) Protect public health and safety.

## "§ 115C-270.49. Oversight, dispute resolution, and enforcement.

(a) Oversight.

- (1) The executive and judicial branches of the state government in each Member State shall enforce this Compact and take all actions necessary and appropriate to implement the Compact.
- Venue is proper and judicial proceedings by or against the Commission shall be brought solely and exclusively in a court of competent jurisdiction where the principal office of the Commission is located. The Commission may waive venue and jurisdictional defenses to the extent it adopts or consents to participate in alternative dispute resolution proceedings. Nothing herein shall affect or limit the selection or propriety of venue in any action against a Licensee for professional malpractice, misconduct, or any such similar matter.
- (3) The Commission shall be entitled to receive service of process in any proceeding regarding the enforcement or interpretation of the Compact and shall have standing to intervene in such a proceeding for all purposes. Failure to provide the Commission service of process shall render a judgment or order void as to the Commission, this Compact, or promulgated Rules.
- (b) <u>Default, Technical Assistance, and Termination.</u>
  - (1) If the Commission determines that a Member State has defaulted in the performance of its obligations or responsibilities under this Compact or the promulgated Rules, the Commission shall provide written notice to the defaulting state. The notice of default shall describe the default, the proposed means of curing the default, and any other action that the Commission may take and shall offer training and specific technical assistance regarding the default.
  - (2) The Commission shall provide a copy of the notice of default to the other Member States.
- (c) If a state in default fails to cure the default, the defaulting state may be terminated from the Compact upon an affirmative vote of a supermajority of the delegates of the Member States, and all rights, privileges, and benefits conferred on that state by this Compact may be terminated on the effective date of termination. A cure of the default does not relieve the offending state of obligations or liabilities incurred during the period of default.
- (d) Termination of membership in the Compact shall be imposed only after all other means of securing compliance have been exhausted. Notice of intent to suspend or terminate shall be given by the Commission to the governor, the majority and minority leaders of the defaulting state's legislature, the defaulting State's Licensing Authority, and each of the Member States' Licensing Authorities.
- (e) A state that has been terminated is responsible for all assessments, obligations, and liabilities incurred through the effective date of termination, including obligations that extend beyond the effective date of termination.
- (f) Upon the termination of a state's membership from this Compact, that state shall immediately provide notice to all Licensees within that state of such termination. The terminated state shall continue to recognize all Licenses granted pursuant to this Compact for a minimum of six months after the date of said notice of termination.
- (g) The Commission shall not bear any costs related to a state that is found to be in default or that has been terminated from the Compact, unless agreed upon in writing between the Commission and the defaulting state.
- (h) The defaulting state may appeal the action of the Commission by petitioning the U.S. District Court for the District of Columbia or the federal district where the Commission has its

principal offices. The prevailing party shall be awarded all costs of such litigation, including reasonable attorneys' fees.

(i) Dispute Resolution.

- (1) Upon request by a Member State, the Commission shall attempt to resolve disputes related to the Compact that arise among Member States and between Member and non-Member States.
- (2) The Commission shall promulgate a Rule providing for both mediation and binding dispute resolution for disputes as appropriate.
- (i) Enforcement.
  - (1) By majority vote as provided by Rule, the Commission may initiate legal action against a Member State in default in the U.S. District Court for the District of Columbia or the federal district where the Commission has its principal offices to enforce compliance with the provisions of the Compact and its promulgated Rules. The relief sought may include both injunctive relief and damages. In the event judicial enforcement is necessary, the prevailing party shall be awarded all costs of such litigation, including reasonable attorneys' fees. The remedies herein shall not be the exclusive remedies of the Commission. The Commission may pursue any other remedies available under federal or the defaulting Member State's law.
  - A Member State may initiate legal action against the Commission in the U.S. District Court for the District of Columbia or the federal district where the Commission has its principal offices to enforce compliance with the provisions of the Compact and its promulgated Rules. The relief sought may include both injunctive relief and damages. In the event judicial enforcement is necessary, the prevailing party shall be awarded all costs of such litigation, including reasonable attorneys' fees.
  - (3) No person other than a Member State shall enforce this Compact against the Commission.

## "§ 115C-270.50. Effective date, withdrawal, and amendment.

- (a) The Compact shall come into effect on the date on which the Compact statute is enacted into law in the seventh Member State.
  - (1) On or after the effective date of the Compact indicated above, the Commission shall convene and review the enactment of each of the Charter Member States to determine if the statute enacted by each such Charter Member State is materially different than the model Compact statute.
    - a. A Charter Member State whose enactment is found to be materially different from the model Compact statute shall be entitled to the default process set forth in G.S. 115C-270.49.
    - b. If any Member State is later found to be in default, or is terminated or withdraws from the Compact, the Commission shall remain in existence and the Compact shall remain in effect even if the number of Member States should be less than seven.
  - Member States enacting the Compact subsequent to the Charter Member States shall be subject to the process set forth in subdivision (22) of subsection (c) of G.S. 115C-470.46 to determine if their enactments are materially different from the model Compact statute and whether they qualify for participation in the Compact.
  - (3) All actions taken for the benefit of the Commission or in furtherance of the purposes of the administration of the Compact prior to the effective date of the Compact or the Commission coming into existence shall be considered to

be actions of the Commission unless specifically repudiated by the Commission.

a. Any state that joins the Compact subsequent to the Commission's initial adoption of the Rules and bylaws shall be subject to the Rules and bylaws as they exist on the date on which the Compact becomes law in that state. Any Rule that has been previously adopted by the Commission shall have the full force and effect of law on the day the Compact becomes law in that state.

b. Any Member State may withdraw from this Compact by enacting a statute repealing the same.

(b) A Member State's withdrawal shall not take effect until 180 days after enactment of the repealing statute.

(c) Withdrawal shall not affect the continuing requirement of the withdrawing State's Licensing Authority to comply with the investigative and Adverse Action reporting requirements of this Compact prior to the effective date of withdrawal.

 (d) Upon the enactment of a statute withdrawing from this Compact, a state shall immediately provide notice of such withdrawal to all Licensees within that state. Notwithstanding any subsequent statutory enactment to the contrary, such withdrawing state shall continue to recognize all Licenses granted pursuant to this Compact for a minimum of six months after the date of such notice of withdrawal.

Nothing contained in this Compact shall be construed to invalidate or prevent any licensure agreement or other cooperative arrangement between a Member State and a non-Member State that does not conflict with the provisions of this Compact.

(2) This Compact may be amended by the Member States. No amendment to this Compact shall become effective and binding upon any Member State until it is enacted into the laws of all Member States.

"§ 115C-270.51. Construction and severability.

(a) This Compact and the Commission's Rulemaking authority shall be liberally construed so as to effectuate the purposes and the implementation and administration of the Compact. Provisions of the Compact expressly authorizing or requiring the promulgation of Rules shall not be construed to limit the Commission's Rulemaking authority solely for those purposes.

(b) The provisions of this Compact shall be severable and if any phrase, clause, sentence, or provision of this Compact is held by a court of competent jurisdiction to be contrary to the constitution of any Member State, a state seeking participation in the Compact, or of the United States, or the applicability thereof to any government, agency, person, or circumstance is held to be unconstitutional by a court of competent jurisdiction, the validity of the remainder of this Compact and the applicability thereof to any other government, agency, person, or circumstance shall not be affected thereby.

(c) Notwithstanding subsection (b) of this section, the Commission may deny a state's participation in the Compact or, in accordance with the requirements of subsection (b) of G.S. 115C-270.49, terminate a Member State's participation in the Compact, if it determines that a constitutional requirement of a Member State is a material departure from the Compact. Otherwise, if this Compact shall be held to be contrary to the constitution of any Member State, the Compact shall remain in full force and effect as to the remaining Member States and in full force and effect as to the Member State affected as to all severable matters.

"§ 115C-270.52. Consistent effect and conflict with other state laws.

(a) Nothing herein shall prevent or inhibit the enforcement of any other law of a Member State that is not inconsistent with the Compact.

1	(b) Any laws, statutes, regulations, or other legal requirements in a Member State in
2	conflict with the Compact are superseded to the extent of the conflict. All permissible agreements
3	between the Commission and the Member States are binding in accordance with their terms."
