## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Food Establishments – Portable Chemical Toilets**

3 FOR the purpose of authorizing certain food establishments to comply with the  
4 requirement to provide a convenient lavatory by providing a portable chemical toilet  
5 that ~~otherwise~~ meets certain requirements; and generally relating to food  
6 establishments.

7 BY repealing and reenacting, with amendments,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
13 That the Laws of Maryland read as follows:

14 **Article – Health – General**

15 21–325.

16 (a) **[Each] SUBJECT TO SUBSECTION (D) OF THIS SECTION, EACH** food  
17 establishment shall have:

18 (1) A convenient toilet that is:

1 (i) Except as provided in subsection (c) of this section, separated  
2 from any room in which food is manufactured, prepared, packed, canned, frozen, sold, or  
3 distributed;

4 (ii) Kept in a sanitary condition; and

5 (iii) Properly ventilated; and

6 (2) A convenient lavatory that is:

7 (i) Supplied with soap, water, towels, or other approved hand drying  
8 devices;

9 (ii) Kept in a sanitary condition; and

10 (iii) Properly ventilated.

11 (b) Each food service facility which prepares food and provides seating for patrons  
12 established after January 1, 1979, shall have available for the public:

13 (1) A convenient toilet that is kept in a sanitary condition; and

14 (2) A convenient lavatory that is:

15 (i) Supplied with soap, water, towels, or other approved hand drying  
16 devices;

17 (ii) Kept in a sanitary condition; and

18 (iii) Properly ventilated.

19 (c) A room that houses a toilet may be constructed within a larger room in which  
20 food is manufactured, prepared, packed, canned, frozen, sold, or distributed.

21 **(D) (1) THIS SUBSECTION APPLIES ONLY TO A FOOD ESTABLISHMENT**  
22 **THAT IS:**

23 **(I) A BUSINESS THAT CONDUCTS AGRITOURISM, AS DEFINED IN**  
24 **§ 4-212 OF THE LAND USE ARTICLE;**

25 **(II) A CLASS 4 LIMITED WINERY LICENSED UNDER § 2-206 OF**  
26 **THE ALCOHOLIC BEVERAGES AND CANNABIS ARTICLE; AND**

27 **(III) A CLASS 8 FARM BREWERY LICENSED UNDER § 2-210 OF**  
28 **THE ALCOHOLIC BEVERAGES AND CANNABIS ARTICLE.**

1                   **(2) A FOOD ESTABLISHMENT MAY COMPLY WITH THE REQUIREMENT**  
2 **TO PROVIDE A CONVENIENT LAVATORY BY PROVIDING A PORTABLE CHEMICAL**  
3 **TOILET THAT ~~OTHERWISE:~~**

4                               **(I) OTHERWISE MEETS THE REQUIREMENTS OF SUBSECTION**  
5 **(A)(2) OR (B)(2) OF THIS SECTION; AND**

6                                       **(II) IS PLACED AT LEAST 25 FEET FROM A WELL.**

8 1, 2025.
