- 3 FOR the purpose of requiring a certain person to attach a copy of an order of the court establishing parentage to a certificate of birth under certain circumstances; 4 5 requiring, for a birth involving a gestational carrier in which parentage is 6 determined by a certain court, that a certain person enter certain information on the 7 forms provided by the Secretary of Health and attach a certain order to the forms; 8 requiring the Division of Vital Records to immediately take certain actions on receipt 9 of certain documents; defining a certain term; and generally relating to birth 10 registration and gestational carriers.
