A BILL TO BE ENTITLED

AN ACT TO REQUIRE AT LEAST THREE CREDIT HOURS OF INSTRUCTION IN AMERICAN HISTORY OR AMERICAN GOVERNMENT IN ORDER TO GRADUATE FROM A CONSTITUENT INSTITUTION OF THE UNIVERSITY OF NORTH CAROLINA WITH A BACCALAUREATE DEGREE OR A COMMUNITY COLLEGE WITH AN ASSOCIATE DEGREE.

The General Assembly of North Carolina enacts:

PART I. TITLE

SECTION 1. This act shall be known and may be cited as the "North Carolina Reclaiming College Education on America's Constitutional Heritage Act" or the "NC REACH Act."

PART II. REQUIRE THREE CREDIT HOURS OF INSTRUCTION IN AMERICAN HISTORY OR AMERICAN GOVERNMENT AT CONSTITUENT INSTITUTIONS OF THE UNIVERSITY OF NORTH CAROLINA

SECTION 2.(a) G.S. 116-11(3) reads as rewritten:

"(3) The Except as provided in subdivision (15) of this section, the Board shall determine the functions, educational activities and academic programs of the constituent institutions. The Board shall also determine the types of degrees to be awarded. The powers herein given to the Board shall not be restricted by any provision of law assigning specific functions or responsibilities to designated institutions, the powers herein given superseding any such provisions of law. The Board, after adequate notice and after affording the institutional board of trustees an opportunity to be heard, shall have authority to withdraw approval of any existing program if it appears that the program is unproductive, excessively costly or unnecessarily duplicative. The Board shall review the productivity of academic degree programs every two years, using criteria specifically developed to determine program productivity."

SECTION 2.(b) G.S. 116-11 is amended by adding a new subdivision to read:

"(15) The Board of Governors shall adopt a policy requiring each constituent institution of The University of North Carolina to require at least three credit hours of instruction in American history or American government, in accordance with G.S. 116-11.5, in order to graduate from the institution with a baccalaureate degree."

(1) 36 (2) A passing score on an International Baccalaureate exam. 37 A passing score on an AS-Level or A-Level Cambridge Advanced (3) 38 International Certificate of Education (AICE) course. 39 (4) A passing grade in a dual enrollment course. 40 The Board of Governors shall ensure that the requirements of this section are 41 incorporated into the degree requirements of all baccalaureate programs and do not do any of the 42 following: 43 Add to the total number of credit hours required for a degree. The Board of <u>(1)</u> 44 Governors shall instead remove one elective course requirement. 45 **(2)** Conflict with the accreditation process for any constituent institution. The Board of Governors shall ensure that each constituent institution complies with 46 47 the requirements of this section. No later than November 15, 2026, and annually thereafter, the 48 Board shall report to the Joint Legislative Education Oversight Committee on compliance with

this section by each constituent institution. The report shall include, at a minimum, a copy of the

syllabus for each course that is offered to comply with this section.

REQUIRE THREE CREDIT HOURS OF INSTRUCTION IN AMERICAN 5 HISTORY OR AMERICAN GOVERNMENT AT NORTH CAROLINA COMMUNITY 6 **COLLEGES** 7 **SECTION 3.(a)** G.S. 115D-5 is amended by adding a new subsection to read: 8 The State Board of Community Colleges shall adopt a policy requiring each 9 community college to require at least three credit hours of instruction in American history or American government, in accordance with G.S. 115D-11, in order to graduate from the 10 11 community college with an associate degree." **SECTION 3.(b)** Article 1 of Chapter 115D of the General Statutes is amended by 12 13 adding a new section to read: 14 American history or American government instruction required for "§ 115D-11. 15 graduation with an associate degree. Each community college shall require as a condition of graduation with an associate 16 (a) 17 degree that all students complete at least three credit hours of instruction in American history or 18 American government that provides a comprehensive overview of the major events and turning 19 points of American history and government. SECTION 4.(a) G.S. 115C-81.45(d) is amended by adding a new subdivision to

- "(3a) A passing grade in an advanced course, as defined in G.S. 115C-174.26(a), or a dual enrollment course, shall satisfy the Founding Principles of the United States of America and the State of North Carolina course requirement if, in addition to meeting the requirements of this section, the course requires students to read the following documents in their entirety:
 - The Constitution of the United States of America. a.
 - The Declaration of Independence. <u>b.</u>
 - The Emancipation Proclamation. <u>c.</u>
 - At least five essays from the Federalist Papers, as determined by the d. teacher.
 - Dr. Martin Luther King Jr.'s Letter from Birmingham Jail. <u>e.</u>
 - <u>f.</u> The Gettysburg Address.
 - The North Carolina State Constitution. g.
 - George Washington's Farewell Address."

SECTION 4.(b) This section is effective when it becomes law and applies beginning with courses offered in the 2025-2026 school year.

PART V. EFFECTIVE DATE

SECTION 5. Except as otherwise provided, this act is effective when it becomes law and applies beginning in the 2026-2027 academic year to students accepted for initial enrollment in a baccalaureate program at a constituent institution or initial enrollment in an associate degree program at a community college.
