1 AN ACT concerning

2 **Prior Authorizations of State Debt – Alterations**

3 FOR the purpose of amending certain prior authorizations of State Debt to alter the
4 requirement that certain grantees provide certain matching funds; extending the
5 termination date of certain grants; changing the locations of certain capital projects;
6 altering the purposes of certain grants; changing the names of certain grantees;
7 altering the authorized uses of certain grants; altering certain matching fund and
8 expenditure requirements; repealing certain provisions of prior authorizations of
9 State Debt that require the recipients of certain grants to provide and expend a
10 certain matching fund; making technical corrections; and generally relating to
11 amending prior authorizations of State Debt.
