Mr. Kennedy (for himself and Mr. Cassidy) introduced the following bill; which was read twice and referred to the Committee on Finance

## A BILL

To amend title XVIII of the Social Security Act to improve home health payment reforms under the Medicare program.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. IMPROVEMENTS TO HOME HEALTH PAYMENT
- 4 REFORMS UNDER MEDICARE.
- 5 (a) Application of Budget Neutrality.—Sec-
- 6 tion 1895(b)(3) of the Social Security Act (42 U.S.C.
- 7 1395fff(b)(3)), as amended by section 51001(a)(2) of the
- 8 Bipartisan Budget Act of 2018 (Public Law 115–123),
- 9 is amended—

1	(1) in subparagraph (A)(iv), in the fourth sen-
2	tence—
3	(A) by striking "shall make" and inserting
4	"shall not make"; and
5	(B) by striking "and shall provide a de-
6	scription" and all that follows through the pe-
7	riod and inserting a period; and
8	(2) in subparagraph (D)—
9	(A) in the subparagraph heading, by strik-
10	ing "ASSUMPTIONS" and inserting "OBSERVED
11	EVIDENCE";
12	(B) in clause (i)—
13	(i) by striking "differences between
14	assumed" and all that follows through
15	"and actual";
16	(ii) by inserting "attributable to the
17	implementation of paragraphs (2)(B) and
18	(4)(B)" after "behavior changes"; and
19	(iii) by adding at the end the fol-
20	lowing: "The Secretary shall publish the
21	determination under this clause with re-
22	spect to an applicable year, including a de-
23	scription of the observed evidence used to
24	make such determination, in the notice and
25	comment rulemaking to update the pro-

1	spective payment system under this sub-
2	section for such year. For purposes of the
3	preceding sentence, the term 'observed evi-
4	dence' means statistically valid data from
5	the most recent cost report and claims re-
6	garding changes in the nature of home
7	health agency patients, patterns of care,
8	service costs, and claims coding after Jan-
9	uary 1, 2020, reflecting behavioral changes
10	relating to implementation of the provi-
11	sions of and amendments made by section
12	51001 of the Bipartisan Budget Act of
13	2018 (Public Law 115–123).";
14	(C) in clause (ii), by inserting "attrib-
15	utable to the implementation of paragraphs
16	(2)(B) and (4)(B)" after "expenditures"; and
17	(D) in clause (iii)—
18	(i) by adding "attributable to the im-
19	plementation of paragraphs (2)(B) and
20	(4)(B)" after "expenditures"; and
21	(ii) by adding at the end the fol-
22	lowing: "If such a temporary increase or
23	decrease does not exceed 2.00 percent in
24	any given year, the Secretary shall apply
25	the entire increase or decrease in the next

calendar year payment update; however, if 1 2 such a temporary increase or decrease ex-3 ceeds 2.00, to provide for minimal disrup-4 tion to patients and providers, the Sec-5 retary shall phase in the temporary increase or decrease in equal amounts not to 6 exceed 2.00 percent in any given year 7 through the respective calendar year pay-8 9 ment updates.".

10 (b) EFFECTIVE DATE.—The amendments made by 11 this section shall take effect as if included in the enact-12 ment of such section 51001(a)(2).
