2 Vehicle Laws - Towed, Removed, or Abandoned Vehicles - Electronic Notice to 3 Owner

- 4 FOR the purpose of authorizing a person who tows or removes a vehicle from a parking lot 5 to provide electronic notice of the tow or removal to the vehicle owner through the 6 Motor Vehicle Administration under certain circumstances; authorizing a police 7 department that takes an abandoned vehicle into custody to send an electronic notice 8 to the last known registered owner of the vehicle through the Administration under 9 certain circumstances; and generally relating to the electronic notice to vehicle 10 owners for towed, removed, or abandoned vehicles.

14 15 16	(6) Shall obtain commercial liability insurance in the amount required by federal law for transporting property in interstate or foreign commerce to cover the cost of any damage to the vehicle resulting from the person's negligence;		
17 18 19	(7) May not employ or otherwise compensate individuals, commonly referred to as "spotters", whose primary task is to report the presence of unauthorized parked vehicles for the purposes of towing or removal, and impounding;		
20 21	(8) May not pay any remuneration to the owner, agent, or employee of the parking lot; and		
22 23 24	(9) May not tow a vehicle solely for a violation of failure to display a valid current registration under § 13–411 of this article until 72 hours after a notice of violation is placed on the vehicle.		
25 26 27 28	(b) A person may not charge for the actual cost of providing notice under subsection (a)(1)(iv) of this section if the vehicle owner, the owner's agent, the insurer of record, or any secured party retakes possession of the vehicle within 48 hours after the vehicle was received at the storage facility.



- 1 **(2)** Establish and maintain a database containing the proper address for providing notice to an insurer under subsection **[(a)(3)] (A)(3)(III)** of this section for each insurer authorized to write a vehicle liability insurance policy in the State; and
- 4 [(2)] (3) Make the database REQUIRED UNDER ITEM (2) OF THIS 5 SUBSECTION available to any tower free of charge.
- 6 (d) An agreement to provide notice electronically made in accordance with 7 subsection **[**(a)(3)(ii)**] (A)(3)(III)** of this section shall remain in effect until terminated by 8 either party.
