A BILL ENTITLED

1 AN ACT concerning

2 **Criminal Law – Threat Against State or Local Official – Law Enforcement**
3 **Officer and Correctional Officer**

4 FOR the purpose of including correctional officers and law enforcement officers within the
5 scope of certain prohibitions against making or delivering threats to commit certain
6 crimes against certain State and local officials; defining certain terms; and generally
7 relating to threats against State and local officials.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Criminal Law**

16 3–708.

17 (a) (1) In this section the following words have the meanings indicated.

18 (2) **“CORRECTIONAL OFFICER” HAS THE MEANING STATED IN § 8–201**
19 **OF THE CORRECTIONAL SERVICES ARTICLE.**

20 (3) **“LAW ENFORCEMENT OFFICER” HAS THE MEANING STATED IN §**
21 **3–201 OF THIS TITLE.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

1 ~~[(2)] (4)~~ “Local official” means an individual serving in a publicly elected
2 office of a local government unit, as defined in § 10–101 of the State Government Article.

3 ~~[(3)] (5)~~ (i) “State official” has the meaning stated in § 5–101 of the
4 General Provisions Article.

5 (ii) “State official” includes the Governor, Governor–elect,
6 Lieutenant Governor, and Lieutenant Governor–elect.

7 ~~[(4)] (6)~~ “Threat” includes:

8 (i) an oral threat; or

9 (ii) a threat in any written form, whether or not the writing is signed,
10 or if the writing is signed, whether or not it is signed with a fictitious name or any other
11 mark.

12 (b) A person may not knowingly and willfully make a threat to take the life of,
13 kidnap, or cause physical injury to:

14 **(1) a State official[.];**

15 **(2) a local official[.];**

16 **(3) a deputy State’s Attorney[.];**

17 **(4) an assistant State’s Attorney[, or];**

18 **(5) an assistant Public Defender;**

19 **(6) A CORRECTIONAL OFFICER; OR**

20 **(7) A LAW ENFORCEMENT OFFICER.**

21 (c) A person may not knowingly send, deliver, part with, or make for the purpose
22 of sending or delivering a threat prohibited under subsection (b) of this section.

23 (d) A person who violates this section is guilty of a misdemeanor and on conviction
24 is subject to imprisonment not exceeding 3 years or a fine not exceeding \$2,500 or both.

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 October 1, 2017.
