Children - Health and Safety - Child Abuse and Neglect Hotline and Signage

3 FOR the purpose of requiring the Social Services Administration of the Department of 4 Human Resources to establish a certain hotline to make certain reports of suspected 5 child abuse or neglect; requiring the Administration to develop a certain 6 methodology to track certain numbers and types of calls to a certain hotline; 7 requiring the Administration to put certain records of certain calls to a certain 8 hotline in a child abuse or neglect central registry; requiring the Administration to 9 create a certain sign that contains certain information to be made available electronically to certain local school systems; requiring a certain sign to be made 10 11 available in certain languages; requiring the Department to adopt certain regulations; requiring public schools to post certain signs that contain certain 12 13 information in certain areas of the school; defining certain terms; and generally 14 relating to the establishment of a Child Abuse and Neglect Hotline.

- 26 That the Laws of Maryland read as follows:

- 20 (A) THE ADMINISTRATION SHALL ESTABLISH A STATEWIDE, TOLL-FREE,
- 21 24-HOUR CHILD ABUSE AND NEGLECT HOTLINE THAT AN INDIVIDUAL MAY USE TO
- 22 MAKE A REPORT OF SUSPECTED CHILD ABUSE OR NEGLECT.
- 23 (B) THE ADMINISTRATION SHALL:
- 24 (1) DEVELOP A METHODOLOGY TO TRACK THE NUMBERS AND TYPES
- 25 OF CALLS RECEIVED BY THE CHILD ABUSE AND NEGLECT HOTLINE; AND
- 26 (2) PUT A RECORD OF EACH CALL MADE TO THE CHILD ABUSE AND
- 27 NEGLECT HOTLINE IN A CHILD ABUSE OR NEGLECT CENTRAL REGISTRY

- 1 (C) (1) THE ADMINISTRATION SHALL CREATE A SIGN THAT CONTAINS:
- 2 (I) THE TELEPHONE NUMBER OF THE CHILD ABUSE AND
- 3 NEGLECT HOTLINE; AND
- 4 (II) INFORMATION ON HOW TO PROPERLY REPORT A SUSPICION
- 5 OF CHILD ABUSE, CHILD NEGLECT, OR CHILD SEXUAL ABUSE.
- 6 (2) THE SIGN SHALL BE PROVIDED IN EACH LANGUAGE THAT IS 7 SPOKEN BY MORE THAN 1% OF THE STATE'S POPULATION.
- 8 (3) THE ADMINISTRATION SHALL MAKE THE SIGN AVAILABLE 9 ELECTRONICALLY TO EACH LOCAL SCHOOL SYSTEM.
- 10 **(D)** THE DEPARTMENT SHALL ADOPT REGULATIONS TO CARRY OUT THE 11 REQUIREMENTS OF THIS SECTION.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2017.
