A BILL

FOR AN ACT ENTITLED

1 "An Act amending the description of parcels within the Fort Rousseau Causeway State
2 Historical Park; and providing for an effective date."

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

4 * Section 1. AS 41.21.191 is amended to read:

5 Sec. 41.21.191. Fort Rousseau Causeway State Historical Park established.
6 Except for upland, shoreland, tideland, and water overlying the land lying
7 northeasterly of a line running parallel to and 1100 feet offset southwesterly from
8 the runway centerline of the Sitka Airport that is within the runway safety area,
9 the [THE] upland, shoreland, tideland, and water overlying the land owned or
10 acquired by the state within the following described parcels are established as the Fort
11 Rousseau Causeway State Historical Park:
