BY repealing and reenacting, with amendments, Article – Business Regulation Section 8-617 Annotated Code of Maryland (2015 Replacement Volume and 2020 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND. That the Laws of Maryland read as follows: **Article - Business Regulation** 8-617. (a) A person may not demand or receive any payment for a home improvement
