## A BILL ENTITLED

1 AN ACT concerning

2 **Public Health – Rural Nonemergency Medical Transportation Program**

3 FOR the purpose of establishing the Rural Nonemergency Medical Transportation  
4 Program; and generally relating to the Rural Nonemergency Medical Transportation  
5 Program.

6 BY adding to

7 Article – Health – General

8 Section 13–4401 through 13–4405 to be under the new subtitle “Subtitle 44. Rural  
9 Nonemergency Medical Transportation Program”

10 Annotated Code of Maryland

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
13 That the Laws of Maryland read as follows:

14 **Article – Health – General**

15 **SUBTITLE 44. RURAL NONEMERGENCY MEDICAL TRANSPORTATION PROGRAM.**

16 **13–4401.**

17 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS  
18 INDICATED.

19 (B) “ELIGIBLE INDIVIDUAL” MEANS AN INDIVIDUAL WHO:

20 (1) DOES NOT QUALIFY TO RECEIVE STATE OR FEDERAL FUNDING  
21 FOR TRANSPORTATION RELATED TO RECEIVING MEDICAL SERVICES BECAUSE THE  
22 INDIVIDUAL:

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 (I) RESIDES IN A LOCATION THAT DISQUALIFIES THE  
2 INDIVIDUAL FROM QUALIFYING FOR THE FUNDING;

3 (II) OWNS A CAR;

4 (III) RECEIVED TRANSPORTATION FROM A VOLUNTEER, BUT  
5 THE INDIVIDUAL NO LONGER HAS ACCESS TO THAT TRANSPORTATION;

6 (IV) HAD A MEDICAL PROCEDURE THAT DOES NOT QUALIFY THE  
7 INDIVIDUAL FOR THE FUNDING;

8 (V) HAS A TEMPORARY DISABILITY THAT DOES NOT QUALIFY  
9 THE INDIVIDUAL FOR THE FUNDING; OR

10 (VI) DOES NOT LIVE WITHIN THE REQUIRED DISTANCE OF A  
11 PUBLIC BUS STOP TO QUALIFY THE INDIVIDUAL FOR THE FUNDING;

12 (2) NEEDS TRANSPORTATION TO OR FROM MEDICAL SERVICES  
13 WHERE EACH TRIP EITHER BEGINS OR ENDS IN A RURAL COUNTY; AND

14 (3) A HOSPITAL CARE COORDINATOR DETERMINES HAS A MEDICAL  
15 NEED FOR WHICH THE INDIVIDUAL REQUIRES TRANSPORTATION SERVICES  
16 THROUGH THE PROGRAM.

17 (C) "HOSPITAL" HAS THE MEANING STATED IN § 19-301 OF THIS ARTICLE.

18 (D) "HOSPITAL CARE COORDINATOR" MEANS AN EMPLOYEE OF A HOSPITAL  
19 WHO COORDINATES TRANSPORTATION RELATED TO MEDICAL SERVICES FOR  
20 ELIGIBLE INDIVIDUALS IN ACCORDANCE WITH THIS SUBTITLE.

21 (E) "NONPROFIT ORGANIZATION" MEANS AN ORGANIZATION THAT:

22 (1) IS:

23 (I) DESCRIBED IN § 501(C)(3) OF THE INTERNAL REVENUE  
24 CODE; AND

25 (II) EXEMPT FROM INCOME TAX UNDER § 501(A) OF THE  
26 INTERNAL REVENUE CODE; AND

27 (2) PROVIDES TRANSPORTATION SERVICES TO ELIGIBLE  
28 INDIVIDUALS THROUGH A PROGRAM ADOPTED BY A HOSPITAL.

1 (F) "PROGRAM" MEANS THE RURAL NONEMERGENCY MEDICAL  
2 TRANSPORTATION PROGRAM.

3 (G) "RURAL COUNTY" MEANS:

4 (1) ALLEGANY COUNTY;

5 (2) CALVERT COUNTY;

6 (3) CAROLINE COUNTY;

7 (4) CARROLL COUNTY;

8 (5) CECIL COUNTY;

9 (6) CHARLES COUNTY;

10 (7) DORCHESTER COUNTY;

11 (8) FREDERICK COUNTY;

12 (9) GARRETT COUNTY;

13 (10) HARFORD COUNTY;

14 (11) KENT COUNTY;

15 (12) QUEEN ANNE'S COUNTY;

16 (13) SOMERSET COUNTY;

17 (14) ST. MARY'S COUNTY;

18 (15) TALBOT COUNTY;

19 (16) WASHINGTON COUNTY;

20 (17) WICOMICO COUNTY; OR

1           **(A) THERE IS A RURAL NONEMERGENCY MEDICAL TRANSPORTATION**  
2 **PROGRAM.**

3           **(B) THE PURPOSE OF THE PROGRAM IS FOR HOSPITALS TO COORDINATE**  
4 **TRANSPORTATION PROVIDED BY A NONPROFIT ORGANIZATION TO OR FROM**  
5 **MEDICAL SERVICES FOR ELIGIBLE INDIVIDUALS.**

6 **13-4403.**

7           **(A) A PROGRAM ADOPTED UNDER THIS SUBTITLE SHALL:**

8                   **(1) COORDINATE TRANSPORTATION PROVIDED BY A NONPROFIT**  
9 **ORGANIZATION FOR AN ELIGIBLE INDIVIDUAL TO TRAVEL TO OR FROM MEDICAL**  
10 **SERVICES;**

11                   **(2) INCLUDE A MONTHLY BUDGET SET BY EACH NONPROFIT**  
12 **ORGANIZATION PARTICIPATING IN A PROGRAM ADOPTED BY A HOSPITAL**  
13 **ESTABLISHING THE TOTAL AMOUNT OF TRANSPORTATION SERVICES THE**  
14 **ORGANIZATION WILL PROVIDE TO ELIGIBLE INDIVIDUALS WHO ARE PATIENTS AT**  
15 **THE HOSPITAL THROUGH THE PROGRAM; AND**

16                   **(3) PROVIDE INFORMATION TO A NONPROFIT ORGANIZATION ABOUT**  
17 **ELIGIBLE INDIVIDUALS THAT THE CARE COORDINATOR HAS SELECTED TO RECEIVE**  
18 **TRANSPORTATION SERVICES THROUGH THE PROGRAM IN A MANNER THAT**  
19 **COMPLIES WITH STATE AND FEDERAL PRIVACY LAWS.**

20           **(B) A PROGRAM MAY NOT PROVIDE TRANSPORTATION:**

21                   **(1) TO AN ELIGIBLE INDIVIDUAL FOR MORE THAN 120 DAYS AT A**  
22 **TIME; OR**

23                   **(2) TO AN INDIVIDUAL WHO REQUESTS TRANSPORTATION BUT DOES**  
24 **NOT USE THE TRANSPORTATION PROVIDED ON MORE THAN ONE OCCASION.**

25 **13-4404.**

26           **(A) A HOSPITAL MAY ADOPT A PROGRAM IN ACCORDANCE WITH THIS**  
27 **SUBTITLE.**

28           **(B) IF A HOSPITAL ADOPTS A PROGRAM, THE HOSPITAL SHALL:**

1           **(1) CONTRACT WITH A NONPROFIT ORGANIZATION TO PROVIDE**  
2 **TRANSPORTATION TO ELIGIBLE INDIVIDUALS WHO ARE PATIENTS AT THE HOSPITAL**  
3 **IN ACCORDANCE WITH THIS SUBTITLE; AND**

4           **(2) ESTABLISH AND ADOPT A PROCESS OF NOTIFYING PATIENTS AT**  
5 **THE HOSPITAL ABOUT SERVICES AVAILABLE THROUGH THE PROGRAM.**

6           **(C) A HOSPITAL CARE COORDINATOR SHALL:**

7           **(1) DETERMINE WHICH PATIENTS OF THE HOSPITAL WHO ARE**  
8 **INTERESTED IN RECEIVING TRANSPORTATION SERVICES THROUGH THE PROGRAM**  
9 **ARE ELIGIBLE INDIVIDUALS;**

10           **(2) DETERMINE WHICH ELIGIBLE INDIVIDUALS WILL RECEIVE**  
11 **TRANSPORTATION THROUGH THE PROGRAM IN ACCORDANCE WITH THE BUDGET**  
12 **PROVIDED BY THE NONPROFIT ORGANIZATION; AND**

13           **(3) COORDINATE TRANSPORTATION FOR AN ELIGIBLE INDIVIDUAL**  
14 **WHO THE HOSPITAL CARE COORDINATOR SELECTS TO RECEIVE TRANSPORTATION**  
15 **TO TRAVEL TO AND FROM RECEIVING MEDICAL SERVICES IN ACCORDANCE WITH**  
16 **THIS SUBTITLE.**

17           **(D) IF A HOSPITAL ENTERS INTO A CONTRACT WITH A NONPROFIT**  
18 **ORGANIZATION FOR THE PURPOSES OF PROVIDING TRANSPORTATION THROUGH**  
19 **THE PROGRAM, A HOSPITAL SHALL REPORT THE NAME AND CONTACT INFORMATION**  
20 **OF THE NONPROFIT ORGANIZATION TO THE DEPARTMENT WITHIN 30 DAYS AFTER**  
21 **THE DATE ON WHICH THE CONTRACT IS SIGNED.**

22 **13-4405.**

23           **(A) IN FISCAL YEAR 2024 AND EACH FISCAL YEAR THEREAFTER, THE**  
24 **GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION OF**  
25 **AT LEAST \$1,000,000 TO THE DEPARTMENT FOR THE PURPOSES OF CARRYING OUT**  
26 **THIS SUBTITLE.**

27           **(B) EACH FISCAL YEAR, THE DEPARTMENT SHALL DISTRIBUTE THE FUNDS**  
28 **APPROPRIATED UNDER SUBSECTION (A) OF THIS SECTION:**

29           **(1) TO EACH NONPROFIT ORGANIZATION THAT PROVIDES SERVICES**  
30 **THROUGH THE PROGRAM, AS REPORTED UNDER § 13-4404(D) OF THIS SUBTITLE;**  
31 **AND**

1                   **(2) IN AN AMOUNT PROPORTIONAL TO THE NONPROFIT**  
2 **ORGANIZATION'S ESTIMATED ANNUAL BUDGET FOR PROVIDING TRANSPORTATION**  
3 **UNDER THE PROGRAM.**

4           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
5 October 1, 2022.
