5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

- * **Section 1.** AS 14.03 is amended by adding a new section to read:
- Sec. 14.03.254. Board-authorized charter schools. (a) The board may authorize a charter school in a school district under regulations adopted by the board. The regulations must include an application procedure and provisions for establishment of an academic policy committee consisting of parents of students attending the school, teachers, and school employees.
 - (b) Before the board authorizes a charter school under this section, a local school board shall review the application for the charter school. Within 60 days after receiving the complete application for review, the local school board shall issue a

1	written decision to the board recommending either approval or denial of t		
2	application. The written decision must include all relevant findings of fact ar		
3	conclusions of law.		
4	(c) The board shall contract with a local school board to operate a char		
5	school authorized by the board under (a) of this section. A local school board		
6	contracts with the board to operate a charter school under this subsection shall operate		
7	the charter school as provided in AS 14.03.255 - 14.03.290.
