CHAPTER _____

1 AN ACT concerning

2 **Baltimore County Board of Education – Student Member – Voting and Training**

3 FOR the purpose of authorizing the student member of the Baltimore County Board of
4 Education to vote on capital and operating budget matters; requiring certain
5 members of the county board and the executive leadership of the Baltimore County
6 public school system to develop a certain draft curriculum for budget training for
7 student members of the county board and submit the draft curriculum to the county
8 board for review; requiring each student member of the county board to complete the
9 budget training within a certain time period after being elected in order to vote on
10 certain matters; and generally relating to the Baltimore County Board of Education.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Education**

19 3–2B–05.

(a) The student member shall:

(1) Be an 11th or a 12th grade student in the Baltimore County public school system elected by the middle school and high school students of the county in accordance with procedures established by the Baltimore County student councils;

(2) Serve for 1 year; and

(3) Advise the county board on the thoughts and feelings of students.

(b) Unless invited to attend by an affirmative vote of a majority of the county board, the student member may not attend an executive session that relates to:

(1) Hearings on appeals of special education placements;

(2) Hearings held under § 6–202(a) of this article; or

(3) Collective bargaining.

(c) Subject to subsection (d) of this section, the student member may vote on all matters except those relating to:

(1) § 6–202(a) of this article;

(2) Collective bargaining; AND

(3) [Capital and operating budgets; and

(4)] School closings, reopenings, and boundaries.

(d) On a majority vote of the nonstudent members, the county board may determine, on a case-by-case basis, whether a matter under consideration is covered by the exclusionary provisions listed in subsection (c) of this section.

(E) (1) ON OR BEFORE DECEMBER 31, 2022, A WORKGROUP COMPOSED OF SEVERAL MEMBERS OF THE COUNTY BOARD AND THE EXECUTIVE LEADERSHIP OF THE BALTIMORE COUNTY PUBLIC SCHOOL SYSTEM SHALL DEVELOP A DRAFT CURRICULUM FOR BUDGET TRAINING FOR STUDENT MEMBERS OF THE COUNTY BOARD AND SUBMIT THE DRAFT CURRICULUM TO THE COUNTY BOARD FOR REVIEW.

(2) THE TRAINING FOR STUDENT MEMBERS SHALL:

(I) FOCUS ON THE OPERATING AND CAPITAL BUDGET PROCESS OF THE COUNTY BOARD; AND

1 (II) BE FACILITATED BY REPRESENTATIVES OF THE
2 BALTIMORE COUNTY PUBLIC SCHOOL SYSTEM'S DIVISION OF FISCAL SERVICES.

3 (3) EACH STUDENT MEMBER SHALL BE REQUIRED TO COMPLETE THE
4 BUDGET TRAINING:

5 (I) WITHIN 2 MONTHS OF THE STUDENT MEMBER'S ELECTION
6 TO THE COUNTY BOARD; AND

7 (II) IN ORDER TO BE ELIGIBLE TO VOTE ON BUDGETARY
8 MATTERS.

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
10 1, 2022.
