A BILL

To amend the Pittman-Robertson Wildlife Restoration Act and the Dingell-Johnson Sport Fish Restoration Act, to provide parity for United States territories and the District of Columbia, to make technical corrections to such Acts and related laws, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. APPORTIONMENT UNDER PITTMAN-ROBERT-
- 4 SON WILDLIFE RESTORATION ACT.
- 5 (a) Equivalent Minimum Apportionment Among
- 6 STATES AND TERRITORIES OF TAX REVENUES ACCRUING
- 7 TO FUND.—The first subsection (c) of section 4 of the
- 8 Pittman-Robertson Wildlife Restoration Act (16 U.S.C.
- 9 669c), relating to apportionment of certain revenues ac-
- 10 cruing to the fund, is amended by striking "among the
- 11 States" and all that follows through the end of the first
- 12 sentence and inserting: "among the States and each of
- 13 American Samoa, Guam, the Northern Mariana Islands,
- 14 Puerto Rico, and the United States Virgin Islands in pro-
- 15 portion to the ratio that the population of each State and
- 16 each such territory bears to the population of all the
- 17 States and such territories, except that each State shall
- 18 be apportioned not more than 3 percent of such revenues,
- 19 and each State and each such territory shall be appor-
- 20 tioned not less than 1 percent of such revenues.".
- 21 (b) Apportionment of Wildlife Conservation
- 22 AND RESTORATION ACCOUNT AMONG TERRITORIES AND
- 23 THE DISTRICT OF COLUMBIA.—The second subsection (c)
- 24 of section 4 of the Pittman-Robertson Wildlife Restoration
- 25 Act (16 U.S.C. 669c), as added by section 902(e) of H.R.

- 8 Account to each of the District of Columbia, Amer-
- 9 ican Samoa, Guam, the Northern Mariana Islands,
- 10 Puerto Rico, and the United States Virgin Islands a
- sum equal to not more than one-half of 1 percent of
- such Account.".

- 19 each year,".

- 15 subsection (d) as subsections (d) and (e), respectively.
- 16 (2) Section 2(6) of such Act (16 U.S.C. 669a(6)) is
- 17 amended by striking "section 304(d)" and inserting "sec-
- 18 tion 4(e)".
- 19 (3) Section 3(c)(2) of such Act (16 U.S.C.
- 20 669b(c)(2)) is amended by striking "sections 4(d) and (e)
- 21 of this Act," and inserting "section 4(e),".
- 22 (d) Subsection (d) of section 4 of such Act (16 U.S.C.
- 23 669c), as redesignated by subsection (c)(1) of this section,
- 24 is further amended in paragraph (2)(A)—
- 25 (1) in clause (i)—

1	(A) by striking "one-third of which is
