A BILL ENTITLED

1 AN ACT concerning

2 **Law Enforcement – Wellness Checks – Requirements**
3 **(Gabriel’s Law)**

4 FOR the purpose of requiring a law enforcement agency that receives a certain request for
5 a wellness check of an individual to immediately conduct a wellness check or submit
6 a request for the relevant law enforcement agency to conduct a wellness check; and
7 generally relating to law enforcement agencies and wellness checks.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Public Safety**

16 **3–531.**

17 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
18 **INDICATED.**

19 **(2) “QUALIFIED REQUEST” MEANS AN ORAL OR WRITTEN REQUEST**
20 **THAT INCLUDES SUFFICIENT INFORMATION REGARDING A SPECIFIC**
21 **LIFE-THREATENING CONCERN FOR IMMEDIATE ACTION OR RESPONSE.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(3) “WELLNESS CHECK” MEANS AN IN-PERSON VISIT BY A LAW**
2 **ENFORCEMENT OFFICER CONCERNING THE WELL-BEING OF AN INDIVIDUAL.**

3 **(B) (1) IF A LAW ENFORCEMENT AGENCY RECEIVES A QUALIFIED**
4 **REQUEST FOR A WELLNESS CHECK OF AN INDIVIDUAL LOCATED IN THE LAW**
5 **ENFORCEMENT AGENCY’S JURISDICTION, THE LAW ENFORCEMENT AGENCY SHALL**
6 **IMMEDIATELY CONDUCT A WELLNESS CHECK OF THE INDIVIDUAL.**

7 **(2) IF A LAW ENFORCEMENT AGENCY RECEIVES A QUALIFIED**
8 **REQUEST FOR A WELLNESS CHECK OF AN INDIVIDUAL WHO IS NOT LOCATED IN THE**
9 **LAW ENFORCEMENT AGENCY’S JURISDICTION, THE LAW ENFORCEMENT AGENCY**
10 **SHALL IMMEDIATELY SUBMIT A REQUEST TO THE RELEVANT LAW ENFORCEMENT**
11 **AGENCY IN THE STATE OR ANOTHER STATE TO CONDUCT A WELLNESS CHECK OF**
12 **THE INDIVIDUAL.**

13 **(C) A LAW ENFORCEMENT AGENCY THAT RECEIVES A QUALIFIED REQUEST**
14 **UNDER THIS SECTION SHALL MEET THE REQUIREMENTS OF SUBSECTION (B) OF THIS**
15 **SECTION REGARDLESS OF WHERE THE INDIVIDUAL OR ENTITY MAKING THE**
16 **QUALIFIED REQUEST IS LOCATED.**

17 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect**
18 **October 1, 2024.**
