Commissioner of Financial Regulation – Licensing of Nondepository Institutions – Elimination of Paper License Requirements

4 FOR the purpose of providing for the elimination of certain paper licenses for collection 5 agencies, credit services, lenders, installment lenders, mortgage lenders, mortgage 6 loan originators, sales finance companies, check cashing services, money 7 transmission businesses, and debt management services; providing for the licensing 8 of certain persons for certain activities through the Nationwide Mortgage Licensing 9 System and Registry (NMLS); requiring that certain licenses provided for through 10 NMLS include certain information; providing that a certain unique identifier of a 11 certain licensee constitutes the licensee's license number; requiring certain licensees 12 to post certain information in a certain manner at certain locations except under 13 certain circumstances and on certain websites; authorizing certain licensees to 14 surrender licenses through NMLS; providing for notification to the Commissioner of 15 Financial Regulation of certain actions by licensees; providing for the surrender of 16 certain licenses in certain manners; defining certain terms and altering certain 17 definitions; repealing certain provisions of law rendered obsolete by this Act; making 18 conforming and stylistic changes; and generally relating to the licensing of financial 19 services providers.




