## A BILL

To extend the authorities under the Water Infrastructure Improvements for the Nation Act of 2016 providing operational flexibility, drought relief, and other benefits to the State of California.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

## 1 SECTION 1. EXTENSION OF AUTHORITY.

2	(a) Subtitle J of the Water Infrastructure Improve-
3	ments for the Nation Act (Public Law 114–322) is amend-
4	ed—
5	(1) in section 4007 (43 U.S.C. 390(b) note)—
6	(A) in subsection (i), by striking "January
7	1, 2021" and inserting "January 1, 2028";
8	(B) in subsection (h)(1), by striking the
9	period and inserting "; and";
10	(C) by redesignating subsection (h)(2) as
11	(h)(3); and
12	(D) by adding after subsection $(h)(1)$ the
13	following:
14	"(2) There is authorized to be appropriated
15	\$134,000,000 for each fiscal years $2022$ through
16	2028.";
17	(2) in section 4011(e)(2), by inserting "projects
18	found feasible under the provisions of section 4007,"
19	after "construction of water storage"; and
20	(3) in section 4013 (43 U.S.C. 390(b) note)—
21	(A) in the first sentence, by striking "the
22	date that is 5 years after the date of its enact-
23	ment" and inserting "December 31, 2028"; and
24	(B) in paragraph (1), by striking "10
25	years after the date of its enactment" and in-
26	serting "on December 31, 2033".

- 1 (b) Section 4(a)(1)(F) of the Water Desalination Act
- 2 of 1996 (42 U.S.C. 10301 note; Public Law 104–298),
- 3 as amended by section 4009(a) of the WIIN Act (Public
- 4 Law 114–322), is further amended by striking
- 5 "\$30,000,000 of funding is authorized to remain available
- 6 until expended; and" and inserting "\$12,000,000 is au-
- 7 thorized to be appropriated for each of fiscal years 2022
- 8 through 2028.".
- 9 (c) Section 1602 of the Reclamation Wastewater and
- 10 Groundwater Study and Facilities Act (title XVI of Public
- 11 Law 102–575; 43 U.S.C. 390h et seq.), as amended by
- 12 section 4009(c) of the WIIN Act (Public Law 114–322),
- 13 is further amended in subsection (g) by striking
- 14 "\$50,000,000 to remain available until expended" and in-
- 15 serting "\$20,000,000 for each of fiscal years 2022
- 16 through 2028".
