5	(a) Preventing Implementation of Medicare
6	HOSPITAL OUTPATIENT PAYMENT CHANGES FOR HOS-
7	PITALS THAT PURCHASE DRUGS UNDER 340B DRUG
8	DISCOUNT PROGRAM.—Beginning on the date of the en-
9	actment of this Act, the Secretary of Health and Human
10	Services shall not take any action to implement, admin-
11	ister, or enforce the provision of the final regulation titled
12	the Medicare Program: Hospital Outpatient Prospective
13	Payment and Ambulatory Surgical Center Payment Sys-
14	tems and Quality Reporting Programs published on No-
15	vember 13, 2017 (82 Fed. Reg. 52356 et seq.), that would
16	change the payment amount under the Prospective Pay-
17	ment System for Hospital Outpatient Department Serv-
18	ices under section 1833(t) of the Social Security Act (42
19	U.S.C. 1395l(t)) for separately payable, nonpass-through
20	drugs and biologicals purchased under the drug discount
21	program under section 340B of the Public Health Service
22	Act (42 U.S.C. 256b). The payment amount under such
23	payment system under such section 1833(t) for such a
24	drug or biological shall be determined through the same
25	methodology as if such final regulation did not apply.
