BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - State Finance and Procurement 15-209.(a) Each member of the Appeals Board shall devote full time to the duties of office. (b) Each member of the Appeals Board is entitled to:
