A BILL

To amend the Energy Independence and Security Act of 2007 to expand and reauthorize the United States-Israel Energy Cooperation program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “BIRD Energy and
5 U.S.-Israel Energy Center Reauthorization Act of 2025”.

1 **SEC. 2. FINDINGS.**

2 Congress finds the following:

3 (1) The Binational Industrial Research and De-
4 velopment (BIRD) Energy Foundation was launched
5 in 2009 to promote bilateral cooperation between the
6 United States and Israel in energy development.

7 (2) BIRD Energy helps address energy chal-
8 lenges and opportunities of interest to both the
9 United States and Israel while focusing on commer-
10 cializing clean energy technologies that improve eco-
11 nomic competitiveness, create jobs, and support in-
12 novative companies.

13 (3) The funding for scientific research and de-
14 velopment helps advance the capabilities of both
15 countries in a wide variety of areas, including cyber-
16 security for energy infrastructure, renewable energy,
17 energy storage, and fossil energy.

18 **SEC. 3. EXTENSION AND REAUTHORIZATION OF ENERGY**
19 **COOPERATION AUTHORITIES.**

20 (a) EXTENSION OF COOPERATIVE RESEARCH AU-
21 THORIZATION.—Section 7(d) of the United States-Israel
22 Strategic Partnership Act of 2014 (22 U.S.C. 8606(d))
23 is amended—

24 (1) by striking “\$2,000,000” and inserting
25 “\$5,000,000”; and

1 (2) by striking “fiscal year 2021” and inserting
2 “each of fiscal years 2026 through 2031”.

3 (b) **EXTENSION OF AUTHORIZATION FOR ENERGY**
4 **CENTER.**—Section 1280A(e) of the William M. (Mac)
5 Thornberry National Defense Authorization Act for Fiscal
6 Year 2021 (22 U.S.C. 8607(e)) is amended—

7 (1) by striking “\$4,000,000” and inserting
8 “\$7,000,000”; and

9 (2) by striking “fiscal year 2021” and inserting
10 “each of fiscal years 2026 through 2031”.

11 **SEC. 4. ADDITIONAL UNITED STATES-ISRAEL ENERGY CO-**
12 **OPERATION CATEGORIES.**

13 Section 917(b)(2) of the Energy Independence and
14 Security Act of 2007 (Public Law 110–140; 42 U.S.C.
15 17337(b)(2)) is amended—

16 (1) in subparagraph (H), by striking “; and”
17 and inserting a semicolon;

18 (2) in subparagraph (I), by striking the period
19 at the end and inserting a semicolon; and

20 (3) by adding at the end the following:

21 “(J) hydrogen energy;

22 “(K) fusion energy;

23 “(L) industrial decarbonization;

24 “(M) carbon management;

25 “(N) agrivoltaics;

1 “(O) grid modernization; and

2 “(P) cybersecurity for energy infrastruc-
3 ture.”.

4 **SEC. 5. REAUTHORIZATION OF UNITED STATES-ISRAEL EN-**
5 **ERGY COOPERATION.**

6 Section 917(e) of the Energy Independence and Secu-
7 rity Act of 2007 (Public Law 110–140; 42 U.S.C.
8 17337(e)) is amended by striking “2024” and inserting
9 “2035”.
