22	"stress reduction";
23	(3) in section 2302 (34 U.S.C. 10492), by in-
24	serting "and mental health services" after "family
25	support services"; and
26	(4) in section 2303 (34 U.S.C. 10493)—

3	ficers and" after "law enforcement"; and
4	(ii) by amending paragraph (4) to
