4 FOR the purpose of altering the composition of the Tidal Fisheries Advisory Commission 5 and the Oyster Advisory Commission; requiring the Department of Natural 6 Resources, in coordination with the Aquaculture Coordinating Council, the 7 Department of the Environment, the Wetlands Administrator for the Board of Public 8 Works, and the Department of General Services to identify State-owned land that is 9 adjacent to certain waterways; requiring the Department of Natural Resources to coordinate with the U.S. Army Corps of Engineers to preapprove certain land for 10 11 aquaculture leasing; requiring the Department of Natural Resources to accelerate 12 the review of a certain aquaculture lease and the issuance of the lease; altering 13 provisions of law relating to the notification of, public meetings held for, and survey of a proposed leased area identified in an application for certain aquaculture leases; 14 and generally relating to aquaculture. 15

3 4	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
5	Article - Natural Resources
6	4–204.
7	(a) (1) There is a Tidal Fisheries Advisory Commission in the Department.
8 9	(2) The Commission is composed of up to 16 members appointed and serving in accordance with the procedures adopted under $\S 1-102(c)$ of this article.
10	(3) (i) The Commission consists of:
11	1. Up to [14] 12 commercial watermen;
12 13	2. One member of the Sport Fisheries Advisory Commission; and

- THE DEPARTMENT, IN COORDINATION WITH THE AQUACULTURE 1 COORDINATING COUNCIL, THE DEPARTMENT OF THE ENVIRONMENT, THE 2WETLANDS ADMINISTRATOR FOR THE BOARD OF PUBLIC WORKS, AND THE 3 DEPARTMENT OF GENERAL SERVICES, SHALL IDENTIFY STATE-OWNED LAND THAT 4 IS ADJACENT TO WATERWAYS THAT: 5 6 **(1)** COULD SUPPORT AQUACULTURE IN A MANNER THAT IS 7 COMPATIBLE WITH THE EXISTING USES OF THE WATERWAYS; AND 8 **(2)** HAVE ENVIRONMENTAL CONDITIONS THAT COULD SUPPORT THE 9 CULTIVATION OF BIVALVE MOLLUSKS. THE DEPARTMENT SHALL: 10 (B) 11 **(1)** COORDINATE WITH THE U.S. ARMY CORPS OF ENGINEERS TO PREAPPROVE FOR AQUACULTURE LEASING THE LAND IDENTIFIED UNDER 12 SUBSECTION (A) OF THIS SECTION; 13 14 ACCELERATE THE REVIEW OF AN AQUACULTURE LEASE 15 APPLICATION FOR LAND IDENTIFIED UNDER SUBSECTION (A) OF THIS SECTION; AND 16 ACCELERATE THE ISSUANCE OF AN AQUACULTURE LEASE FOR 17 LAND IDENTIFIED UNDER SUBSECTION (A) OF THIS SECTION. THE DEPARTMENT MAY ADOPT REGULATIONS TO CARRY OUT THIS (C) 19 SECTION.

- 21If an application for a submerged land or water column lease in the 22 Chesapeake Bay or in the Atlantic Coastal Bays meets the requirements of this subtitle:
- 23 The applicant for the lease shall mark the proposed area with a (i) 24stake; and

- 26 Advertise the application on the website of the 1. 27 Department and once a week for 2 weeks in a newspaper published in the county or counties where the proposed lease is to be located WITHIN 30 DAYS AFTER RECEIPT OF 28 29 THE COMPLETE APPLICATION:
- 30 2. Notify the owners of property directly in front of the

- proposed activity;

 Notify each Chair of an Oyster Committee in the county in which the proposed activity is located; and
- 4. Notify other interested parties that the Department 5 deems appropriate.
- 6 (2) (i) Within 30 days [of publication of the last advertisement] AFTER
 7 THE APPLICATION IS ADVERTISED under paragraph (1) of this subsection, any person
 8 who has a specific right, duty, privilege, or interest that is different from that held by the
 9 general public and may be adversely affected by the proposed lease may file a petition with
 10 the Department protesting the issuance of the lease.
- 11 (ii) The protest shall be heard in accordance with the requirements 12 of the Administrative Procedure Act under Title 10, Subtitle 2 of the State Government 13 Article.
- 14 (iii) The Department [shall] MAY hold a public informational 15 meeting on the issuance of a lease on the request of any person WHO HAS A SPECIFIC 16 RIGHT, DUTY, PRIVILEGE, OR INTEREST THAT IS DIFFERENT FROM THAT HELD BY 17 THE GENERAL PUBLIC.
- 18 (iv) [Immediately] WITHIN 180 DAYS after termination of the 19 period prescribed in subparagraph (i) of this paragraph for filing a petition or after a final 20 decision dismissing a protest, the Department shall survey the proposed leased area and 21 issue a lease to the applicant.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July $1,\,2023.$
