18 19	(2) "CRIME OF MALICIOUS OR FRAUDULENT BURNING" MEANS A VIOLATION OF § 6–104, § 6–105, OR § 6–106 OF THIS SUBTITLE.
20 21	(3) "SERIOUS PHYSICAL INJURY" HAS THE MEANING STATED IN § 3–201 OF THIS ARTICLE.

- 1 (B) A PERSON MAY NOT COMMIT A CRIME OF MALICIOUS OR FRAUDULENT 2 BURNING THAT RESULTS IN THE DEATH OF OR SERIOUS PHYSICAL INJURY TO A 3 FIREFIGHTER.
- 4 (C) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A FELONY AND 5 ON CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 10 YEARS.
- 6 (D) A SENTENCE IMPOSED UNDER THIS SECTION MAY BE SEPARATE FROM
 7 AND CONSECUTIVE TO OR CONCURRENT WITH A SENTENCE IMPOSED FOR ANY
 8 CRIME BASED ON THE ACT ESTABLISHING THE VIOLATION OF THIS SECTION.
- 9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 10 October 1, 2025.
