A BILL

To amend the Congressional Budget Act of 1974 respecting the scoring of preventive health savings.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SCORING OF PREVENTIVE HEALTH SAVINGS.
- 4 Section 202 of the Congressional Budget and Im-
- 5 poundment Control Act of 1974 (2 U.S.C. 602) is amend-
- 6 ed by adding at the end the following new subsection:
- 7 "(h) Scoring of Preventive Health Savings.—

1 "(1) Determination by the director.— 2 Upon a request by the chairman or ranking minority 3 member of the Committee on the Budget, the Com-4 mittee on Finance, or the Committee on Health, Education, Labor, and Pensions of the Senate, or by 5 6 the chairman or ranking minority member of the 7 Committee on the Budget, the Committee on Energy 8 and Commerce, or the Committee on Ways and 9 Means of the House of Representatives, the Director 10 shall determine if a proposed measure would result 11 in reductions in budget outlays in budgetary out-12 years through the use of preventive health and pre-13 ventive health services. "(2) Projections.—If the Director determines 14

- "(2) Projections.—If the Director determines that a measure would result in substantial reductions in budget outlays as described in paragraph (1), the Director—
 - "(A) shall include, in any projection prepared by the Director, a description and estimate of the reductions in budget outlays in the budgetary outyears and a description of the basis for such conclusions; and
 - "(B) may prepare a budget projection that includes some or all of the budgetary outyears, notwithstanding the time periods for projections

2	402, and 424.
3	"(3) Definitions.—As used in this sub-
4	section—
5	"(A) the term 'preventive health' means an
6	action that focuses on the health of the public,
7	individuals and defined populations in order to
8	protect, promote, and maintain health and
9	wellness and prevent disease, disability, and
10	premature death that is demonstrated by cred-
11	ible and publicly available evidence from epide-
12	miological projection models, clinical trials, ob-
13	servational studies in humans, longitudinal
14	studies, and meta-analysis; and
15	"(B) the term 'budgetary outyears' means
16	the 2 consecutive 10-year periods beginning
17	with the first fiscal year that is 10 years after
18	the budget year provided for in the most re-
19	cently agreed to concurrent resolution on the
20	budget.".
