 9 *and designated as the “Howard C. Liebengood Center for*
 10 *Wellness”.*

11 *(b) EFFECTIVE DATE.—This section shall apply with*
 12 *respect to fiscal year 2021 and each succeeding fiscal year.*

13 *CAPITOL POLICE SALARY CAP ADJUSTMENT*

14 *SEC. 302. For the purposes of administering pay dur-*
 15 *ing calendar year 2021, the maximum annual payable rate*
 16 *for any member or civilian employee of the Capitol Police*
 17 *whose compensation includes overtime pay under the Fair*
 18 *Labor Standards Act of 1938 (29 U.S.C. 201 et seq.) shall*
 19 *be set at Executive Schedule II at \$199,300. Excluded from*
 20 *this limitation for calendar year 2021 shall be retention*
 21 *bonuses and hazard bonuses related to the events of January*
 22 *6th.*

1 *ARCHITECT OF THE CAPITOL*

2 *CAPITAL CONSTRUCTION AND OPERATIONS*

3 *For an additional amount for “Capital Construction*
 4 *and Operations”, \$21,869,069, to remain available until*
 5 *September 30, 2022, to prevent, prepare for, and respond*
 6 *to coronavirus, for necessary expenses of the Architect of the*
 7 *Capitol to supplement the funding made available in Public*
 8 *Law 116–136, as amended by section 159(3) of Public Law*
 9 *116–159, and for the same purposes; and for related pur-*
 10 *chases for Congressional offices, including in Congressional*
 11 *Districts and State Offices, wherever located: Provided,*
 12 *That any funds transferred by the Architect to restore*
 13 *amounts, either directly or through reimbursement, for obli-*
 14 *gations incurred for the purposes provided herein prior to*
 15 *the date of enactment of this Act shall be merged with and*
 16 *made available for the same purposes, and period of avail-*
 17 *ability, as the appropriations to which the funds are trans-*
 18 *ferred: Provided further, That such amount is designated*
 19 *by the Congress as being for an emergency requirement pur-*
 20 *suant to section 251(b)(2)(A)(i) of the Balanced Budget and*
 21 *Emergency Deficit Control Act of 1985.*

22 *CAPITOL POLICE BUILDINGS, GROUNDS AND SECURITY*

23 *(INCLUDING TRANSFER OF FUNDS)*

24 *For an additional amount for “Capitol Police Build-*
 25 *ings, Grounds and Security”, \$300,000,000, to remain*

1 *available until September 30, 2023, to respond to the events*
2 *at the United States Capitol on January 6, 2021: Provided,*
3 *That of such amount \$283,000,000 shall be for necessary*
4 *upgrade or replacement of windows and doors in the Cap-*
5 *itol Building and the House of Representatives and Senate*
6 *office buildings on the Capitol grounds, as well as any re-*
7 *lated work to harden or enhance physical security of such*
8 *structures: Provided further, That of such amount,*
9 *\$17,000,000 shall be for the purchase and installation of*
10 *cameras at the Senate and House of Representatives office*
11 *buildings for the purposes of safety and security: Provided*
12 *further, That amounts necessary for the purpose in the pre-*
13 *ceding proviso may be transferred between the Architect of*
14 *the Capitol and the United States Capitol Police, as needed:*
15 *Provided further, That such amount is designated by the*
16 *Congress as being for an emergency requirement pursuant*
17 *to section 251(b)(2)(A)(i) of the Balanced Budget and*
18 *Emergency Deficit Control Act of 1985.*

19 **GENERAL PROVISIONS—THIS TITLE**

20 *SEC. 310. None of the funds made available in this*
21 *or any other Act in prior fiscal years, this fiscal year, or*
22 *any fiscal year thereafter may be used to install permanent,*
23 *above-ground fencing around the perimeter, or any portion*
24 *thereof, of the United States Capitol Grounds, as described*
25 *in section 5102 of title 40, United States Code.*

17 *SEC. 401. (a) Section 602(b) of the Afghan Allies Pro-*
 18 *tection Act of 2009 (8 U.S.C. 1101 note) is amended—*

19 *(1) in paragraph (2)—*

20 *(A) in subparagraph (A) by amending*
 21 *clause (ii) to read as follows:*

22 *“(ii) was or is employed in Afghani-*
 23 *stan on or after October 7, 2001, for not less*
 24 *than 1 year—*

1 “(I) by, or on behalf of, the
2 United States Government; or

3 “(II) by the International Secu-
4 rity Assistance Force (or any successor
5 name for such Force) in a capacity
6 that required the alien—

7 “(aa) while traveling off-base
8 with United States military per-
9 sonnel stationed at the Inter-
10 national Security Assistance
11 Force (or any successor name for
12 such Force), to serve as an inter-
13 preter or translator for such
14 United States military personnel;
15 or

16 “(bb) to perform activities
17 for the United States military
18 personnel stationed at Inter-
19 national Security Assistance
20 Force (or any successor name for
21 such Force);” and

22 (B) in subparagraph (D)(ii)(I)(bb)—

23 (i) in the matter preceding subitem
24 (AA), by inserting “per denial or revoca-
25 tion” after “written appeal”; and

1 (ii) in subitem (AA), by inserting “or
2 thereafter at the discretion of the Secretary
3 of State” after “in writing”;

4 (2) in paragraph (3)(F)—

5 (A) in the subparagraph heading, by strik-
6 ing “2021” and inserting “2022”;

7 (B) in the matter preceding clause (i)—

8 (i) by striking “exhausted,” and in-
9 serting “exhausted,”; and

10 (ii) by striking “26,500” and inserting
11 “34,500”;

12 (C) in clause (i), by striking “December 31,
13 2022” and inserting “December 31, 2023;”; and

14 (D) in clause (ii), by striking “December
15 31, 2022” and inserting “December 31, 2023;”;

16 (3) in paragraph (4)(A), by inserting “, includ-
17 ing Chief of Mission approval,” after “so that all
18 steps”; and

19 (4) in paragraph (13), in the matter preceding
20 subparagraph (A), by striking “January 31, 2023”
21 and inserting “January 31, 2024”.

22 (b) *EMERGENCY REQUIREMENT.*—The amount pro-
23 vided by this section is designated by the Congress as being
24 for an emergency requirement pursuant to section

1 251(b)(2)(A)(i) of the *Balanced Budget and Emergency*
2 *Deficit Control Act of 1985*.

3 (c) *REPORT TO CONGRESS*.—

4 (1) *IN GENERAL*.—Not later than 1 year after
5 the date of the enactment of this Act, the Secretary of
6 State, in consultation with the Secretary of Defense,
7 shall submit to the appropriate congressional commit-
8 tees a report, including a classified annex, if nec-
9 essary, on the Afghan special immigrant visa pro-
10 gram as described in Section 602(b) of the *Afghan Al-*
11 *lies Protection Act of 2009* (8 U.S.C. 1101 note) and
12 Section 1059 of the *National Defense Authorization*
13 *Act of 2006* (8 U.S.C. 1101 note).

14 (2) *ELEMENTS*.—The report required by para-
15 graph (1) shall include the following:

16 (A) The total number of visas issued under
17 such program, disaggregated by fiscal year.

18 (B) With respect to principal aliens issued
19 special immigrant visas under such program, a
20 description of the types of roles performed for
21 which such aliens earned eligibility for such
22 visas.

23 (C) Information regarding the average proc-
24 essing times for visa applicants under such pro-
25 gram, disaggregated by the fiscal year in which

1 *visa applications under the program were sub-*
 2 *mitted.*

3 *(D) The number of individuals who have*
 4 *pending applications for visas under such pro-*
 5 *gram, including—*

6 *(1) The number of individuals approved of the*
 7 *total number of applications processed by the Chief of*
 8 *Mission; and*

9 *(2) The number of successful appeals of the total*
 10 *number of application appeals filed.*

11 *(E) The estimated total number of individ-*
 12 *uals who have performed the requisite employ-*
 13 *ment to apply for a visa under such program,*
 14 *but who have not yet applied for or received a*
 15 *visa, including a description of the methodology*
 16 *used to create such an estimate.*

17 *(3) APPROPRIATE CONGRESSIONAL COMMITTEES*
 18 *DEFINED.—In this section, the term “appropriate*
 19 *congressional committees” means—*

20 *(A) the Committee on Appropriations, the*
 21 *Committee on Armed Services, the Committee on*
 22 *the Judiciary, the Committee on Foreign Rela-*
 23 *tions, and the Committee on Homeland Security*
 24 *and Governmental Affairs of the Senate; and*

1 (B) the Committee on Appropriations, the
2 Committee on Armed Services, the Committee on
3 the Judiciary, the Committee on Foreign Affairs,
4 and the Committee on Homeland Security of the
5 House of Representatives.

6 WAIVER OF MEDICAL EXAMINATION FOR AFGHAN ALLIES

7 SEC. 402. (a) AUTHORIZATION.—The Secretary of
8 State and the Secretary of Homeland Security may jointly
9 issue a blanket waiver of the requirement that aliens de-
10 scribed in section 602(b)(2) of the Afghan Allies Protection
11 Act of 2009 (8 U.S.C. 1101) undergo a medical exam under
12 section 221(d) of the Immigration and Nationality Act (8
13 U.S.C. 1201(d)), or any other applicable provision of law,
14 prior to issuance of an immigrant visa or admission to the
15 United States.

16 (b) DURATION.—A waiver under subsection (a) shall
17 be for a period of 1 year, and, subject to subsection (g),
18 may be extended by the Secretary of State and Secretary
19 of Homeland Security for additional periods, each of which
20 shall not exceed 1 year.

21 (c) NOTIFICATION.—Upon exercising the waiver au-
22 thority under subsection (a), or the authority to extend a
23 waiver under subsection (b), the Secretary of State and the
24 Secretary of Homeland Security shall notify the appro-
25 priate congressional committees.

1 (d) *REQUIREMENT FOR MEDICAL EXAMINATION*
 2 *AFTER ADMISSION.*—

3 (1) *IN GENERAL.*—*The Secretary of Homeland*
 4 *Security, in consultation with the Secretary of Health*
 5 *and Human Services, shall establish procedures to en-*
 6 *sure, to the greatest extent practicable, that any alien*
 7 *who receives a waiver of the medical examination re-*
 8 *quirement under this section completes such an exam*
 9 *not later than 30 days after the date on which the*
 10 *alien is admitted to the United States.*

11 (2) *CONDITIONAL BASIS FOR STATUS.*—

12 (A) *IN GENERAL.*—*Notwithstanding any*
 13 *other provision of law, an alien who receives a*
 14 *waiver of the medical examination requirement*
 15 *under this section shall be considered, at the time*
 16 *of admission to the United States, as an alien*
 17 *lawfully admitted for permanent residence on a*
 18 *conditional basis.*

19 (B) *REMOVAL OF CONDITIONS.*—*The Sec-*
 20 *retary of Homeland Security shall remove the*
 21 *conditional basis of the alien’s status upon the*
 22 *Secretary’s confirmation that such alien has*
 23 *completed the medical examination and is not*
 24 *inadmissible under section 212(a)(1)(A) of the*

1 *Immigration and Nationality Act* (8 U.S.C.
2 1182(a)(1)(A)).

3 (3) *REPORT*.—*Not later than 1 year after the*
4 *date on which the waiver authority under subsection*
5 *(a) is exercised, or such waiver is extended under sub-*
6 *section (b), as applicable, the Secretary of Homeland*
7 *Security, in consultation with the Secretary of Health*
8 *and Human Services, shall submit to the appropriate*
9 *congressional committees a report on the status of*
10 *medical examinations required under paragraph (1),*
11 *including—*

16 *(or rescinded or transferred, if applicable) only if the Presi-*
